Weaver named City Commissioner

Norman Weaver was unanimously appointed as a City of Chiefland Commissioner at the April 8 meeting, filling the No. 5 seat left vacant from the passing of Mayor Betty Walker. Weaver will serve at least until the August election. Elected commissioners serve two-year terms.

Weaver is a retired educator/administrator who relocated to Chiefland 13 years ago after marrying his wife Mary. He is the voice of Chiefland Middle High School's baseball program and has been involved with D&D Dance Studio as the emcee for their annual recital. He currently is an official for high school football and basketball.

The commission also received letters of interest from former Commissioner Teresa Barron and Cheryl Langston Barron, a tattoo artist and owner of Artistic Soul Tattoo.

It's a go: Golf carts approved for three streets

The City of Chiefland determined that golf carts may safely travel on certain city streets.

According to newly adopted Ordinance NO. 19-01, golf carts can now be legally operated on NW 21 Avenue between NW 11th Drive and the entrance to the Southern Leisure RV park, on NW 11th Drive between NW 5th Street and the NE corner of the CVS parcel, and on NW 5th Street between NW 11th Drive and the NW corner of the NAPA building.

"Those roads were chosen because golf carts cannot cross State highways," said City Manager Mary Ellzey.

Commissioner Donald Lawrence said he has already seen some unique carts on the move at the RV park. "I bet I counted 20 to 25 golf carts there," he said.

Although signs will be ordered to designate the allowed areas, the ordinance took effect on April 8.

RV park manager, commissioner seeks upgrade for dusty road

Tim West, managing member of Strawberry Fields RV Park and Vice Mayor of Chiefland, asked the Board of County Commissioners to help resolve a dust issue with a road that runs parallel to the under-construction facility.

West shared a photo of dust flowing from NW 110 Street across the park with County Commissioners at the April 2 meeting promising that it was not staged.

"I'm not looking to get the road paved," West said. "I am looking just to keep the dust down."

The road stretches partially in unincorporated Levy County and partially in the City of Chiefland.

West said Strawberry Fields originally offered to mill the street, but was told that would lead to having to eventually pave it.

"I wanted to see about sharing costs," West said. "Before the

park opens."

West said attempts at grading the street actually created more dust, and other attempts have been made graveling or tacking it occasionally.

West said the dust coming across the 60 acres is, "detrimental to our business" and asked if it was possible to discuss or brainstorm ideas.

Commissioner Mike Joyner said he had recently stayed at the park, and said he thought the 2,000-foot-long by 30-foot-wide road was in the City, but it's a County road.

West mentioned that impact fees for the RV park had been collected by the City.

"The purpose of impact fees is growth paying for its own growth," Commission Chair John Meeks said about those impact fees paid. "I find it interesting

Levy next on Daytona Beach man's list of ADA lawsuits

Joel Price vs. Flagler County, Joel Price vs. St. Johns County, Joel Price vs. Levy County.

On March 25, Levy County was officially served a summons in a civil action by Lawyer Scott R. Dinin of Miami. The lawsuit filed on behalf of Daytona Beach Resident Joel Price claims that because electronic documents Price requested from Levy County, many of which are in PDF format, are "not accessible by persons who are visually impaired and who utilize screen readers," that Price has been discriminated against under Title II of the American with Disabilities Act of 1990 and under Section 505

of the Rehabilitation Act of 1973 through which Section 504 "is enforced to redress unlawful disability-based practices and to make Plaintiff Joel Price whole."

The lawsuit says that Price visited the Levy County's website in December 2018 "with the intent of educating himself about the quality of life and governmental functioning Levy County" but the documents were not provided in "an accessible HTML or PDF format." Price is visually impaired and uses a screen reader.

The suit claims that Price has "suffered injuries in shame, humiliation, isolation, segregation," and has experienced, "emotion-

that the City is collecting impact fees from you, whether it's our road or not. This is infrastructure that this gentleman knew was inside the City (he) needs in order to make his business prosper.

"Shouldn't the City maybe

want to partner with us and come to the table?" Meeks asked.

Lilly Rooks invited West and other City Commissioners to come to the upcoming April 30 road workshop to discuss details about the road.

Meeks brought up Picnic Street and confirmed that it is a County road. "And the City (Chiefland) just paid to have it repaved," Meeks said. "So there's a precedent that has been set. That it's a benefit for the community."

That was confirmed by County

Coordinator Wilbur Dean. "Just making sure," Meeks said.

"Maybe it's not doable," Meeks told West. "But I would certainly, on behalf of the taxpayers of Levy County, like to share the cost at the minimum of this project with the City, especially considering that they collected impact fees."

Meeks then made sure the County was extending an invite to Chiefland City Manager Mary Ellzey to the April 30 workshop to explore options.

Milton Light Artillery unit visited the Chiefland Farmers Flea Market on April 6 and set up camp to create a living history experience. The group depicts an authentic Florida unit named after John Milton who served as the 5th Governor of Florida. The unit visited in the Fall and was invited back this Spring to mingle with shoppers and fire off cannons. Visitor Marty McGee of Bron-



son brought his authentic Calvery saber to show off. It was made by Ames Manufacturing Co. in 1865 of brass and steel and passed down in his family. It takes eight people to run the cannon. Ready! Powder! Fire in the hole! Fire in the hole! the commander yelled. Then Fire! and boom. The gunner called the shot, and the major would have up to 12 guns under his watch according to Major Bryan Lynch.

al suffering, pain and anguish and has been segregated and prohibited from enjoying the programs, services and activities offered by the Defendant to the public."

"As such, Defendant has denied Plaintiff Joel Price access to that content," the suit says. "In doing so, Defendant has denied Plaintiff his fundamental right to observe and participate in the democratic process of self-government."

The relief requested in the lawsuit includes a declaration that Levy County violated Price's rights, that Levy County update all electronic documents to be ADA compliant, that a consultant be hired to assist the County in improving accessibility of its electronic documents, that periodic accessibility audits be made to make sure documents are ADA compliant, award damages, cover Price's attorney fees, and award further relief as deemed

necessary.

The Flagler County Commission ended up approving a settlement payment for \$15,700 for the similar suit brought against St. John County by Price. According to county officials, Price's share was \$1,200 and the attorneys were paid \$14,500.

Price has also made the same claim against Orlando Health, Inc., Hernando County, Keiser University, Brevard County, and Manatee County.

Florida municipalities are not the only organizations to be sued for electronic document compliance.

A class-action lawsuit was filed against Singer-songwriter Beyoncé's management company claiming that her website is in violation of ADA and unable to be used by people who are visually impaired.

Jason Camacho, a blind resident from Brooklyn, N.Y., filed 50 lawsuits against colleges over the accessibility of their websites.

Levy County addressed the suit at the April 2 meeting.

Levy County Procurement Coordinator Alicia Tretheway proposed that the County Commission waive the bid process and approve and

agreement between Levy County and an ADA site compliance company that could bring 13,177 pages from 2015-2017 up to compliance at \$2.85 per page costing \$37,554.45.

The Commission weighed expediting the service, but Commissioner Mike Joyner first said that waiving due process might set a precedent for future requests.

Commissioner Matt Brooks said he also has reservations about "being held hostage."

Brooks said, "We're trying to be good stewards of the dollars for taxpayers. I don't think waiting and doing an RFP (request for proposals) is showing bad faith."

Commission Chair John Meeks agreed with Brooks and Joyner. They didn't want to rush due process in case another company entered a bid of less than \$2.85 a page.

"If we're going to get sued, we're going to get sued," Meeks said. "We're trying not to get charged an exorbitant rate."

The Commission agreed to not rush the process and voted to put the remediation of the 13,177 pages out for bid.

School district sees savings on health care

Levy County School District employees using the CareHere Health Center saved \$361,921 on medical expenses from October 2017 through September 2018.

During the annual report to the Levy County School Board, Michelle Anglea, Senior Vice President and Chief Clinical Officer for Care Here shared trends and data on how employees have used the facility located on 445 Ishie Avenue in Bronson. CareHere has been in partnership with LCSB for five years.

The number of employees who have access to use the health center are

Bronson man charged with sexual battery, molestation towards child

The Levy County Sheriff's Office Criminal Investigation Division Detective Justin VanDuren responded in March to a report of a sexual battery in Bronson. The mother of the victim told VanDuren that her child disclosed that Richard Uliano, 40, of Bronson, had sexually molested her. Beginning at the end of the school year in 2018 and into the summer, the victim reported Uliano, who had custodial responsibilities for the child, on three separate occasions forced her to watch and/or perform sexual acts on him. Detective VanDuren located and arrested Uliano on March 29 after obtaining information



Uliano from him that validated the victim's statements. Uliano was booked into the Levy County Detention Facility and charged with three offenses: sexual battery by a custodian, lewd and lascivious molestation and lewd and lascivious exhibition. Uliano is being held in lieu of a \$300,000 bond.

Fanning Springs family suffers serious to critical injuries

A 3-year-old suffered critical injuries and was airlifted to Shands while a 33-year-old Fanning Springs woman and three more children received serious injuries on April 7 when their minivan rear-ended a semi-trailer car hauler on U.S. 19 just south of NW 140th Street near Chiefland.

The minivan, driven by Maria Ruiz, crashed into the back of the hauler in the southbound lane as the truck was slowing to make a turn into a business, according to the Florida Highway Patrol report. The accident happened around 6:30 p.m.

The semi wasn't transporting any vehicles at the time of the crash.

The driver of the semi, Tony Jackson, 54, of Dade City, Alabama, was uninjured. Ruiz suffered serious injuries, and serious injuries were reported at the scene for passengers Cuahtemo Ruiz, 12, Kayla Ruiz, 9, and Alejandro Ruiz, 4, all of whom were taken to Shands.

Alan Lopez Ruiz, 3, was determined at the scene to have critical injuries. FHP was continuing to investigate the crash.

Truck giveaway raffle raises big funds for local youth groups

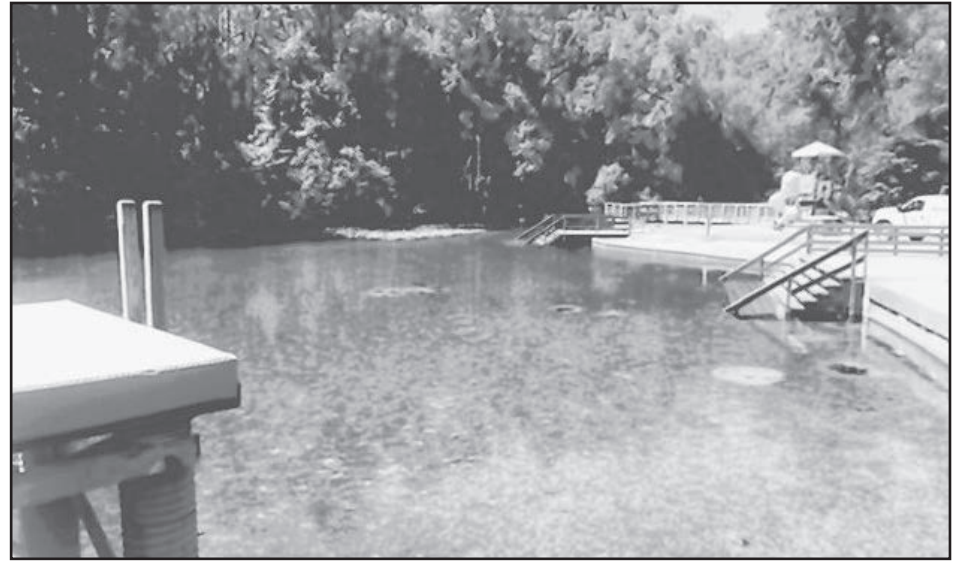

If I had as many children as God, I wouldn't last a day after seeing how they treat each other. Correction: I wouldn't last five minutes – make that five seconds.

Thankfully, God is infinitely long-suffering and immeasurably powerful. As our heavenly Father, He never grows weary of watching over us.

With this in mind, what if we made a decision to cover one another with love? What if we finally accepted that the people around us will never be perfect and chose to bear with each other's flaws – and prayed they would have the grace to bear with ours, as well?

Sometimes the best way to love each other (besides praying for one another) is to tolerate each other's imperfections, remembering we're all works in progress. Then maybe we can begin to treat each other more lovingly – for more than five seconds at a time.

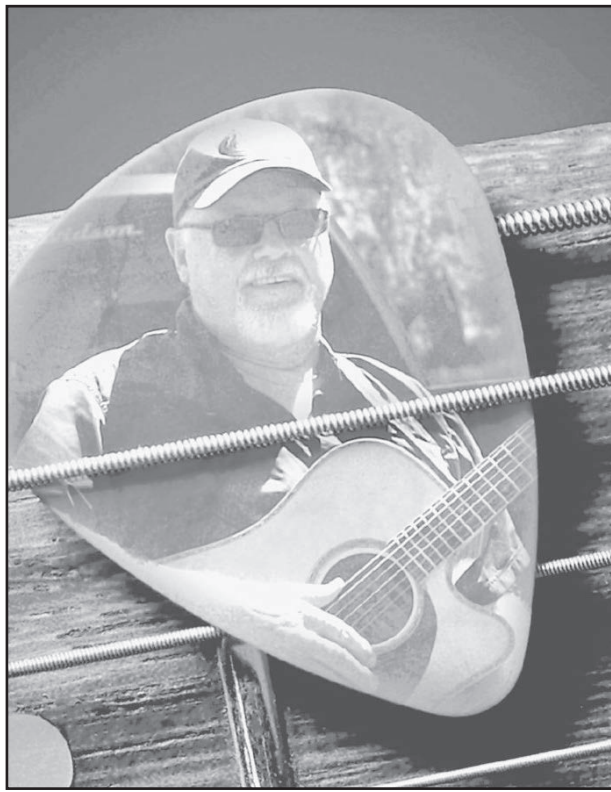

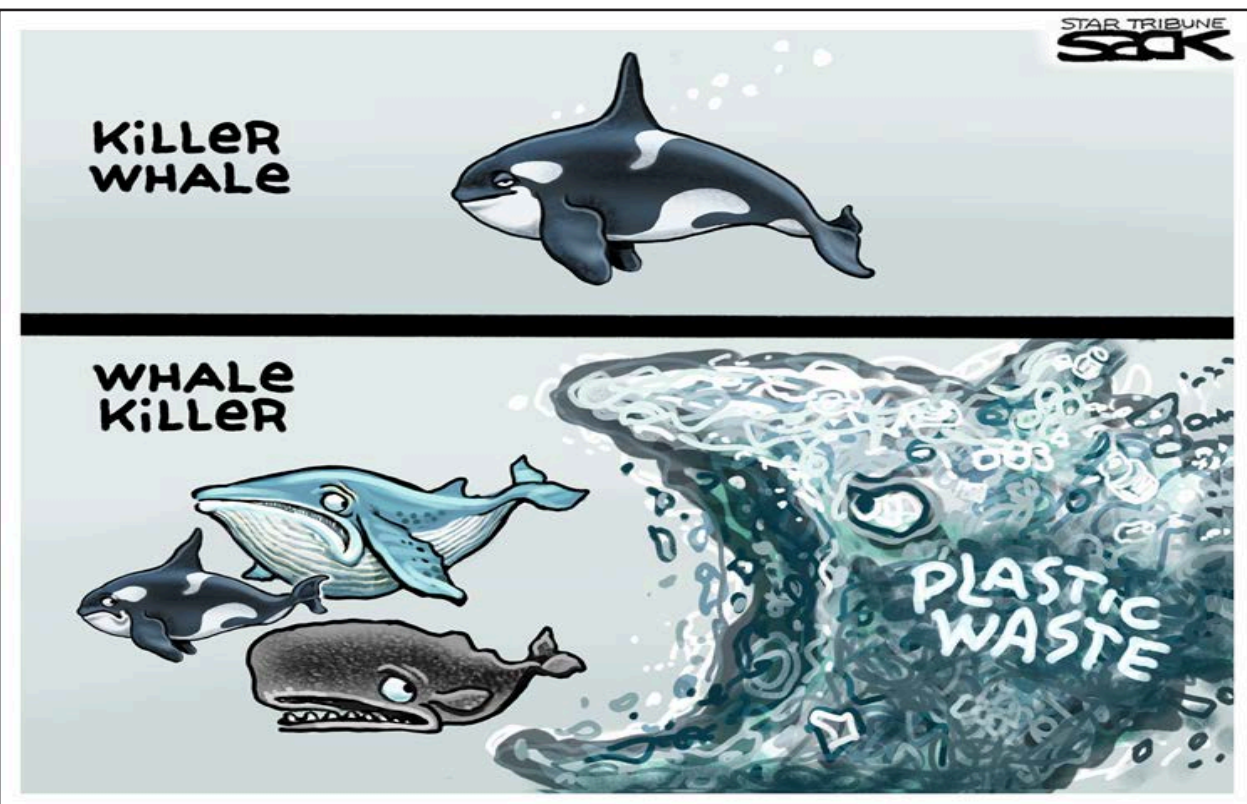

Recently I crossed the Mississippi River by car at Vicksburg. The river was nearly topping its banks.

We stopped at the Mississippi Welcome Center, stood in the misty, morning air, high above the river, sipped our complimentary coffee and read the Civil War historical marker commemorating Grant's siege of Vicksburg. That Americans had lived underground for months right below our feet to avoid cannon fire from other Americans on the river's opposite side in 1863 was difficult to comprehend. The volume of swirling, angry water below us racing southward was equally difficult to fathom.

The Missouri River, the longest in North America, has flooded recently, causing historic damage. Levees have broken throughout the Midwest. Estimates of crop loss in Nebraska approached a billion dollars some weeks ago. The Missouri empties into the Mississippi near St. Louis, so high water upriver causes more extensive flooding further south. Record snowfall has also impacted the Illinois and Ohio Rivers. A rainy spring will bring more flooding.

The economic ramifications of flooding are difficult to calibrate, but significant nonetheless. First, there is damage to crops and livestock. At this writing, I-29 in Iowa remains closed. Trains must utilize alternate routes. Rural roads are impassable. Bridges are damaged. Many farmers plant in spring and depend on overland transpor-

tation and barge shipments traveling upriver to deliver fertilizer. All of these connections are being disrupted. Crops and livestock must be transported to market eventually, so the route disruptions hurt farmers coming and going.

Some neighborhoods will be abandoned, as floodwaters ruin residential areas. Many businesses will close. The financial fallout is similar to a natural disaster like a hurricane or tornado, but with a much, much wider geographic scope and with national and global economic impact. During the Great Flood of 1927 an area the size of Scotland was flooded as the Mississippi overflowed its banks. Six states and 27,000 square miles were inundated. The Flood Control Act of 1928 soon followed, legislation which heightened and lengthened levees along the river.

The American Midwest is the largest contiguous body of farmland in the world, and it's connected to oceans and the Gulf of Mexico by a massive system of rivers and manmade waterways. Because of it, we largely take food security for granted, something many nations cannot do. The crops and livestock grown there satisfy domestic and global food needs. When Omaha, Nebraska sneezes, Paris, France catches a cold. The impact on food prices, jobs and the economy remain to be seen, as does the extent of the flood damage to one of our most productive regions.

FDOT: Support work zone safety during National Work Zone Awareness Week 2019

Whether you work in an office or on nation's roadways, everyone deserves to get home safely.

National Work Zone Awareness Week (NWZAW), in its 19th year, is a national public awareness campaign that spreads the message that we are all responsible for work zone safety. This year's NWZAW is April 8-12 and this year's theme is "Drive Like You Work Here".

"When traveling through an active work zone, drivers are entering the 'office' of those working on the project and must be focused and eliminate all distractions," said Florida Department of Transportation Secretary Kevin Thibault. "From moving equipment to directing traffic, there is a lot of activity in these areas, and motorists need to be mindful. Safe work zones are a top priority for the Department, and we will be working with our law enforcement partners to ensure a safe environment."

Recent statistics from the National Highway Safety Administration's Fatality Analysis Reporting System

(FARS) show (from 2016 to 2017) a two percent increase in total work zone fatalities and increase from 668 to 710 total work zone crashes. Those startling statistics further demonstrate the importance of spreading awareness of work zone safety and participating in NWZAW to spread the message that we all play a role in getting roadway workers home safely.

Additionally, there were a total of 158,000 work zone crashes total in 2016—of which 42,000 were injury-involved crashes that resulted in 61,000 injuries – which underscores the need for further awareness of how to behave and drive safely in work zones.

"Motorists always need to remain attentive when driving, but this is especially the case in work zones," said Greg Evans, secretary of FDOT District 2 which covers Northeast Florida. "There are numerous uncertainties in work zones – potential lane closures, construction equipment, barrels, and, most importantly, our workers – that could have an impact on your travel. So be safe – slow to the posted speed limit, eliminate distractions, and be watchful for workers and equipment."

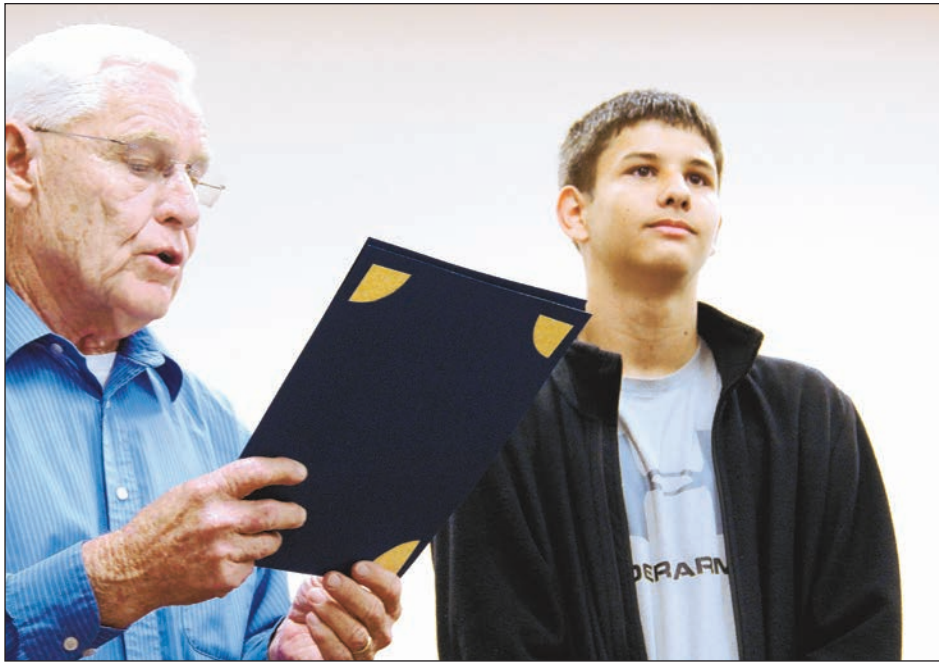

are 665 according to the report. Employees made 4,187 appointments at the center and had a low no-show rate of 3.2 percent.

"That's a fantastic no-show rate," Anglea said. "Nationally, in the market the average is about 17 percent," she said.

There were 248 health risk assessments conducted, 208 of those were by employees, 34 were dependents, and 6 were retirees.

The health center average visit cost did rise from \$69 to \$79.42 because of the rise in physician costs, Anglea said

when a board member asked about the increase.

Anglea said that the average market visit cost is \$159.51, almost double what the employees are paying.

Beyond saving money, employees are saving time, Anglea told the Board. "The average time someone takes off to go to see a doctor for a market visit is four hours," she said. "In the health center, it's an hour or less."

Board Member Cameron Asbell said he has had positive experience with the health center. "You go in there for a 10 o'clock and you're with a doctor by 10:05," he said.

Average office visit in the market is 6-8 minutes, according to Anglea.

She added that the health

center is usually 20 minutes, sometimes 40 minutes, sometimes an hour.

"The importance of uninterrupted time, where you can build a relationship and establish yourself and help you focus on continuity of care," she said.

In the clinical overview of the primary care, family practice health center, Anglea said in the report year there were 4,169 diagnoses made, 3,759 medications distributed and 2,352 labs run.

The health center offers a Health Risk Assessment that will run diagnostics to help catch any abnormalities. With employee participation at just 32 percent, Anglea said the health center is looking at ways to improve employee utilization.

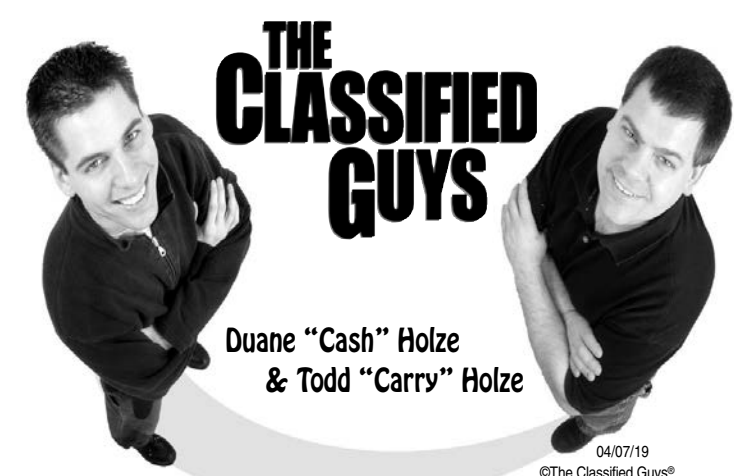
Ask the Guys
