# **Skatetown USA might**have to close doors

FORT PIERCE – Area residents were surprised to learn recently that Skatetown USA – which has been in business since the early 1980s – might have to close shop. The business has been listed and the owners are doing everything they can to ensure that it remains a skating rink for kids to enjoy, but they are worried that might not eventually be in the cards.

One of the owners, Harry Stuart, said that the business has been beset by a series of setbacks throughout the years. The hurricanes of 2004 – Jeanne, Wilma and Frances – all did major damage to the property and that subsequent insurance and legal battles, along with the 2008 recession, have crippled their finances. But a change-of-hands from Riverside Bank to TD Bank also has

hindered the process, Mr. Stuart said, because they were not nearly as willing to work with Skatetown to keep them afloat.

"Everything was going along smoothly until the hurricanes came along," Mr. Stuart said. "Hurricane Frances wreaked havoc with us and we were closed for about a month because it destroyed the floor and tore off the canopy in front." The hurricanes also did major damage to his home and he used the same insurance company for both policies and he added their insurance adjuster did not cover all the damages to his home or business, thus resulting in the subsequent legal skirmishes.

"They were going to give me nothing, and consequently we had to sue, which I was successful at," Mr. Stuart said. "And they did the same thing to my home ... so we had to sue again and were successful again. But the attorney then gets 30 per-See SKATETOWN, page 7

# County welcomes yacht builder

Both County Commission and Planning Board pave way for growing boat building industry

ST. LUCIE COUNTY – Both the St. Lucie County Commission and the Planning & Zoning Commission recently voted to launch a new yacht building enterprise near the airport and facilitate the expansion of an established boat manufacturer in Fort Pierce.

On April 20, the Planning & Zoning Board unanimously recommended the County Commission approve a conditional use permit so the owners of Tattoo Yachts could reopen a successful business operated in Martin County for the last couple of years until their lease ran out. County Commissioners then took up the matter May 2, voting 4-0 with Commission Chairman Chris Dzadovsky absent to welcome the company to St. Lucie County.

The president of the Economic Development Council of St. Lucie County, Pete Tesch, addressed the County Commission right before the vote, saying he valued the cooperative effort that brought yacht builders Paul and Laura Sharp north from Martin County. The EDC worked hand-in-hand with St. Lucie County Business Navigator Peter Jones to make the transition of Paul and Laura Sharp's business as smooth as possible so they can continue manufacturing sailboats and catamarans near the Treasure Coast International Airport.

"They are the epitome of very engaged and resourceful business owners," Mr. Tesch said. "Their company, Tattoo Yachts, is going to be a great addition to the community."

Commissioner Linda Bartz said the cooperation between all parties helped make the company's transition a success.

"This is the way it's supposed to work," she said, "with staff, with partnerships See YACHT, page 9





## **Athletes receive cleats**

# The Aaron Project, an organization started by the family of Aaron Beauchamp, donated soccer cleats to area athletes

ST LUCIE COUNTY – The Aaron Project, an organization started by the family of Aaron Beauchamp following his tragic death in a bus accident in 2012, honored 12 high school athletes on May 2, who were nominated by their coaches for excellence. Each honoree was able to choose a new pair of cleats and each was personalized with Aaron's initials and his number, "2."

"In this small way, Aaron's love of soccer gets carried onto fields all over this community," according to a press release from the organization on its Facebook page.

His father, Simon Beauchamp, said the event has been hosted annually and always helps him remember and memorialize his

"Each day is a struggle, but the years go by so quickly," Mr. Beauchamp said. "It's certainly emotional at some points, because it's hard to conceive. Aaron loved soccer so much and he certainly touched so many people in the ways he played on the field and off the field in ways we didn't know until the tragedy happened.

"it's not me who is doing this, it's Aaron; I'm just the physical part who is trying to inspire others to make a difference."

The event also allowed the athletes to see each others cleats, Mr. Beauchamp said, and thanked Rustico's in St. Lucie West for hosting the evening's event. It was hosted by Fort Pierce Central Athletic Director Jay Stewart, although Aaron always will play a central role. The cleats come from the Nike Mercurial line of products, because they were Aaron's favorites when he played soccer.

"They got to select the cleats, and the colors and textures are wonderful," Mr. Beauchamp said. "When Aaron was selecting his cleats, he loved the pink ones and he always selected the bright colors and he put his insignia – AB2 – on the cleats. So what we've done on every cleat that we give out is we have continued to put his insignia on every one we give out."

Mr. Beauchamp said the athletes were thrilled to receive the cleats and even more honored to be a part of The Aaron Project. "They were all so touched by being selected, and the story behind The Aaron project.

cent of whatever we get.

There were some things that never did get fixed."

Mr. Stuart and his wife, Jerri - who are both schoolteachers - have owned he business since 1993, but he was working there all the way back to the early 1980s and loves the sport and recreation aspects of skating in an old-fashioned rink. The 11,000-square-foot rink is contained in an 18,000-square-foot building and has so far been an interesting prospect for potential suiters. There have been a few inquiries with interested parties, but not all of them want the site to remain a skating rink.

The kids in this community are really the reason why we do this, and the reason we kept this place open - even though it wasn't making money - is for the kids, because there's not that much to do in Fort Pierce for them," Mr. Stuart said. "Somebody may buy it and keep it as a skating rink, but I doubt it because it's a very valuable piece of commercial property, plus it has a new roof?

All the difficulties have made it to where if he cannot get an investor to buy it and lease it back to him in that fashion, he will simply have to sell the entire business.

'We're still actively looking, and we've had six phone calls to me and four talking about buying it. Two of them want to keep it as a skating rink, but there were another two from the tri-county area who were willing to invest and buy the place to keep it open for the kids," he said. "They have not come back to me with specifics, so our hope is that somewhere along the way we hope we are able to resolve this issue and keep it open."

like the EDC and great people who understand what this community has to offer," she

Mr. Tesch had previously addressed the members of the Planning & Zoning Commission April 20, emphasizing the significance of the yacht manufacturer relocating to St. Lucie County.

"There are 49 sustainable jobs that will be created as the result of this project," he said.

"The Sharps are second generation boat-builders, and they've built over 45,000 boats in California since 1960."

Tattoo Yachts originally came to the Treasure Coast through the efforts of the Business Development Board of Martin County. The organization's Executive Director, Tim Dougher said that although his organization was unable to find the company a new permanent home in Martin County, he's happy they will remain in the area.

"Martin, St. Lucie and Indian River Counties are all a part of a regional marketing effort called the Research Coast," he said. "Tattoo Yachts remaining here is good for the area's marine industry and economy."

Mr. Jones also spoke to P&Z Commission members, saying they would add another layer to the county's successful boat manufacturing sector.

"As a targeted industry, we welcome them and we welcome the jobs they're going to create," he said. "They join a really wonderful flotilla of boat companies here in St. Lucie County, which is a great thing for all of us."

Although she didn't address the County Commission, Ms. Sharp did speak to the members of the Planning Board about the company's plans to hire local workers for the 26,000-square-foot building on Sun Citrus Boulevard.

"A lot of our employees when we were in Martin County came from St. Lucie County, and we expect a number of them might want to come back," she said.

Right before the P&Z unanimous vote to recommend the approval of the project, board member James Clasby said he also appreciated the collaborative effort to Tattoo Yachts on the Treasure Coast.

"I love to see applicants come forward like this, especially when they're joined by our EDC and our Business Navigator," he said. "It shows that the county really is working towards bringing jobs to our county and just really helping to develop things."

For his part, Mr. Tesch emphasized the international connections the yacht builder already had in place.

"What's also very fascinating is that the Sharps are exporters, with many of their boats ending up in European markets," he explained. "So having a preferred manufacturer that is an exporter in our community is certainly desirable from an economic perspective."

Last March, Mr. Tesch and Mr. Jones also heralded the planned expansion of the Maverick Boat Group, Inc. of Fort Pierce, which builds fishing boats and employs nearly 300 people. The company plans to hire an additional 100 employees after building a new, 100,000-square-feet facility, County commissioners agreed during their March 28 meeting to provide the company a waiver from the average wage requirement, in addition to providing up to 100,000 in grant funding towards the project.

Maverick Marketing Director Charlie Johnson declined to give specifics recently, saying it was still too early to discuss the expansion.

"While we have closed on the property, we have not committed to breaking ground as we are still in negotiations on a number of aspects of the build out," he said at the time.

Stop taking the everyday things she does for granted and let her know how much you appreciate it. You will be surprised how much she will love it.

So what should you cook? I will give you a good idea.

#### STEAK AU POIVRE

#### Ingredients

2 tenderloin steaks, 6 to 8 ounces each, no more than 1-1/2 inches thick Kosher salt

- 1 tablespoons whole peppercorns
- 1 tablespoon unsalted butter
- 1 teaspoon olive oil
- 1 teaspoon prepared mustard
- 1/3-cup beef stock
- 1/3-cup brandy or bourbon
- 1 cup heavy cream

#### Directions

Remove the steaks from the refrigerator for at least 30 minutes and up to 1 hour prior to cooking. Sprinkle all sides with salt. Coarsely crush the peppercorns with a mortar and pestle, the bottom of a cast iron skillet or using a mallet and pie pan. Spread the peppercorns evenly onto a plate. Press

the fillets, on both sides, into the pepper until it coats the surface. Set aside.

In a medium skillet over medium heat, melt the butter and olive oil. As soon as the butter and oil begin to turn golden and smoke, gently place the steaks in the pan. For medium-rare, cook for 4 minutes on each side. Once done, remove the steaks cover with a plate and set aside.

Add brandy to the pan and carefully ignite the alcohol with a long match. Gently shake pan until the flames die. Return the pan to medium heat and add the cream, mustard and stock. Bring the mixture to a boil and whisk until the sauce coats the back of a spoon, about 5 to 6 minutes. Season to taste with salt.

Add the steaks back to the pan, spoon the sauce over and serve.

# Want to be wowed? Visit The Breakers

In 1936, Fortune Magazine declared The Breakers in Palm Beach, "undoubtedly the finest resort hotel in the world." After spending just a few days at this historic resort I must say that 80 years later, the title is still in the Palm Beaches.

Henry Flagler opened The Palm Beach Inn, the original Breakers Hotel, in 1897. A year later the Ocean Course, believed to be Florida's first golf course, opened for play. It wasn't until 1901, that the resort would become The Breakers thanks to savvy travelers requesting rooms on the oceanfront "down by the breakers".

After being destroyed by fire in 1903, Flagler vowed to rebuild and reopen the resort by the winter season. When it reopened in 1904, rooms started at \$4 per night and included three meals daily. In March of 1925, a careless guest failed to turn off her curling iron and, fed by the fresh ocean breeze, an ensuing fire consumed the entire hotel again.

The Flagler heirs, having inherited the resort shortly after Henry's death in 1913, again rebuilt. This time the hotel was built of stone and masonry in the Italian Renaissance theme. Several hundred Italian artisans were brought in to sculpt and paint. The rebuild took an astonishingly short 11-½ months and cost a then-staggering \$7 million.

Since that time, the resort has continu-

ally added here and there, but the grandeur and charm has remained untouched. The best addition came in 1970 when The Breakers became fully air conditioned, allowing the resort to stay open all year long. Prior it had been open only from December through April. A few years ago the resort completed a \$250 million revitalization and expansion program.

What I liked best about The Breakers (and the choice was a difficult one because everything is amazing) was the golf. My son and I even enjoyed a lesson at the John Webster Golf Academy before heading to the links to test our games.

At the Golf Academy at The Breakers, Webster has assembled the most complete, player-centered golf education experience at any top-tier resort in the country. Judging by my son's noticeable improvement from just one quick lesson, it's easy to see why the academy has become one of the top in the country.

The Breakers features two golf courses, the Ocean Course and the Rees Jones

Course.

The historic Ocean Course, located adjacent the resort on Palm Beach was redesigned and reconstructed by Brian Silva in 2000. The par-70 course measures just 6,167 yards, challenging your mind's skills, rewarding wit over power. The constant ocean winds adding to the test.

Silva's redesign of the course brought it back to its 1896 vintage design, while adding modern irrigation and drainage. The course features fabulous landscaping and fairways that weave between sandy hazards, embodying an oldworld feel. The putting surfaces are elevated and flanked by deep bunkers and close-cut 'green surrounds', making a variety of recovery shots

For those looking for a more modern challenge, The Breakers Rees Jones Course is located 11 miles west of the main hotel. Measuring 7,104 yards from the back tees, and

built in the neo-classic style, the course will test golfers of any ability.

While my game was severely tested, my son enjoyed the best back-nine of his life on the Jones Course. The course is just as immaculate and pristine as the Ocean Course, but with a little more room and a wider variety of hole designs and options.

While we were playing golf, my wife and our daughter were enjoying a Beach Bungalow, complete with all the amenities of a room, sans the bed. Throw in several pools to choose from, a pristine beach, your own personal concierge, and pampering beyond belief, and I think they were ready to move in.

A broad selection of distinctive restaurants, ranging from casual to fine dining, are available at the resort. We chose the Flagler Steakhouse for our dinner experience. And what an experience it was! We enjoyed wonderful seafood, tender steak, tasty appetizers and more from a diverse menu. Everything was paired with the perfect wine by our servers. My daughter declared the house-made chicken strips and the chef's secret buffalo sauce the best

she has ever had. The dessert was too tempting to pass up, even though we were full from our meals.

One of the resort's best-kept secrets is its water-based recreation activities. Just a half-mile offshore lies one of the world's most incredible coral reefs. It's on my list of things to see the next time I stay.





# **Preparing your yard** for hurricane season

ith the Atlantic hurricane season just a few weeks away, it is again that time of year when we need to create a hurricane plan for our yards. Most of us remember all too well how much work it was to get your yard "hurricane ready" in just a few hours. Now is the time to plan and prepare your yard so if a tropical storm whirls on our doorstep, getting ready won't be so complicated.

The first thing you should do at the beginning of hurricane season is to trim

all your trees and bushes. Get rid of any foliage that is dead or might be hanging your house. If you any dead or weak trees, cut them down so they don't have a chance to do damage this year. Take a tour of your yard and make



There are many plants you can put in your yard that are both attractive and also seemed to hold up fairly well during a hurricane. Hibiscus, Plumbago, Firecracker plant, Ixora, and even my roses seemed to hold up very well during our twin hurricane marathon in 2004. You may also want to consider some plant varieties such as Palmetto Bush, Passionflower, Azalea Bush, Wax Myrtle, Live Oak and Southern Magnolia. These plants seemed to hold up well during past bouts with tropical systems. They also add a

natural beauty to your yard.

If you live near the ocean, planting becomes even more of a challenge because you need to have plants that resistant to salt spray. Remember that a

hurricane can carry the ocean mist far inland with its 70+-mph winds. Plant varieties such as Indian Hawthorne, Saw Palmetto, Confederate Jasmine, Society Garlic, Daylily, Pittisporum, Oleander and Mexican Petunia can do very well

in areas where salt spray can be a problem. Gardenia plants also can fare well with less than 25 percent damage and full recovery after one growing season.

When planning your landscape, if you are going to plant large trees, you should always keep the distance from the tree to the house greater than the height of the tree when it is full grown. If you have any trees that are weak or leaning, either have them secured or remove them if they are within striking distance of your home. Another thing to look for are exposed roots. If the soil has been washed away from the roots of your trees, the root structure may be weakened and allow the tree to topple easily. Fill in these areas with soil back to the original ground

As you can see, with a few common sense tips and some good planning, you can have both an attractive and safe yard this hurricane season.
