## City wants stoplight at N.W. 9th St.

At the Okeechobee City Council meeting on May 7, Okeechobee City Administrator Marcos Montes De Oca presented a video to council members on what he refers to as the most dangerous intersection in Okeechobee.

The nearly three-and-a-half-minute video showed a series of traffic accidents and congestion issues at the intersection of North Parrott Ave and Northwest Ninth Street, which is located just before the railroad tracks next to Glades AC. There have been 34 reported accidents at the intersection in the past two years alone.

The video consisted of security footage provided by Glades AC and drone footage of the intersection recorded for the City of Okeechobee at no cost by Gilbert Experience. The security footage documents the multitude of crashes at the intersection over the last two

“July 2, 2014 was my day. That was the day I was going to kill myself,” said Leah Suarez.

“It’s difficult to stand up and say that,” she told the Okeechobee County Board of Commissioners at its May 9 meeting. She shared her own story because she wants our community to understand how important mental health is to each individual child and family.

Even with her education and local contacts, “on that day I had a difficult time finding help,” she said. “I had a much more difficult time asking for help.”

Mrs. Suarez was at the commission meeting for the proclamation of May as Mental Health Awareness Month.

Mental health is a topic that is not talked about until something bad happens, she continued. She encouraged community members to paint their thumbnails green in honor of mental health month. Paint your thumbnail green to start a conversation, she said.

# Lake area counties work toward common goals

Officials from the five counties that surround Lake Okeechobee met Tuesday to find common ground and start the work to come up with unified message about the future of Lake Okeechobee.

Commissioners from Martin, Hendry, Glades, Palm Beach and Okeechobee counties gathered in the Okeechobee High School Lecture Hall on May 7. A crowd of about 350 people from all around the lake filled the lecture hall for a two-and-a-half-hour discussion hailed as the start of a larger effort to bring everyone together to work for a common goal.

The U.S. Army Corps of Engineers is in the process of working on a new Lake

Okeechobee System Operation Manual (LOSOM), which will replace the Lake Okeechobee Regulation Schedule (LORS) when repairs to the Herbert Hoover Dike are complete in 2022. LORS tries to keep the lake no lower than 12.5 feet and no higher than 15.5 feet (above sea level).

The lake level plan is a balancing act. Florida Audubon has warned that levels above 15.5 feet are harmful to the lake's marshes, which provide habitat for fish and wildlife and also act as the lake's natural filter system. Palm Beach County officials have expressed concern that water levels falling too low could mean water shortages not only for farmers but also for the urban communities of Southeast Florida.

U.S. Rep. Brian Mast of Stuart has publicly

advocated lowering the lake to 10.5 feet by the end of the dry season (May 31) to assure more water storage capacity at the start of the wet season. Others, more concerned with water supply, have advocated for high levels above 15.5 feet.

Hendry County Commissioner Karson Turner said that initially, his goal for the meeting was a joint resolution. "I found out you can't do it because it's illegal," he explained. However, each individual board can pass its own resolution.

Mr. Turner said it's important for all of the counties to share the same message with our federal partners.

"We need to stop the rhetoric. Let's quit blaming each other," said Palm Beach County Commissioner Melissa McKinlay.

"We want a cleaner lake, cleaner estuaries and a cleaner river. I hope this opens up the door for more friendly conversations on how to get to that end result."

"It's as much Walt Disney's fault as it is historic farming practices from 40 years ago. Every one of us who owns a home plays a part."

The commissioners discussed asking county staffs to work together. They also discussed having more meetings that include all of the counties. Martin County commissioners offered to host the next meeting.

## Should golf carts be allowed on some roads?

State law gives local government the option to allow the use of properly equipped golf carts on some roads with speed limits up to 35 mph. At the May 9 Okeechobee County Commission meeting, local resident Nikki Salmon asked the commissioners to consider this option for some roads in the county.

County Administrator Robbie Chartier said under the state statute, golf carts allowed on designated county roads would be required to have safety equipment such as lights, turn signals, seat belts and windshield wipers to be designated as low-speed vehicles. The county can also require a registration sticker. The roads must be marked as designated to allow use of low-speed vehicles. The low-speed vehicles would be allowed on county roads only from sunrise to sunset.

She said while state law allows golf carts to cross state roads, that crossing a state road in Okeechobee County could be problematic for a low-speed vehicle.

She said state law requires the local government to consider the character of the traffic that is on that roadway when considering the option to allow the low-speed vehicles.

While this option is in the state statutes, Okeechobee County has never taken action on it, Mrs. Chartier said.

"Okeechobee is a growing county. We want to encourage people to come here. People come here every day," said Ms. Salmon.

"Traffic is a problem. 49 states have already adopted the rule. Many counties have

already adopted a rule and figured out some way to make this work," she said.

She said most low-speed vehicles are electric. "There's a movement of green going on. Everybody wants to cut back on fuel and costs," she said. "When you are driving down the road and you see people riding scooters and golf carts on the sidewalks, most of them have some kind of handicap that prevents them from driving a vehicle," she explained.

"What they are doing right now is not legal," she added.

Designating some county roads as open to low-speed vehicle use would be an opportunity for new business in the county, she said, helping those who sell and repair golf carts. The conversion kits to add the safety features required are relatively inexpensive, Ms. Salmon added. She said when people with the larger RVs come into town, they don't have a way to bring an automobile with them. "This would be a very easy solution for them to be mobile."

"The concern I have is the misuse in an area that is not designed to handle the mixed use," said Okeechobee County Sheriff Noel Stephen. "We have a community within our county that is perfectly designed for this," he said. "Because of the misuse of the mixed use, it creates problems.

"I wish we were designed for it, but at this point I don't think it is a healthy thing for us to move into," said the sheriff.

Commissioner Bryant Culpepper said there is an area where there are already a lot of accidents involving people on golf carts. "We had one recently, a fatality when an

elderly gentleman pulled out in front of a car," he said.

"We have some multiple issues with vehicles," said Commission Chairman Terry Burroughs. "Trying to accommodate one compromises the sheriff on another." He said he does not want to compromise the sheriff's ability to enforce the existing laws.

Commissioner David Hazellief suggested the property owners of Silver Palms and the Publix shopping center could work together to create a private road between the Silver Palms gated community and the shopping center and designate parking at the shopping center for golf carts.

### Make sure you know the law before building a farm structure

The scenario goes something like this. A property owner will call me after he has received a notice of violation from a city or county advising he has built a farm structure or performed site work without a permit.

"But I'm exempt because of the Right to Farm Act. I don't have to get a building permit or comply with any laws," the property owner will tell me.

Not exactly.

A provision in Florida law (Florida Statute 604.50) deals with ability of cities and counties to regulate non-residential farm structures.

First, a non-residential farm structure is a building or support structure that is an integral part of a commercial agricultural operation. This can include a pole barn, a horse stable, a manure bin, a riding arena, and a shed to store agricultural equipment and supplies. It is no longer nonresidential when it is used for habitation, such as a hunting camp, groom's quarters or housing for a watchman or employee.

Next, the law takes a two-prong approach to determining whether the farm structure is an integral part of a commercial

agricultural operation. The simplest way to make this determination is asking whether the property has an agricultural classification granted by the county Property Appraiser. The Property Appraiser is charged with classifying land as agricultural or non-agricultural. Only lands used for commercial agricultural activities are eligible to receive an agricultural classification and the corresponding reduction in the assessed ad valorem value for property tax purposes.

There are some instances when property is being developed for commercial agricultural activities, like horse boarding and training. In order to rent stall space, the stalls must be built or renovated. Making good faith preparations to prepare and use the land and buildings for commercial use is the second way to demonstrate that these farm structures will be used for something more than a mere hobby or personal use. However, you do not need an agricultural classification to avoid the imposition of local codes and building permit fees on farm structures.

What does this mean? The key is commercial agricultural activity which simply means the intent to earn a profit from the good faith commercial use of property. So

if you are constructing a pole barn to house the tractors, mowers, feed and other inputs used to run your cattle ranch, you do not need a building permit. You are exempt from local land development codes or building permit fees for such non-residential farm structures provided you meet the statutory criteria.

The state law, however, allows a city or county to require a permit where construction of the farm structure occurs in a floodplain. This is typically known as a floodplain development permit. Always check with your local building department to find out whether you are in a zone that requires this special type of permit. For some tracts of property, the flood zone may be different so check first and decide if you want to build the structure within the zone or adjust your plans to build outside the flood zone.

Simply hiring a contractor to complete the work for you does not excuse you from understanding the law and performing your due diligence as you develop your plans to improve agricultural property.

I frequently receive calls from property owners who are cited for permitting violations because they filled a pond, paved

a designated wetland area, disturbed protected species habitat or diverted surface water flows without a permit. These types of activities are not always exempt from permitting so care should be given before undertaking site work.

It's worth distinguishing that the Right to Farm Act is primarily designed to protect agricultural property owners from nuisance suits. This is in recognition of the fact that urban development has encroached on farmlands, creating conflicts between agriculture and residents. The Right to Farm Act also protects farmland from duplicative regulation where the property is regulated by Best Management Practices or BMPs.

Remember, before you build or perform site work on your agricultural property, make sure you perform your due diligence and understand when permits are and are not required. Consulting with an experienced attorney who understands the laws and regulations governing agriculture can save you time, money and aggravation.

# City Council members vote to take CVS to court

Okeechobee City Council members voted in favor of City Attorney John Cook commencing legal action against the CVS Pharmacy located at 106 N. Parrott Ave.

CVS has racked up over \$20,000 in fines over the course of a year for code violations related to failure to maintain the company's property.

A year ago, in a Feb. 13 hearing, the city code board found Spirit CV Okeechobee FL LLC (the CVS property) in violation of city codes related to landscaping and public nuisance. The city code defines public nuisance as "the existence of excessive accumulation of litter or untended vegetation, garbage, weeds, or other dead or living plant life; or places holding stagnant water, and all other objectionable, unsightly

or unsanitary matter upon any lot, tract of land within the city, whether uncovered or under shelter."

City code also requires: "All owners of improved property shall cut and keep cut all weeds, grasses or undergrowth on the entire property, to a height not to exceed 8 inches. Also, all landscaping shall be trimmed and kept in a neat appearance so as not to adversely affect the aesthetic appearance of the property and adjacent properties."

Around the same time last year, Walgreens, located directly across from CVS at 100 N.W. Park St., was also found in violation of city codes relating to landscaping and public nuisance. Following that hearing, Walgreens installed irrigation and new landscaping to come into compliance with city code.

CVS, however, did not.

"Walgreens stepped up and replaced all their landscaping and put in irrigation so it would be maintained; CVS hasn't," said City Attorney John Cook at the May 7 City Council meeting. "We've been in touch with them over and over and over. I believe if we commence legal action, it will at least get their attention and get some response."

According to Okeechobee Code Enforcement Officer Fred Sterling, the local management at CVS report that their district managers are aware of the fine but have chosen not to respond.

The aesthetics of the City of Okeechobee often come up in debates about attracting new businesses and residents to the area. During a political forum in 2018, Okeechobee County Commissioner Terry Burroughs addressed the issue directly.

"We've had a lot of conversation relative to code enforcement," said Commissioner

Burroughs. "If the environment doesn't look nice, people will not come and open up a business."

With its central location at the main intersection of Okeechobee, the CVS property plays a crucial role in how both residents and visitors view the city.

"I did mention to the local manager while I was in the store that this issue was going to be on our agenda," said Okeechobee Mayor Dowling Watford shortly before city council members voted. "I thought it was fair to let him know. He responded that CVS does not let him take care of those things. He told me that the regional manager would be there the next day and he would let him know. Obviously, they weren't that concerned about it."

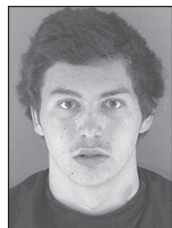
The city council voted unanimously in favor of the motion.

## Teen arrested on felony charges for fourth time in a year

An Okeechobee teen was arrested after a homeowner allegedly caught him and an accomplice in his garage and detained them until Okeechobee County Sheriff's Office deputies arrived. Sgt. He got out of his jeep and confronted the suspect, and that was when he realized there was a second person in there as well, he said. He called 911 and had the two suspects wait until help arrived.

The two suspects were identified as 20-year-old Kevin Lee Schick, Northwest 87th Court, and 16-year-old Jacob Curtis Lawrence, Northeast Fourth Lane. Lawrence was dressed all in black and carried a hat and a small flashlight, according to Sgt. Ellis' report.

Both Lawrence and Schick were arrested and charged with burglary of an unoccupied structure. Bond was set at \$5,000 for

Schick, but because Lawrence is a juvenile, he was transported to the Department of Juvenile Justice in Fort Pierce.

This is not Lawrence's first brush with the law. He was arrested last May when he was 15 years old and charged with grand theft auto. In August 2018, he was arrested again and charged with unarmed burglary of a conveyance and, in September 2018, he was arrested and charged with burglary of a structure, grand theft of a motor vehicle and criminal mischief.

Schick has no felony arrests on his record.

years. The video was prepared ahead of a meeting the Okeechobee city administrator has with the Florida Department of Transportation (FDOT) in order to display why a traffic light is needed at that intersection.

FDOT was first contacted about the need for a traffic light at the intersection back in 2001, but FDOT denied the request. After the industrial park was opened in Okeechobee a few years later, traffic issues only worsened.

"When I came on board I wanted the industrial park to grow," said Mr. Montes De Oca, who was appointed city administrator in 2015. "We're here for development and for pushing things forward, but we couldn't get traffic in and out of the industrial corridor that runs along Northwest Ninth. So

four years ago, we brought up the request again to FDOT. Three years ago we were ranked second in congestion management, but for the past two years we've been ranked first. And we're still not funded. So obviously we're not getting through to FDOT. Together with the county's support, we're pushing this right now."

Mr. Montes De Oca has two meetings scheduled in May with FDOT District 1 secretary L.K. Nandam, and he's hopeful the video of the intersection will make it clear how badly a traffic light is needed.

"We were seeing the accidents come in through the police office," said Mr. Montes De Oca. "The police officers would review the footage, and I just thought, 'Man, we need to get this out.' So hats off to Gilbert and Glades AC for helping us put this together. It's terrible seeing the accidents, but I think it conveys the point we're trying to make."

Commissioner Kelly Owens said parents may know something is wrong with a child but not address it. The hardest thing as a parent may be to acknowledge there are issues with your own child, she said.

Tiara Weethee, of Suncoast Mental Health, said Suncoast started by serving the mental health needs of children and now serves children, adults and families.

Commission Chairman Terry Burroughs said the county has a mental health court, and that he has been working with County Judge William Wallace to also start a veterans court.

He said the National Association of Counties is promoting mental health court programs. The jail staff is using tools provided by these programs to identify those in the jail who have mental health issues.

"Rather than being in jail, we would like to see them get help and be productive members of our society," he said.

In other business, the county proclaimed the month of May also as Foster Care Month.

"It's poignant today that you have two proclamations on mental health and foster care," said Pat McCoy, who is on the board of directors for Communities Connected for

Kids. She said those issues, as well as the issues of substance abuse and homelessness, are connected.

Many children in foster care come from families affected by mental health and substance abuse, she explained.

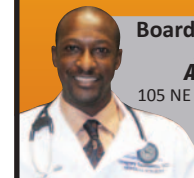

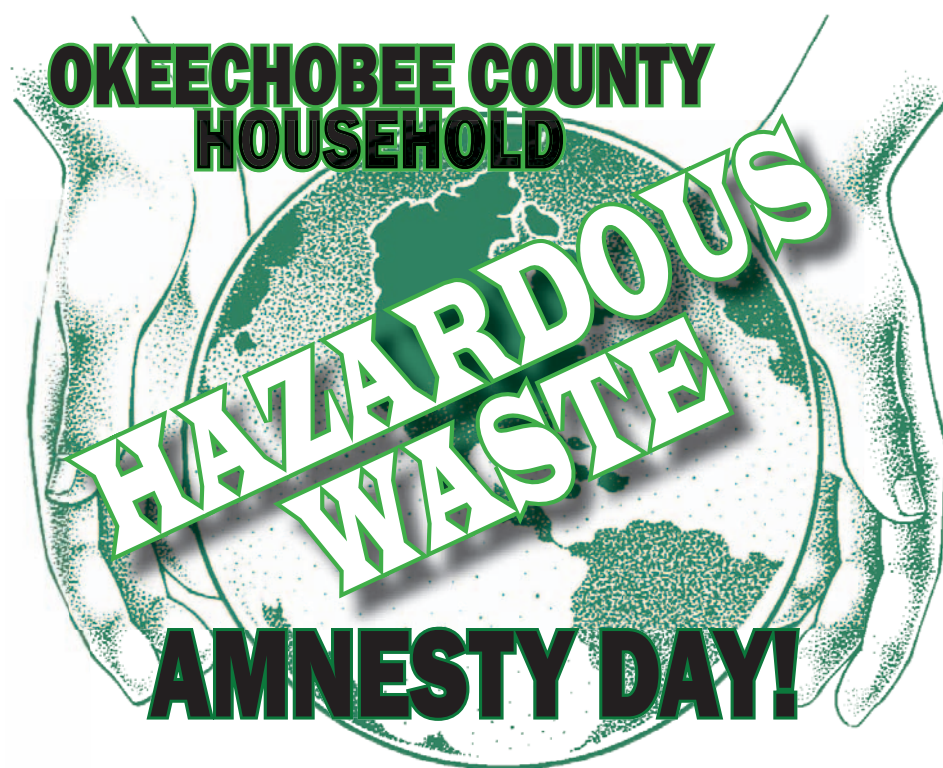

## FWC plans fishing grant program

Florida Fish and Wildlife Conservation Commission (FWC) members approved staff development of an R3 Fishing Grant program at their meeting on May 1 near Tallahassee.

The FWC is striving to increase participation in freshwater and saltwater fishing through an effort known as R3 (Recruitment, Retention and Reactivation). Recruitment of new anglers, retention of active anglers and reactivation of lapsed anglers are important to the future of conservation funding. R3 programs are focused on increasing and diversifying the fishing participation rate of different age groups and backgrounds over the next 10-15 years. This rule amendment allows the FWC to offer grants to partners helping achieve participation goals, assisting with fisheries research and evaluating the effectiveness of R3 programs.

Funding derived from fishing and boating activities supports management programs tasked with ensuring Florida continues to meet the needs of stakeholders with a vested interest in Florida's aquatic resources. Much of Florida's growth is in urban areas where people are less likely to have exposure to nature-based activities. Studies have shown there is a strong interest in fishing from adults and youth who have never fished, but there are barriers and uncertainty about where to begin. Research also indicates the key motivating factors for fishing are for consumption, appreciation of the outdoors and spending time with family and friends.

The intent of this grant program is to allow stakeholders the ability to partner with the FWC on facilitating R3 programs, expanding R3 reach and increasing the participation rate of under-represented fishing groups in the angling community. The FWC

is committed to working with partners to find solutions that will overcome these barriers so future generations have the knowledge and skills to become safe, successful anglers with an appreciation for Florida's natural resources.
