## Woman arrested for trying to sell fake gold jewelry

A local man who had the foresight to verify the worth of some jewelry that a stranger attempted to sell him lucked out.

He wasn't taken in by the woman's story but she was taken in - by a Blountstown Police Officer.

The man was at the Chevron in Altha early Friday morning when a woman walked up to his truck and asked for his help, according to a report from the police department. She told him she needed a thousand dollars to return to her home in Romania with her three children.

She said she could sell him an 18K gold necklace and ring, which she claimed was worth more than \$1,000. He wasn't interested. Then she said if he gave her the money

now, she would send him \$5,000 when she arrived in her home country.

He let her think that offer had caught his attention but told her he wanted to show the necklace to his wife first. Instead, he came to Blountstown to have the pieces appraised at The Diamond Corner.

Owner Lynn Strawn has seen several pieces of costume jewelry like this in the past few weeks. Even though they are stamped as being 14K gold, they are fake, she said. She gave the same news to the man that brought it in, telling him neither item contained any gold.

The woman, identified as Banatanca Miclescu, 37, had apparently followed him into Blountstown and was walking away from The



Diamond Corner when a police officer arrived in response to Strawn's phone call.

She was arrested and charged with grand theft and exploitation of the elderly. The arrest report said she had four necklaces, two charms, four bracelets, and fifteen rings in her possession. All were stamped 14K gold. All were

fake.

Miclescu admitted she was selling the jewelry and told the officer that it was all "plastic and fake."

She said she was "only asking \$50" for everything.

The victim told the officer he initially wanted to help her but he "just didn't feel right" about the situation.

## Car hits liquor store after SR 20 collision

A driver was transported to the emergency room to be checked for possible minor injuries after a two-vehicle collision in the intersection of SR 20 and NW 11th Street in Blountstown Thursday.

According to the Florida Highway Patrol, Maria Del Carmen Hamm, of Blountstown pulled out from 11th Street onto SR 20 and into the path of an oncoming 2005 Nissan Sentra driven by Tris-

ton Seth Mendenhall of Altha.

Hamm's southbound 2015 Toyota Yaris struck the front of Mendenhall's eastbound vehicle. The impact sent the Toyota into a counter-clockwise rotation before it came to rest in the eastbound lane of SR 20, facing north.

The Nissan went off the road, hit a stop sign and then struck the side of the West End Liquor store. Neither Mendenhall nor his passenger, identified as Breanna Lynn Terry, were injured.

Hamm was charged with failure to yield at a four-way stop intersection.

Damages to the store were estimated at \$15,000, and \$1,000 in damage to the stop sign.

The Nissan was not operable after the crash, which resulted in approximately \$10,000 in damages. Damages for the Toyota were also estimated at around \$10,000.

The 4:18 p.m. crash was investigated by FHP Trooper T.B. Lincoln.

Committees have been formed to engage local leaders and concerned citizens in every facet of helping people recover from Hurricane Michael.

The NFI LTRG's mission is to coordinate recovery services and build resiliency for individuals, families and entities adversely impacted by the 2018 Hurricane Michael in Calhoun and Jackson counties.

# Florida Forest Service issues a reminder about burning in those areas impacted by the hurricane

VICKSBURG - Officials with the Florida Forest Service's Chipola Forestry Center are reminding residents of both the importance of prescribed fire and the hazards that remain in our area post Hurricane Michael.

This week is Prescribed Fire Awareness Week and Florida has the most robust prescribed burning program in the nation. While the Florida Forest Service works to promote prescribed burning for its benefits to the natural ecology and to reduce the risks of wildfires, elevated caution should be utilized for any open burning.

Burn practitioners are being reminded that the Florida Forest Service has heightened restrictions on burn authorizations within the primary impact zone of Hurricane Michael. Restrictions might include but are not limited to on-site inspections by Flori-

da Forest Service personnel or the requirement of heavy equipment being on-site for all burns. As always, weather is a key component and restrictions can change based on current and forecast conditions.

"Hurricane Michael left an unprecedented volume of timber on the ground, creating a serious wildfire threat," said Jim Karels, State Forester and Director of the Florida Forest Service. "Firefighter and public safety must remain our primary focus as we reintroduce open burning into these hardest hit areas."

To obtain a burn authorization in Bay, Calhoun, Gulf, Holmes, Jackson Walton or

Washington County, call (850) 373-1801. For current wildfire conditions, interactive fire maps and more information on burn authorizations, visit FloridaForestService.com.

An authorization is not required to burn yard waste as long as you meet the required setbacks and there are no local, city or county ordinances in place that prohibit burning.

The Florida Forest Service, a division of the Florida Department of Agriculture and Consumer Services, manages more than 1 million acres of state forests and provides forest management assistance on more than 17 million acres of private and community forests. The Florida Forest Service is also responsible for protecting homes, forestland and natural resources from the devastating effects of wildfire on more than 26 million acres. # Workshop offered on using prescribed fire to promote wildlife on private lands

The Florida Fish and Wildlife Conservation Commission (FWC) and partners are hosting a "Prescribed Fire & Wildlife Stewardship" workshop for private landowners in northwest Florida.

The workshop, sponsored by the FWC, the Florida Chapter of the Wildlife Society and the University of Florida/IFAS, will be held Feb. 26-28 at the North Florida Research and Education Center, 155 Research Road, in Quincy.

Registration information and the agenda are available on the Florida Chapter of The Wildlife Society's website: [ftws.org/new-events](http://ftws.org/new-events). Sign up in advance, since this workshop can accommodate only 35 participants, with a cost of \$25.

Landowners in Gadsden County and surrounding counties who attend will hear and participate in presentations, panel discussions and field exercises on local private lands. The hands-on field exercises will allow landowners to work in small groups and begin incorporating ideas into their own prescribed fire plans

and operations.

Staff from the FWC's Wildlife and Habitat Management Section and Landowner Assistance Program will participate.

Use of prescribed fire in Florida is beneficial for wildlife and habitats, and helps reduce the risk of wildfires.

### Winners to receive a 4 year Florida College scholarship First Lady announces Black History Month theme and contests

#### •STUDENT ART CONTEST

Three winners will be selected: one elementary school teacher (grades K-5), one middle school teacher (grades 6-8) and one high school teacher (grades 9-12). Nominations may be submitted by a principal, teacher, parent/guardian or student.

# Two much-needed vehicles donated to BFD

BLOUNTSTOWN - October 10, 2018 changed everything for the Florida Panhandle, and Blountstown was no exception. The widespread destruction of Hurricane Michael impacted virtually everyone in not only the City of Blountstown, but also those for more than 50 miles around.

"We needed help, and help is what we got!" said Blountstown Fire Chief Ben Hall. It came in every shape and form, from private donors to FEMA Strike Teams and even the military. All lent a hand in the recovery efforts.

Within the first few hours of the storm, Blountstown's firefighters realized a need for a smaller, more efficient pickup truck. The Blountstown Fire Department's (BFD) stable includes two Rosenbauer commercial cab engines and a Chevrolet utility truck.

Unfortunately, the Chevrolet suffered a major mechanical failure just weeks before the hurricane. "We were looking at options for replacement through a grant and running a needs assessment to see if we could phase that unit out, but then the storm came."

According to Chief Hall the need for a small combination unit known sometimes as a "Squad" became more apparent very quickly. "It didn't take long for us to run out of apparatus and realize how badly we missed that old truck!"

Thanks to a friend at a neighboring school district, BFD was able to borrow a pickup truck for a few weeks to meet the immediate need, but that

truck had to be returned. "I explored what I thought was all of our options. Requests via the EOC, reaching out to dealerships, quick grants and even social media. Nothing seemed to work." That's when the Chief remembered the Florida Fire Chief's Association.

"I just send out an email. I explained our need and within just a few hours my phone was ringing".

The department knew a vehicle purchase was out of the question. "We're a small town, just five square miles and our budget is low," said Hall. "Now, post storm, we're facing bills in the tens of millions of dollars for utility repair and debris cleanup. There's no way we could afford a truck when we're facing that kind of debt."

That's where Chief Trip Barrs of Treasure Island Fire Rescue stepped in. A very excited Chief Hall said, "I got a call from a South Florida phone number and Chief Barrs said 'I think we can help you out'. It was the best news I'd been given in a long time!"

Chief Barrs, his department and City Council graciously donated a 2001 Ford F-350 Rescue Truck to Blountstown Fire Department. It will perfectly meet the need.

"We had just been given a '03 Chevy

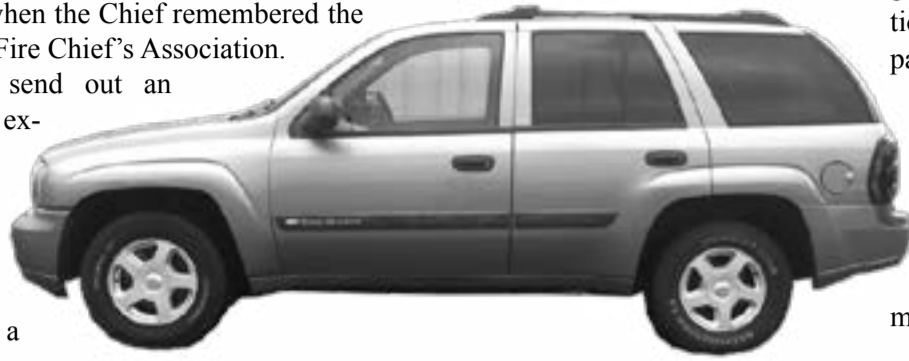
Trailblazer, donated by a retired Panama Handle Fire Chief (by way of Panama City Beach Fire Rescue) and our next step was to seek out a government surplus Humvee to convert for wildland

Humvee and at far lower costs.

Chief Hall expects a very active wildfire season on the horizon and the need for a 4x4 response vehicle was great. These two very generous donations will equip Blountstown Fire Department for many years to come.

An emotional Chief Hall said, "One of our City Council members said it best- it's just humbling to know people are willing to make sacrifices on their own part to help our little town.... And we appreciate it so very much."

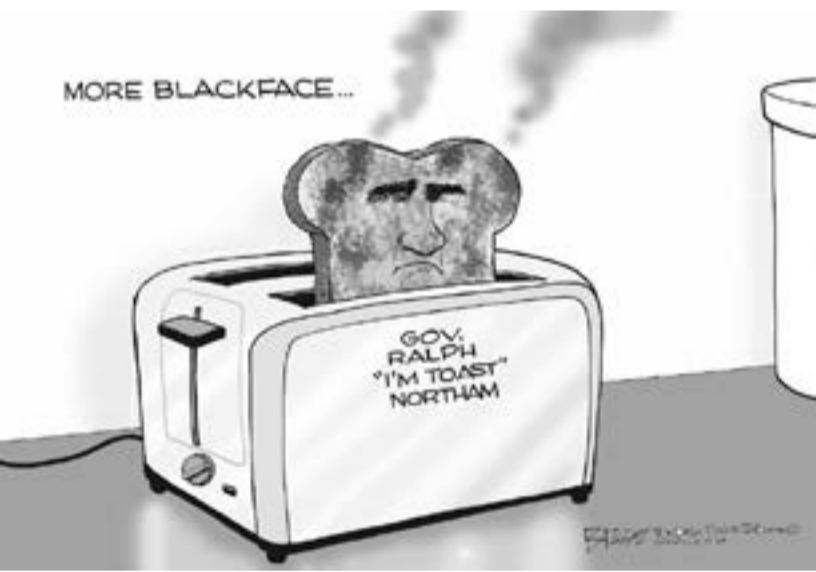
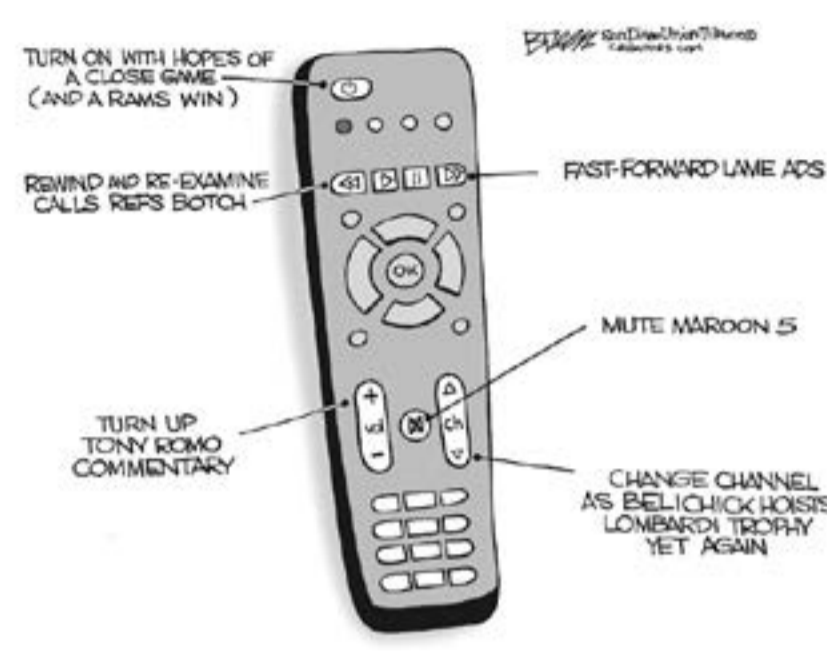
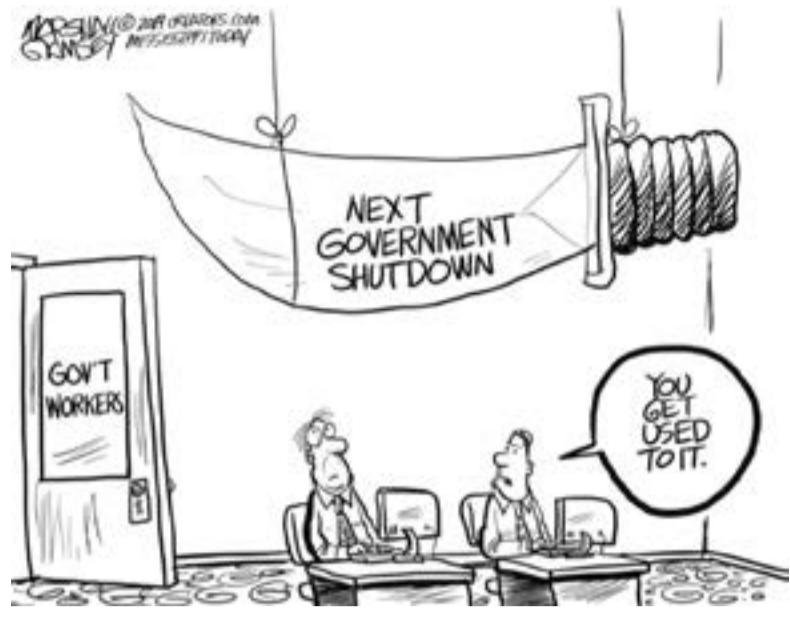

He was every old man you've ever met. And he wanted to go fishing. Doctors said it was a bad idea, but his son disagreed.

"Doctors don't know everything," says his son John. "Daddy wanted to fish, so by God, we took him."

You should've seen it. A sunny day. Four men escorting an old man down the dock. They lowered him into a 14-foot camouflage boat.

The old man held them for support. He mumbled something to them. Nobody understood. The strokes had slowed his mouth down.

The men used ratchet straps to make an improvised seatbelt for him. And away they went.

The old man had been fishing here ever since the invention of red mud.

"Feesing heah wuh mah bess gurl," the old man said through a contorted mouth.

His daughter translated for her kids: "Granddaddy says he used to fish here with his best girl."

Granny. His "best girl." When she was alive, they came here. The old woman loved fishing as much as he did.

The old man wanted a beer. He demonstrated this by reaching for the cooler. His daughter held a can to his mouth. Beer ran down his chin.

Everyone cheered. "Don't tell Daddy's doctor about this," John said.

The boat was in motion. The motor trolled. The old man was smiling. Familiar feelings were in the air.

"I remember when Daddy took my middle-school boyfriend out here," his daughter said. "I knew how to bait my own hook, my boyfriend didn't. Daddy got a kick outta that."

She also remembers a senior who once came calling on her. He drove a muscle car and wore too much leather. Her father greeted the kid on the porch, polishing his iron.

"Reckon you'd better keep

a'driving, son," her father told the kid.

The old man was something else. He was funny. He was clever. He was the best our land had to offer. A soldier, a salesman, a father, a fisherman. He was among the last of his generation.

He was a caretaker. They say he sat beside his wife's bed the morning she passed. He told her, "It's alright to leave, baby," right before her final sigh.

"Oh, he loved Mom," says his son. "When she got sick, he cooked, helped her use the restroom, doctors appointments... It wrecked him."

Then came his stroke. Then another. And more problems. He went downhill fast. The doctor said he didn't have long.

Someone's reel made a sound. A pleasant noise.

"Quick!" shouted John. "Give the rod to Daddy!"

John stood behind his father, holding the liver-spotted hands which once taught him to gut a bass. John did the cranking; the old man got the credit.

"Wee d-d-dugah!" the old man said.

"Wee doggie," his daughter translated. "Daddy used to say that a lot." Wee doggie.

That day came and went too quick. It seems like an ancient photo now.

"My daddy was the kinda man I wish I could be," says John. "Getting him out there on the water that day, I just wanted to say, 'Daddy, look at us, we're the beautiful family YOU made.'"

Yes. It was a beautiful afternoon, even though a very important woman was missing from the passenger count.

But then, none of that matters now. Because a few days ago, his best girl met him at the gate.

And I'll bet I know what they're doing right now.

During long, gray, bleak winters -- before the women's and men's college basketball tournaments and before baseball's opening days -- I confess to an embarrassing secret: I thoroughly enjoy watching TV- and movie-related awards shows on TV, not just the Oscars but also the Golden Globes, the Screen Actors Guild Awards and others.

Why? To catch the awkward and unscripted acceptance remarks when there are no cuts or retakes. For example, there was an unforgettable moment at the Emmy Awards more than a decade ago, shortly after Liza Minnelli married for the fourth time. (The 850 guests included Elton John and Donald Trump.) Her unlikely groom in the union, which would not survive to celebrate an anniversary, was David Gest, a music producer and first-time groom who, according to friends, had not dated any woman for three decades before Minnelli and chose Michael Jackson to be his best man, while the eight-times-wed Elizabeth Taylor was maid of honor.

The resourceful Martin Short was hosting the show and also was nominated for a best performer Emmy, which, it was announced, he did not win. After what

could have been a bit of a disappointment, an upbeat Short returned to continue his hosting duties and explained his reaction: "As David Gest said to Liza Minnelli on their wedding night, 'No hard feelings.'"

That brings me to my sadly untelevised but totally deserved award for the Great American Movie of the Year: "Stan & Ollie." It stars

John C. Reilly and Steve Coogan as, respectively, Oliver Hardy and Stan Laurel. They re-create before our eyes the two men who made the most successful double act -- forget Dean Martin and Jerry Lewis or Bud Abbott and Lou Costello -- in American entertainment history. But first and foremost, this is a story of the friendship, love and caring of these two entirely differ-

ent men -- the British-born Stan, who sailed to the U.S. with Charlie Chaplin, and the Georgia native Ollie -- as they, in the twilight of their careers, make, without popular demand, a would-be comeback tour of England and Ireland.

A warning: If your definition of a good movie includes at least one of the following -- explosions, car chases, extraterrestrials, serial copulation, murders, incest and natural disaster -- forget about "Stan & Ollie." I have always felt about "poignant" the way Supreme Court Justice Potter Stewart wrote about recognizing pornography: "I know it when I see it." Reilly and Coogan, here at the top of their professional games, have made a movie about two imperfect men that is moving and touching. It is sad, funny and heart-warming.

Please do yourself a genuine favor. Do not walk; run to the closest theater with the good judgment and respect for its audience to be showing "Stan & Ollie." If, like the case with your writer, running is more of a fond memory, please walk briskly to the theater. I promise you that you will be glad you did.

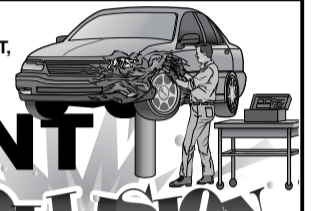
