### Gator Growl rocks UF

**■ LAUGHS RANGED FROM** PILLS TO PORN.

It started with three United Special Operations States Command paratroopers weaving red smoke above the stadium and ended with Wayne Brady impersonating Tina Turner.

More than 40,000 witnessed the Florida Blue Key-produced Gator Growl 2005 at Ben Hill Griffin Stadium on Friday night.

The show, billed as the largest student-run pep rally in the nation, featured improvisation by "Whose Line Is It Anyway?" star Wayne Brady, stand-up comedy from "Tough Crowd with Colin Quinn" regular Greg Giraldo, the crowning of the Homecoming queen and a fireworks finale that blanketed the stadium with smoke.

Pre-taped comedy skits were projected on two movie theater-sized screens on the sides of the stage, filling time between Gators teams and speeches by alumni and coaches pumping up the crowd. The skits featured mockeries of rival schools, the Alligator and UF President Bernie Machen's push to curb underage and binge drinking.

Machen sported a leather vest and jeans during the opening ceremonies while standing next to his Harley-Davidson motorcycle at the corner of the end zone.

"This is the Gator Nation," he said. "Let the Gator Growl.'

Giraldo made fun of everything from Christians traditions to erectile-dysfunction


"They've got a new boner pill out," he said. "They've got new pills every three sec-

### **Smith inspires Gators**

Just hours before kickoff, a UF team still searching for an offensive identity went through its usual game-day morning routine.

Then, Coach Urban Meyer decided to serve breakfast with a heaping side of old-school Gators' greatness.

Emmitt Smith, the NFL's all-time leading rusher, returned to Gainesville and spoke to the team about accountability and playing like a family.

What ensued was a 35-9 defensiveled pummeling of a Mississippi State team that had upset these same Gators just a year ago when goal posts came

down in Starkville, Miss.

"[Emmitt] gave as good of a speech to this team as I've ever heard," Meyer said. "The whole thing was to take care

### Scooter spots increase

Scooter parking on campus may increase at the expense of spots for full-sized cars, UF officials said.

Campus parking officials plan to replace lesser-used traditional parking spots this Spring with spaces for smaller-sized vehicles such as scooters and motorcycles, said Scott Fox, UF's Transportation and Parking Services director.

The department also plans a short-term fix this week or next, when it will enlarge the areas around select scooter parking lots, Fox said.

"We should be able to increase the amount of space available for motorcycles and scooters in a week or so," Fox said. "But any real noticeable change in parking space won't be ready for the students until the Spring."

He noted that any immediate increases in scooter parking will come from annex-

ing unused land next to current scooter lots.

However, any immediate additions to scooter parking will not be significant, he

Scooter sales in Gainesville have escalated by as much as 15 percent because of the dramatic increases in gas prices, according to a recent Alligator report.

The sales of motorcycle and scooter decals have seen a similar rise, tripling in the last four years, Campus Fox said.

However, the amount of parking zones for those vehicles has increased only slightly.

Fox explained that the delay in parking expansion stems from the fact that there is a finite amount of space on campus available for parking.

"With the limited amount of resources for parking, it has become an art to have






### Free flu shots no more

STUDENT HEALTH CARE CENTER WILL CHARGE \$5 FOR VACCINE.

UF students who benefited from free flu vaccinations in the past at UF's Student Health Care Center will be charged a \$5 copayment this year due to the rising cost of the vaccine.

"The cost of the vaccine has quadrupled," said Jane Cullen, associate director of nursing at SHCC.

Still affected by the flu vaccine shortage of last year, UF will receive only half of the usual 10,000 annual doses of the past five years, Cullen said.

Last October, the United States' second largest supplier of flu vaccines was unexpectedly shut down by British regulators because of possible contamination. UF was left without the 10,000 doses it typically administered free of charge to students, Cullen said.

As vaccines slowly arrived throughout the year, they were given to people considered at high risk, such as healthcare workers, those with chronic health problems and pregnant women, Cullen said.

Starting Oct. 17, SHCC staff will begin

administering the vaccine to those considered high risk.

On Oct. 25, any student, staff or faculty member can be vaccinated at the healthcare center and satellite clinics around campus. The shot, for which UF pays \$10.42 per dose, will be \$5 for students and \$20 for faculty and staff. FluMist, an alternative nasal-spray vaccine, will cost \$30.

"The co-pay of \$5 is just to feel like we're breaking even," Cullen said.

The shortages last year forced a cooperative effort between UF, Shands at UF and the private medical system in Gainesville to locate high-risk individuals, vaccinate them and work down the hierarchy, said Alachua County Health Director Tom Belcuore.

"There is a level of trust and faith in each other," Belcuore said. "We are ready for an influenza challenge of any kind."

Flu season in the United States typically starts in November and ends in May, peaking in early January.

### Cops catch theft team

Gainesville Police Department officers caught a team of two burglars Thursday.

Jamie Moodie, 24, and Greg Laughton Baldwin, 21, were arrested for breaking into two apartments and stealing items totaling \$2,312, according to police reports.

Moodie entered a Boardwalk apartment, located at 2701 SW 13th St., on Aug. 28 through an unlocked sliding glass door.

Moodie then stole two white leather purses containing \$300 and a Motorola cell phone worth \$250.

The second residence, an apartment in The Landings, located at 3801 SW 13th St., was entered

through a bedroom window. This burglary occurred on the night of Sept. 16.

Moodie stood as a lookout for Baldwin as he entered the bedroom and stole jewelry, X-Box games, an XBox game controller and 35 DVD movies, which he put in a stolen black Reebok duffle bag.

Moodie became a suspect when he sold six DVD movies soon after the second burglary to Hear Again CDs, 818 W University Ave.

Both men were interviewed by GPD to determine their involvement in other burglaries that have occurred in the city.

Baldwin and Moodie admitted to committing both burglaries and stealing the personal property that was inside the residences after the arrest.



### Desert defies CIMAR

UF's NaviGATOR, a 4,300-pound robotic racer, finished far better than last year's competitor in the 131.6-mile Grand Challenge race but came well short of winning the \$2 million prize.

Built by Team CIMAR, which is comprised of eight UF graduate students, the robot didn't finish the race, placing 18th out of 23, but did travel 23 miles, more than twice what last year's UF robot managed.

Stanford University's Stanley won the Mojave Desert race in 6:53: 48, under the 10-hour time limit set by the U.S. Department of Defense, which sponsored the competition.

At 3 a.m., all the competitors received the race route via CD-ROM. UF's team worked busily inputting the latitudes and longitudes into the global positioning equipment on board the NaviGATOR.

"We really pushed [the NaviGATOR] as hard as it could go because we came to win," said Dave Armstrong, project manager for Team CIMAR. "But it ended up costing us."

Armstrong said if they had slowed down their progress through the course, they could have easily

placed in the top five teams.

"The team didn't want to come to the line knowing we would lose," he said.

"This was a milestone in robotics for sure."

Armstrong is nonetheless proud.
"The vehicle we developed is an awesome machine," he said. "It was one of the cleanest out there. We spent a lot of time designing it and carrying out the building of it."


The team is bringing the vehicle back to UF to finish more details on the NaviGATOR and let the students perform more tests.

"Once we finish it up in the next six months, it will be one of the best unmanned systems in the world," Armstrong said.

The team will give its "baby" up for adoption when it donates it to the research and development department of the Air Force.

Although the loss was disappointing for the team, Armstrong said it was exciting to see the winning vehicle pass the finish line.

"This was a milestone in robotics for sure," he said.


JROTC members march to the commands of their superior officer during the Homecoming Parade on Friday.



Wayne Brady and Greg Giraldo may have two very different comedic styles, but they both agreed that getting their humor across to the thousands who attended Friday's Gator Growl would be a unique challenge.



### Library should get cut of Starbucks profit

Tvery time a Starbucks goes up, a few feisty idealists drag out their anti-corporate posters and lament the terrible 

It gets a little annoying.

But what really chafes the Editorial Board's bums is when we agree with their ultimate opinion and hate their empty arguments.

And we're feeling that distaste more than ever with the argument over placing a Starbucks in the remodeled Library West.

UF administrators want the company to have a permanent shop within the new library when it opens. The university will have to pay for a few start-up costs but ultimately will squeeze out a more than 10 percent commission from sales.

It will all be placed in a UF Business Services food service

Here's where the arguments come in.

Protesters argue that the library shouldn't be used for someone else's profit. They don't want ugly corporations in their place of learning, and thus want Starbucks run from campus like a dog with its tail between its legs.

This is incredibly far-fetched. As it has been stated again and again, UF needs money. Students pay close to nothing to attend classes, our government constantly cuts education budgets, and public schools like UF have to find ways to pad their accounts.

The answer is corporate money. We may not like it, and our campus may feel like an advertisement, but that's life. Deal with

Our only other option is to make students voluntarily increase their tuition three-fold. That's just laughable.

So why can't protesters turn their attention to something a little more constructive?

The Editorial Board believes the library should get a cut of Starbucks' profit. Our library is an integral part of UF, and the

coffee shop will be taking up valuable space.
UF is spending millions of dollars expanding the undersized library. We're betting it still won't be big enough to accommodate a collection appropriate for UF's 48,000 students. And now they want to take away some of that space for an establishment that will produce a lot of foot traffic without helping the

UF President Bernie Machen wants UF to be a Top 10 public research university. A library is an important part of that goal. Of course, there are a million other things that are just as important, but they won't have to deal with the irritating presence of

This is an easy opportunity to funnel money directly to a needy section of the university without touching the university's bigger budget.

But ultimately, it's the administrators' decision, and we don't

doubt that they need the money.

We're just a little taken aback by the kinds of tactics used to

In several e-mails, some UF administrators discussed how to discourage library officials from trying to get a cut of the Starbucks profits. They wrote about downplaying how much profit will be made and picking what figures should be used in a report to librarians.

Some bickering is always expected between two underfunded parties grasping for dough. But officials are starting to look a little childish, albeit entertainingly so.

The bottom line is that everyone needs money and no one should underestimate that need. But UF officials should look to create good relations with the library, rather than trying to deviously deprive librarians of a say in what happens in their workplace.

### Religious right draws morals from faith

ho's afraid of the big bad religious right? Lots of people, apparently, and they range from conservatives to the far left.

Try typing "religious right" into Google. The first entry I found was a Web site called Theocracy Watch, and another paid link simply said, "Stop the religious right." The third was titled, "How to fight the Religious Right: a guide to defending yourself against Fundamentalist Christians" and stated that fundamentalists' "existence is a threat to

Are these Web sites talking about terrorists, vampires or those wrinkly old people who talk about Jesus on

And the paranoia doesn't stop with fringe Web sites. The People for the American Way list several Christianoriented groups in its "Right Wing Watch," and some days its Web site contains more headlines sniping at the Christian right than at the president.

There is a general consensus that President Bush won re-election because of the contributions of some fundamentalist groups, and this belief has sprung an abundance of books aimed at secular or politically liberal audiences. They all reinforce the same old bigotry, that the Christian right is a small group of manipulative white men who hide behind the Bible to oppress gays, keep women in the kitchen, stop teenagers from having premarital sex, and other sorts of fun.

These books have titles like "Jesus is Not a Republican," and one specifically uses the words "religious right's conspiracy." But most books on the subject don't bother making a case for a liberal Jesus. They simply maintain that the religious right has little to no business in politics because of the separation of church and state.





### Super-flu could kill as many as 1.9M Americans

A super-flu could kill up to 1.9 million Americans, according to the government's plan to fight a worldwide epidemic.

The Bush administration has spent the last year updating its plan for how to fight the next flu pandemic. A recent draft of the plan, first reported Saturday by The New York Times, models what might happen

based on the last century's three pandemics. In a best-case scenario, about 200,000 people might die. But if the next pandemic resembles the 1918 Spanish flu, as many as 1.9 million could die, Michael Osterholm

The bird-spread avian flu, which kills more than half of humans infected, can be contracted through undercooked poultry as well as contact with the saliva, mucous and feces of the birds, said a representative of the Centers for Disease Control and Prevention.

Alachua County Health Director Tom Belcuore said avian flu is a concern.

"It represents the potential that for the first six months, if it mutates, there will be no vaccine ready, and it will circle the globe," he said.

The number of confirmed human cases of the virus is increasing, a World Health

Organization report showed. Seventy-one human cases of the virus were reported since the end of last year, the report stated. There have been 59 known deaths, 27 of which were reported in the last year.

Although cases of the virus have only been reported in Asia, worldwide transportation of the virus is possible through planes and travelers, the CDC representative said.

"There is terror of this virus because there is no immunity to it," he said.

If the avian flu reaches Gainesville, Belcuore said, laboratory teams will be sent out to investigate every case of flu virus, even if it is not the avian flu. The department will have a plan that follows federal guidelines to allocate the antiviral medication Tamiflu.

The government has on hand enough of the anti-flu drug to treat 4.3 million people. Manufacturing of \$100 million worth of a bird flu vaccine just began.

Mary Thorkildson, nurse practitioner of the UF Student Health Care Center at Shands and coordinator of clinical programs, said she doesn't know if avian flu should concern UF.

"When it is something this remote, we're not proactive," she said about the virus.

### UF defense leads charge against Bulldogs

`That was a powerful message by arguably the greatest football player of all time. And a Gator."

Apparently Smith's message affected the entire team, not just the offensive players. It was UF's defense that held the Bulldogs to 243 total yards, while pressuring for six sacks, creating three turnovers and registering two safeties.

Defensive end Jeremy Mincey led the charge with 10 tackles and two sacks.

But it was middle linebacker Brandon Siler that had arguably the most dominating game. Siler, who knocked the Bulldogs' quarterback Omar Conner out of the game with a bruised chest, finished with four tackles, a fumble recovery, a sack and a safety. After the game, Meyer called Siler the defensive MVP.

Despite the success on defense, Meyer walked off the field seemingly in despair for an injury-riddled offense trying for consistency and production. It's also an offense, ready or not, that will face No. 10 Louisiana State on Saturday.

"What you've been seeing on the field is not what

we've been trying to run, and I'm not satisfied with our offense at all," Meyer said. "We're obviously struggling. I think the 480 offensive yards you see on paper is very misleading."

After secretly not practicing all week with a bruised right shoulder, quarterback Chris Leak went 18 of 33 for 244 yards with a touchdown and two interceptions. Dallas Baker led all receivers with seven catches for 123 yards, both career highs, and a touchdown.

While the passing game showed signs of promise despite missing both Andre Caldwell and Jemalle Cornelius, it was a different story for the running game. Redshirt freshman Markus Manson had the best day of the running back by committee, showing the speed needed to be successful in Meyer's offense. Manson ran the ball seven times for 45 yards. But with a trip to Death Valley looming, the Gators ran back into the tunnel with a question mark at the position where Smith once ran supreme.

"I thought Markus Manson played very well for us today," Meyer said. "He averaged 6.4 yards a run and did some good things, but right now we're still a running back by committee, and we'll continue to do that until someone steps up and owns the spot."

our limited supply meet our incredible demand," he said.

Managing spots for scooters and cars is difficult, he said, because any time the scooter parking is increased, a space must be taken away from someone else.

On campus, the stretch of Museum Road from Newell Drive to Southwest 13th Street sees an average of 16,000 vehicles a day, according to data from the Division of Facilities, Planning and Construction.

And with more scooters in Gainesville, traffic will only be

a greater problem on campus, said Lt. Joe Sharkey, University Police spokesman.

"Any time you have an increase in the amount of vehicles around campus, this time from scooters and motorcycles," Sharkey said, "it's always going to amount in more traffic and congestion."

### Getting started

#### How do I find an apartment?

Pick up an Off-Campus Housing Packet from the University of Florida Division of Housing located at the corner of Museum Road and S.W. 13th Street. It contains maps and information on apart-ment complexes and utilities.

Rental opportunities may also be found in the classified sections of The Gainesville Sun, The Independent Florida Alligator, and bulletin boards around campus.

#### What should I look for in an aprtment?

In Gainesville, there is a glut of available apartments. You should examine several apartments before signing a lease.

- Application Deposits: Never put down a deposit to hold an apartment unless you have a written agreement indicating whether it is refundable.
- Cost: Can you afford it? Even if your roommates leave?
- Location: Is the neighborhood safe? Even at night? Are you within easy walking or cycling distance of campus? Are buses

available?

- City Limits: Gainesville protects tenants by enforcing housing codes. The city will order landlords to make repairs. Alachua County will inspect apartments and issue a report of violations.
- Model Apartments: Never sign a lease based upon a model. Insist on seeing your actual apartment.
- Pest Control: Does the landlord maintain a regular spraying program?
- Function: Check appliances, run water in all sinks, showers and tubs, flush toilets, and check air conditioning and heating.
- Appearance: Is it clean? Do the carpets look worn or smell bad? Has the apartment been recently painted? Do the walls have nail holes?
- Inventory: Note all defects on the inventory sheet or check-in list signed by the landlord or an impartial witness. Photograph or videotape the apartment at move in.
- Landlord: Speak to tenants of the apartment complex. Does the landlord make a habit of unannounced entries? Are repairs made quickly?
- Noise and Parking: Check for noise and parking problems by visiting the apart-

ment at various times during the day, at night and on weekends.

- Safety: Are there deadbolts on the doors? Are hallways and parking lots well lit? If there are sliding glass doors, are there adequate locks to deter forced entry? You can contact the Alachua County Sheriff's Office or the Gainesville Police Department to obtain information on crime in the area.
- Single-Family Housing: The landlord may legally provide fewer services for houses and duplexes. The landlord may also shift maintenance responsibilities to you in the lease. In some neighborhoods, only three unrelated persons may live together. Check with the city if you plan on having more than two roommates.

#### What should I do before I sign a lease?

- ☑ Do read the lease and make sure you understand it.
- ☑ Do have a lawyer review the lease.
- ☑ Do expect to pay full rent, not just your share. This is what "joint and several" liability means, a term included or implied

in nearly all leases.

- ☑ Do obtain a copy of the lease and all attachments or addendums to the lease
- ☑ Do have all promised repairs and improvements written into the lease and signed by the landlord.
- ☑ Do keep a copy of the lease and all the attachments or addendums with your important, permanent records.
- ☑ Do insist on seeing your actual unit.
- ☑ Do get clear written permission for any
- ☑ Do check for maintenance responsibilities when renting a house or duplex.
- ☑ Do not sign a 12-month lease unless you are willing to pay rent for 12 months.
- ☑ Do not sign a 12-month lease with roommates unless all roommates are willing to pay rent for 12 months.
- ☑ Do not have your parents sign the lease or a parental guarantee agreeing to be responsible for rent.
- ☑ Do not sign a lease with an automatic renewal clause.
- Do not sign a lease that gives the landlord unlimited access to the apartment without notice or consent.

- Do not sign a lease before visiting the neighborhood at various times during the day, at night and on weekends.
- ☑ Do not sign a lease until all agreements negotiated with the landlord are in writing.

#### How do I find a -good roommate?

The University of Florida Division of Housing maintains a roommate share board. Other bulletin boards around campus and classified ads are additional sources.

Discuss with potential roommates preferences in food, music, personal habits, sleeping and study hours, friends and finances. An open and frank appraisal of each other's likes, dislikes, and expectations will increase the chances of an enjoyable shared living experience. A written roommate agreement is advisable.

Do I really need insurance for my personal property?

Yes. Unless you are financially able to replace all your belongings, you should have insurance. Proper insurance coverage will protect you against the loss of your valuables in most circumstances. Landlord's are legally responsible for such losses only under very specific, limited circumstances which may be very difficult to prove in court.

If you are a resident-relative of your parents, your personal property may be insured through their homeowner's policy. Have your parents confirm the coverage in writing with their insurance agent.

If coverage is not available through your parents' homeowner's policy, you may be able to purchase renter's insurance. Even with insurance, there are certain precautions you should always take. Always lock your apartment securely even if you are only going next Never leave jewelry, cameras, cash, checkbooks, credit cards, or other valuables in plain sight.

Getting Along
My landlord refuses to make repairs.

What can I do?

You may be able to either withhold your rent or terminate your lease if the problem

constitutes a material breach of the lease or the Act. You must follow the exact require-

You must give the landlord a written notice demanding the repairs be made in seven days. The notice must indicate your intention to terminate the lease or withhold rent if the repairs are not made.

This is a complicated process and the legal consequences are very serious. You should obtain legal advice before attempting to terminate your lease or withhold rent.

Can I deduct repair costs from my rent?

No. The Act does not authorize you to make repairs or to recover the cost of such repairs. In fact, most apartment leases prohibit repairs by tenants. When the landlord refuses to make repairs, the Act gives you a qualified right to terminate the lease or withhold rent. As previously indicated, you should consult an attorney before attempting to terminate the lease or withhold rent.

What can I do about noisy neighbors?

Try to reason with the neighbor to reach an acceptable compromise. Thin walls and conflicting schedules make some amount of noise disturbance an unavoidable reality of apartment

Ask the landlord for assistance. If the landlord refuses to correct the problem, you may be able to break your lease. Because the law in this area is so poorly developed, legal representation is a necessity.

In extreme cases, call the police and report the matter. Unfortunately, this can lead to revenge and reprisals.

#### I can't stand my roommate. What can I do?

Immediately discuss the matter with your roommate. Don't ignore the problem with the hope that it will go away. A little give and take may result in a livable compromise.

Under the Act, your landlord is not responsible for most roommate disputes. If your roommate is violating the lease, you should consult an attorney.

#### Can my rent be increased during my lease term?

Not unless the lease contains a specific provision allowing for a rent increase. From the tenant's perspective, one of the primary reasons for having a written lease is to lock in the rent for the rental period. Normally, you should not sign a lease providing for a rent

#### Can my landlord enter my apartment without notice?

No. Unless there is an emergency or you have abandoned your apartment, the landlord must provide reasonable notice and obtain your consent prior to entering your apartment.

You cannot unreasonably withhold consent. If the landlord persists in entering without notice or consent, contact an attorney.

> How soon must I renew my lease?

There is no time period established by the Act. You should not sign a lease that provides for automatic renewals or requires you to give the landlord a notice of nonrenewal. If you do sign such a lease, you must strictly comply with the notice requirements imposed by the lease.

If the lease does not specify otherwise, renewals are a matter of general contract law. The landlord cannot force you to renew prior to the end of your lease. However, if you do not renew by the landlord's "deadline," the landlord may rent your apartment to someone else.

Getting Out
Can I break my lease because... "I am graduating?" No! "My roommate left?" No! "I cannot afford the rent? No! "I need to work this summer?" No! "The neighborhood is unsafe?" No!

Under the Act, you can only terminate the lease if the landlord is materially violating your lease or the Act. You should obtain legal advice before attempting to terminate your lease. In many cases, the best thing you can do is find replacement tenants.

#### Can I sublet my apartment?

Usually. The landlord cannot unreasonably withhold consent to an assignment or sublease. The landlord may require potential replacement tenants to submit an application including a credit check. The landlord may also charge a reasonable sublet fee even when you provide the replacement tenants. Normally you remain liable under your lease if the replacement tenants do not pay rent or damage the apartment. Some landlords will release you from the obligations of your lease. If you are being released, get it in writing.

#### Can I just move out and forfeit my security deposit?

No. Some tenants will walk out on a lease and receive no adverse action, while others will be pursued to the fullest extent of the law. In Gainesville's current rental market, the odds are that you will be sued unless you supply acceptable replacement tenants.


Your losses in court will not be limited to your security deposit, but will include rent for each month the apartment remains vacant during the term of your lease, plus court costs and the landlord's attorney's fees.

#### Getting it back What steps can I take to protect my security deposit?

When you take occupancy of the apartment, complete a thorough written inventory of the apartment's condition and have the landlord or an impartial witness sign the inventory. Make sure you keep a copy of the inventory. This helps protect you from the landlord claiming you caused pre-existing damage.

When you move out, completely and thoroughly clean the apartment. Some landlords provide a checklist outlining the cleaning they expect you to do. Keep all your receipts for cleaning supplies and professional carpet cleaning as evidence.

Before you leave, ask the landlord to inspect the apartment with you. Complete a move-out checklist and make sure the landlord signs and dates it. Use an impartial witness if the landlord is not available or refuses your request. Move-in and move-out

photographs or videotape are also strongly recommended in case there is a dispute.

#### Can I use my security deposit for the last month's rent?

No. Landlords can legally evict you for non-payment of rent even when your "security deposit" is equal to your last month's rent. The purpose of the security deposit is to protect the landlord against damages to the apartment.

### Does the law require interest payments on security deposits?

Landlords must hold security deposits in one of three methods. Two methods of holding the deposits require interest to be paid. The method which does not require interest payments is the one most landlords use. The landlord is required to inform you in writing how your deposit is being held, where it is held, and whether you will receive interest.

### What can I do if my landlord doesn't return my deposit?

A landlord shall have 15 days after termination of the lease to return the security deposit together with interest if otherwise required, if he or she does not intend to impose a claim on the security deposit. If the landlord intends to impose a claim on the security deposit, he or she shall have 30 days to give the tenant written notice by certified mail, stating how much is going to be deducted and why. You must object to the deduction in writing within 15

days from the date you receive the notice, or the landlord will be authorized to deduct his or her claim from your security deposit.

If the landlord fails to give the required notice within the 30-day period, he or she forfeits the right to impose a claim upon the security deposit.

However, if you damaged the apartment, the landlord can sue you even when the 30-day notice is not given. Because the landlord can also get court costs and attorney's fees, you should consult an attorney before filing any lawsuits.

## Getting Evicted What are my duties as a tenant?

- \*First, last, and always PAY RENT!
- \*Comply with all other lease terms.
- \*Comply with all rules and regulations.
- \*Comply with housing and health codes.
- \*Comply with all zoning restrictions.
- \*Keep the apartment clean and sanitary.
- \*Keep plumbing fixtures sanitary.
- \*Do not damage the apartment.
- \*Do not disturb your neighbors.

#### What exactly is an eviction?

An eviction is the formal end to your right to occupy the apartment. It does not end your duty to pay rent.

An eviction starts with a Summons. You must file an Answer within five days. Contact an attorney immediately.

If the court rules against you, a judgment for possession of the apartment, unpaid rent, late fees, interest, court costs and attorney's fees will be entered for the landlord. The sheriff will post a notice at the apartment that requires you to vacate in 24 hours. If you do not vacate within 24 hours, the sheriff will remove you and your personal property from the apartment.

### What can happen if I don't pay rent?

Failure to pay rent is the quickest way to be evicted. The landlord will serve a notice demanding payment of rent or possession of the apartment. If you fail to comply with the demand within three days, excluding weekends and holidays, eviction proceedings may be started. Neither surrender of the apartment nor eviction ends your liability for rent. You should immediately contact an attorney upon receipt of a three-day notice.

### Can I be evicted for any other reasons?

Yes. Your lease can be terminated if you violate any lease terms, rules and regulations, or the Act. If your lease is terminated and you do not vacate the apartment, the landlord may immediately file for your eviction.

Termination begins with a 7-day notice. Your options depend on whether the violations are classified as "curable" or "noncurable."

If you receive either type of notice, you should immediately contact an attorney. Neither termination of your lease, nor your eviction from the apartment ends your liability for rent.

#### Curable violations:

You will be given seven days to correct a curable violation. Curable violations include

unauthorized pets, guests, or parking, or the failure to keep the apartment clean and sanitary. If you repeat the violation within 12 months, you will not be given another chance.

#### Noncurable violations:

The landlord may terminate your lease with a 7-day notice without giving you a chance to correct a noncurable violation. Noncurable violations include deliberate destruction or misuse of the landlord's property or a continued, unreasonable disturbance.

#### Can I be evicted if I pay "my" rent and my roommates don't?

Usually. Most leases provide that the tenants are jointly and severally liable for the entire rent. This means the landlord can evict you unless the full rent is paid.

It is possible for you to sue your roommates in small claims court to collect their share of the rent and utilities. A written roommate agreement will be helpful in proving your case in court.

Given the difficulty of collecting money on a judgment quickly, the best thing you can do is obtain new roommates.

### So what if I get sued, I have no money!

Any judgment for money damages is enforceable for at least 20 years and earns interest. A judgment may be enforced by seizing your wages, bank accounts, or your personal property. A judgment will also adversely affect your credit rating.





### Nelson smiles wide on UF special teams

**THE JUNIOR SPARKED** THE GATORS WITH TWO **PUNTS DOWNED INSIDE** THE 1-YARD LINE.

If you knew what made Reggie Nelson happy, you wouldn't want to make him mad. It's not that he's a bad guy. All it

takes is a glance at his ever-present smile to figure that one out.

Just stay out of his way on Saturdays, and everything will be just fine. But step on his 100-by-53-yard lawn, and his smile won't

look all that pretty.
"I love hitting," said the UF cornerback with a chuckle. "Hitting, smiling and going back out there to do it again."

That's because he's a football player - a hungry football player, looking to finally make a name for himself in Gainesville.

So far, he seems to be doing a pretty good job.

As the Gators' offense floundered against Mississippi State on Saturday, the first-year junior helped construct a special teams extravaganza, recovering a fum-bled punt and setting up a pair of safeties with two punts downed inside the 1-yard line.

Not bad for a guy who played the last two seasons at Coffeyville (Kansas) Community College.

"Reggie did both of them?" asked UF coach Urban Meyer about Nelson's pair of downed punts. "What a football player he is. I tell you, he hits you and he smiles. That's a hell of a concept. Reggie Nelson is a heck of a football player."

Perhaps that gridiron grin is what Bulldogs return man Jonathan Lowe saw just before he muffed a punt inside his own 15, with Nelson screaming right toward his head.

Maybe Mississippi State quarterback Michael Henig could explain the terror of Nelson's pearly whites after the cornerback twice gave him a worm's eye view of Florida Field.

At 6-foot-1, 175 pounds, Nelson might not look too imposing. But Gators linebacker Brandon Siler knows a headhunter when he sees one.

"He's great. He comes off that edge, and he's coming to get you,' said Siler of the Gators' nickel back. "And he packs a punch too. You would think with a little guy like that, he doesn't, but he does



Credit that tenacity to two years of football purgatory in Coffeyville, where Nelson enrolled after failing to gain entry into UF in 2003 due to

academic issues.

Now, Nelson, the Gators' No. 3 cornerback, must make the most of any opportunity.

"Every chance I get, I just go out there and make the best out of it," said Nelson, who works more with the special teams than the defense.

And that kind of work ethic has made Nelson a popular figure in the UF locker room.

In the words of defensive end Jeremy Mincey, Nelson is the Gators' "sixth man."

While he might not see most of the snaps on Saturdays, his teammates can rely on him to make plays after those that he does.

"I love Reggie Nelson," Mincey said. "He's one of my favorite players on the team. He comes with his A-game every game. He doesn't play as much, but every time he does he makes a huge impact. I love it every time he's in there. I can always count on him, and that's a large part of it-accountability."



### Leak fights through injury

**A SECRET SHOULDER** INJURY KEPT THE JUNIOR FROM PRACTICING

This was the kind of play UF skeptics had sneered about.

Chris Leak, regarded as a far better pocket-passer than runner, chugged to his right then pitched the ball to Chad Jackson. Jackson wheeled ahead for six yards. Meanwhile Leak, his right shoulder leading the way, was crushed into the turf by Mississippi State defensive back Kevin Dockery. Leak's arm dangling from his shoulder, he straggled off the field. There was one prevailing assumption among players: Leak

was done. "The fans were thinking the same thing," receiver Dallas Baker said.

The truth?

Leak was done last Saturday

when his shoulder was bruised against Alabama. A week later, after Leak completed just 18 of 33 passes, Coach Urban Meyer revealed his dirty little secret:

"I don't want to keep things from you - I also don't want the opponent to know - but Chris Leak didn't practice this week," Meyer said.

"A real courageous guy, a tough guy," Meyer said. "He missed some throws and hopefully we'll get him ready for this

week coming up. I think he's ok." Or is he? Meyer said Leak aggravated a shoulder injury suffered in last season's Florida State game. Leak denied such claims

"That's a totally different deal," Leak said. "It's just something that aggravates you, but it's nothing more than a bruise."

For a Gators team that has scored four total offensive touchdowns against the likes of Tennessee, Alabama and Mississippi State, it seems like there could be nothing worse than the possibility of a chronic injury for Leak.

Saturday, the junior looked confused at times. At others, the shoulder clearly fitted Leak with a straitjacket. He overthrew his receivers on several attempts, including an errant pass to a streaking Nyan Boateng in the end zone.

He also threw two more interceptions, bringing his total to four in the last two games

"Of course you want to correct that and make sure that you're making the right reads and that guys are making the right routes," Leak said. "The first thing I have to do is protect the ball. Everything else will get cleared."

### Injuries plague offense

On Sunday, Coach Urban Meyer revealed that injuries and depth are what concerns him most as his No. 11 Gators (5-1, 3-1 SEC) begin preparation to face No. 10 Louisiana State on Saturday.

"I said it before and I'll say it again," Meyer said. "We are not a great team. We just have a few players who are playing great. Right now though, we need to get those players some rest because the game against LSU will be fast-paced.

Meyer applauded defensive end Jeremy Mincey for his effort on Saturday. As fellow defensive end Ray McDonald continued to recover from a knee injury, Mincey registered two sacks and 10 tackles against Mississippi State.

The good news for the defense is that McDonald may be back on the field sooner than expected.

"The doctors have only had positive things to say about Ray," Meyer said. "He could make a contribution this week against LSU, but for sure he will be back by the Georgia

On the other side of the ball, an injury to junior Jemalle Cornelius has further limited an offense already plagued by the season-long loss of Andre Caldwell.

"You take [Cornelius] out and all we have in experienced receivers is Chad Jackson and Dallas Baker," Meyer said. "It is impossible to run any offense with only two receiv-

Cornelius suffered an ankle sprain in the second half against Alabama and did not see any action against Mississippi State. Jackson suffered a knee injury and Baker had to leave the field during the third quarter due to cramping.

Excluding Jackson and Baker, UF's stable of wide receivers have combined to catch only four passes the last two weeks.

"Ideally, you want five thoroughbreds out there," Meyer said. "We have about 35 plays with five or six wide receiver sets, so you can see why the passing game is having problems."



### Baker becoming UF's go-to guy

If Urban Meyer's offense truly isn't ready for Southeastern Conference play, somebody forgot to relay the message to Dallas Baker.

The spring superstar, the receiver with all the big-play potential, the player that seemed to have an underachiever patch sewn on his jersey, has finally emerged. What a time to

With two of UF's top receivers out with injury and UF's offense stuck somewhere between neutral and reverse, Baker has surprisingly become quarterback Chris Leak's goto guy. After proving to be UF's only legitimate threat in a loss to Alabama a week ago, Baker once again hit the century mark in UF's 35-9 victory against Mississippi State, scoring a touchdown and receiving a solid endorsement from Meyer.

"Dallas Baker played a tremendous game," Meyer said. "I think he's turned into our most polished

Baker finished with a career-high 123 receiving yards on seven receptions while adding a timely touchdown that gave UF a comfortable 19-3 lead midway through the third quarter.

"Honestly, it feels like a dream," Baker said. "I've been trying so hard to step up my play from the fall to the spring, and now that I'm finally doing it, it's like, 'wow."

Baker has been the unofficial MVP in the last three spring games, wowing the crowd with acrobatic

Yet, when the scores count and the opponent is no longer a teammate, Baker has faded into the background, while players like Andre Caldwell and Chad Jackson have become SEC stars.

"He kind of came in as a freshman not really knowing his place and now he's really fitting in," center Mike Degory said. "His eye is there and that's the thing that maybe sometimes people question him on. We really see what he's doing now,

and he's producing."

It's been nearly a year-long odyssey for Baker, whose career hit a low point last season after a devastating and controversial personal foul against Tennessee.

Baker said Meyer and receivers coach Billy Gonzales have challenged him to become more of a man on and off the field while becoming more assertive on game day.

"I can't be one of those guys that likes to sit back in the shadows and think, 'Well, we need Chad to make a play, or Chris or DeShawn Wynn," Baker said. "I have to be one of those guys that comes in when my number is called and make a play."

But are back-to-back 100-yard games really that impressive considering that Baker underachieved for more than two seasons?

Baker doesn't believe he'll suffer a relapse. When he hits the practice field on Monday, he won't remember the 123 yards and the touchdown.

"When I go out to practice I'm going to act like I had only two catches for negative 3 yards," Baker said.


