Bronson Incurs Wrath of Verizon for Letter from City Attorney

A potential jackpot for Bronson may have evaporated because of a "crazy letter" sent by City Attorney Steve Warm.

The town was being offered about \$1,000 per month for up to 20 years, with a 2 percent increase annually, if it allowed Verizon wireless to build a cell phone communications tower at the James H. Cobb Park.

The deal is on ice for now.

Verizon representative Mike Nuckols said based on a letter it agrees to the lease language and terms. He said he is

from Warm which he said accused Verizon of dishonesty, he was considering other options and it was unlikely a deal would be possible.

"Based on that crazy letter from the attorney, I need something in writing to give me a comfort level that the Town Commission can be reasonable," Nuckols wrote. "I'd say it's unlikely to work out based on crazy talk (calling us dishonest), but I'm trying to be open-minded and can appreciate you're in a tough position. Thanks!"

Nuckols said he needs a letter from the town stating

considering another option and the offer to the town is being seen as a back-up.

Warm had written a Nov. 6 review of the Verizon contract at the request of the council. His letter, which the town sent to Verizon, criticized the way parts of the contract were written and called one paragraph that sandwiched in the term "annual termination" as "disingenuous."

The term disingenuous generally refers to someone not being candid or sincere.

Warm said Nuckols was basically calling him a "bum" and continued on page 3A

Commissioners Decline Williston Landowner's Request to Get **Information on Gas Pipeline**

Levy County commissioners Tuesday declined a request by a Williston property owner to use their powers to ask questions of a company building a gas transmission line through private property in the Williston area.

Beth Gordon said she has attempted to ask questions of Sabal Trail Transmission LLC but the company has been unwilling to explain how they plan to protect property owners or if they are insured for disasters.

"I think everyone knows pipelines are dangerous. They blow up all the time," said Gordon, an attorney who lives about five miles outside Williston and is worried the methane pipeline could be a hazard to residents.

Gordon said she wants to know more about the methane transmission pipeline. She said the company plans to bury the 36-inch pipeline three feet under her property and run the pipeline through farms and residential property in the Williston area.

She wanted commissioners to require the company to be insured for accidents and to build the pipeline on county easements when possible to avoid private lands. She also wanted to know if county fire rescue departments were being trained to respond to a major gas pipeline explosion.

Gordon wanted commissioners to invite Sabal Trail Transmission LLC to a county commission meeting to answer questions that she said company officials dodged when she made inquiries.

"It's a fairly substantial pipeline and we don't know continued on page 7A

Chiefland Realtor Doris Rogers passed away Saturday. She was known to be prim and proper in the way she dressed and carried herself as a businesswoman.

as a respected civic and political leader, passed away Saturday among family and friends at her 95th birthday party. Rogers, a real estate broker, sold the land that Winn Dixie and Eckerd's

became the site of the former drug store shopping center across from Chiefland High School, and she also sold the the Wal-Mart Supercenter.

"I remember every day Doris would come through in her Cadillac to make sure everything was okay with construction of the shopping center," said former City Commissioner John Hart. "She had a thing about neatness and detail."

Always considered a courteous but professional businesswoman, her daughter Carolyn told the story of how she reacted at the closing on the Wal-Mart property when Wal-Mart officials asked her for the deed and said they would send her a check later.

She politely rejected the offer. Rogers responded

She served on the city commission from August 1983 to August 1985 and served on the planning board for three terms – from June 1975 to August 1983, from November 1985 through August 1991 and from January 1992 to February 2001.

Rogers was active at First Baptist Church and loved the Chiefland community.

"If asked my opinion of Mrs. Doris (D.L.) Rogers, I would have to say Chiefland has lost one of its best friends. She never missed voting in city elections and was always interested in community activities," said A.D. (Andy) Andrews, publisher of the Levy County Journal. "After arriving here in 1952, Mrs. Doris was highway frontage that became always involved in church and interaction with the people of Chiefland. She immediately became one of us. I would have to say that with the many business activities that she was involved with, she was a latter day pioneer of Chiefland. She will be sorely missed."

Two years after arriving in Chiefland with her husband and children, Carolyn and Earl, Rogers became a realtor in 1954. At the time, there was no business district from Chiefland High School north. She started out as a salesman with her husband D.L., but he told her in a subtle way to prepare for life without him, if it ever came to that.

Toys for Tots Giving Good, but Could Have **Been Better**

Children who registered to receive Christmas gifts from the Toys for Tots Christmas gift program won't be disappointed this year, but the organizers were hoping for a better result.

In Gilchrist County Tuesday, 420 children received 6 toys, 1 game and 1 sports gift. The 370 Levy County children registered to receive gifts this Friday at Wal-Mart in Chiefland will receive the same number of gifts.

Giving was especially heavy in front of the Wal-Mart Supercenter store in Chiefland Sunday following a story in the Levy County Journal noting that giving had been light up to that point.

But the total number of toys given to Toys for Tots, even with Saturday's surge in giving

at Wal-Mart, was 1,200 toys. The Toys for Tots program purchased an additional 1,100 toys with sponsorship money, individual cash donations and raffle money, according to organizer Bryan Chrisp of the Marine Corps Reserve.

The total amount of cash collected was \$11,000.

Chrisp said this was the first year back after a layoff for Toys for Tots, and that made a difference. In Williston for example, donations were light, but there weren't many box locations. Chrisp blamed the lack of locations on the fact that this was a reorganizing year. He said he would focus on Williston next year.

He said the number of children registered in Levy County was less than in Gilchrist County for the same reason. It was the first year back for Toys for Tots and the organization didn't

register as many Levy County children as in the past.

But there were many bright spots. The AmVets Post 444, American Legion and several motorcycle clubs collected eight full boxes of toys Saturday during a Toys for Tots run.

Even as late as Tuesday, generosity prevailed. A full box of toys left Deke's Steakhouse around noon destined for Toys for Tots. People who preferred to give cash often stopped at Toys for Tots locations and dropped a dollar or two in the collection box.

Collections at Wal-Mart ceased this week because the store chain had promised Toys for Tots three weekends. The fact that it rained all day Saturday didn't help matters.

But Chrisp is optimistic that Toys for Tots will get better as it literally gets its legs back

Gainesville Man Gets 5 Years in Prison for Williston Carjacking

Jordan King, an 18-year-old Gainesville man, was sentenced by Circuit Judge William Davis to 5 years in state prison last week on charges of robbery and carjacking.

Williston police say King and two companions, a man and a woman, concocted a plan in Gainesville on April 11 to rob Darryl Rucker of his truck in Williston.

Co-defendant Merse'des Bowers was used as bait in the scheme. She arranged to meet Rucker at the Williston Motor Inn. When she arrived, Rucker was already at the motel in his

Sentencings from the Bench

Circuit Judge William Davis issued the following sentences in Levy County Circuit Court last week.

Jessie Bryan Balogh, 26, Chiefland, 180 days days in the Levy County Jail, with 50 days in the Levy County Jail with 21 days credit for time served on charges of cocaine possession, paraphernalia possession and resisting without violence.

Balogh was arrested by Chiefland police on Nov. 22 after they saw him loitering at the South Chevron station. When police began to approach him he placed a beverage on the window sill and started to walk away.

When officers tried to place handcuffs on Cook he pushed one of the deputies in the shoulder, knocking a microphone loose. He was placed on the hood of a patrol car to gain control of him. At the jail he was told to take his shoes and socks off. He threw one of the shoes at a deputy. Kyle Dean Courtier, 21, High Springs, 180 days in the Levy County Jail, with 34 days credit for time served, for probation violation.

As soon as Bowers climbed in the truck with Rucker, King and a second man, Jaakrri Middleton, armed themselves with guns and walked over to Rucker's truck. Middleton handed his gun to King and walked to the driver's side and pulled Rucker from his truck, Levy County court records said.

King was pointing his weapon at Rucker as the victim exited his truck. Rucker said later that he thought he was going to be shot. The suspects allowed Rucker to go free. The three suspects left the Williston Motor Inn in two vehicles, with Middleton driving Rucker's truck.

Williston police were notified of the carjacking and attempted to stop Middleton on U.S. 41 as he headed toward Gainesville. The high speed chase reaching speeds of 100 miles per hour had to be called off because it was endangering other motorists.

Middleton crashed the truck later in the day. Police found Rucker's wallet in the truck along with his Social Security card and two credit cards, but \$700 cash was missing.

The crash of the truck totaled out Rucker's \$44,000 vehicle.

Police said Bowers admitted her role and King's role in the scheme.

"essentially a dumb hick."

The question is whether it's in the town's interest to do the lease, Warm said. City Clerk Kelli Brettel had prepared a letter of response before the meeting saying the town was excited about Verizon's offer and the opportunity it presents. The letter said the town accepts Verizon's terms in the contract.

"We sincerely hope that you consider the Town of Bronson's James H. Cobb Park as your first option and again we thank you for the opportunity," Brettel wrote.

The council agreed to send the letter to Verizon.

Brettel said in hindsight it was probably a mistake to send Verizon a copy of Warm's letter, which had been written for town council review, and not for Verizon's review, but she said hindsight is always golden.

"Daddy always had a philosophy: train a wife to be a widow, so she took the broker's test," Carolyn Rogers said. D.L. Rogers passed away in 1972.

Doris Rogers was born in Galena, Kansas, but was raised in West Texas. The story about her birth is that her parents were traveling by train when the baby decided to make its entrance in Galena. But the family was still from West Texas. She later moved to Miami, Oklahoma with her family when her father, an employee of Empire District Electric, transferred to the new location.

D.L. Rogers suffered from arthritis, and the ailment resulted in doctor's orders to move from Oklahoma to a warmer climate. He was a telegrapher for the railroad in Oklahoma and shipped hunting dogs around the country. Hart said he shipped hounds to Frank Marshburn and Cy Allen in Chiefland and often corresponded by way of telegraph to stationmaster Lyle Lathrop. It was his communications with Lathrop about Chiefland that led Rogers to move his wife and family here in 1952. Hart joked that the early telegraph messages were the forerunner of today's texting.

When D.L. and Doris Rogers arrived in 1952, the main street in Chiefland, U.S. 19, still had large oak trees growing in the middle of the street. The oak trees were later cut down when the highway was widened to a four-lane.

Hart said Rogers worked to promote a positive image in Chiefland, both as a realtor and as a city official. Carolyn Rogers said her mother always had a vision of developing Chiefland around her home. Her home lies north of the old Winn Dixie shopping center and south of the Wal-Mart Supercenter. She sold the land for a McDonalds to move in a half block from her. An auto parts discount store is next door to her home, which was built in 1962. When her home was constructed, the only business within eyesight was the old Truck Town restaurant and gas station, which has since been replaced by new businesses.

"She was very dedicated to the community," Hart said. "She had a real deep concern for the image of the city, including the real estate and residential areas. She was real concerned about the city's image."

Rogers worked as a real estate broker until she was in her 80s when a broken hip forced her to retire. Carolyn Rogers said she talked her mother into retiring one other time, but when she went out of town for a while, she returned to find her mother was back in real estate.


Rogers became a successful businesswoman long before women were prominent in the business community. She was one of the early female elected officials in Chiefland. But she kept her successes in perspective.

"She never came across as a person who was in charge," Hart said. "She would give direction on which way she wanted to go. Class and honesty; if you wanted to sum her up in two words, that would be it," Hart said.

Rogers was 94 years old the day she passed away at her birthday party. She would have turned 95 the following day.

Oh, SNAP: What They Forget to Say About Food Stamp Cuts

At the end of October, supplemental aid to the federal food stamp program - officially called the Supplemental Nutrition Assistance Program, or SNAP — ran out.

USA Today reported "[v] ulnerable populations will be hardest hit." CNN posted a column by Feeding America's

Bob Aiken that warned of the new "strain on millions of families struggling with food insecurity." Currently, there are 47 million Americans receiving SNAP entitlements. There were just over 28 million enrolled in 2008.

What's largely missing from the coverage is why cuts happened in the first place.

Heartless conservative politicians are not responsible for sending kids to bed hungry. The expiration of this expanded spending was embedded in the infamous stimulus bill that was rammed through Congress by Harry Reid and Nancy Pelosi in 2009 at the behest of President Obama. Stimulus spending provided for only a temporary increase. After all, people were only supposed to need more SNAP money until the economy recovered. Surely, they figured, the economy would rebound in four-and-a-half years.

But that was before things such as ObamaCare and the Obama Administration's war on fossil fuels.

Back in 2009, in the \$847 billion stimulus bill — called the American Recovery and Reinvestment Act (ARRA) - only \$45 billion of that spending went to feed hungry

economic growth.

Therein lies the problem. It is difficult to make the claim that stimulus spending actually worked as intended — creating jobs and growing the economy — while also lamenting that people who should now be self-sufficient still need to be fed through government entitlements. At some point, it can't be denied the original program failed. Obama himself joked back in 2011 that 'Shovel-ready was not as... uh... shovel-ready as we expected.'

The problem is that the stimulus, increased regulations and now ObamaCare are failing. Instead of creating jobs, increasingly reliant on entitlements such as SNAP.

Rather than admitting defeat, liberals' next step is to push for more regulation and more spending to subsidize and prop up their failures without ever having a conversation about why the original grand ideas did not work. All the while, more people are signing up for entitlements - straining the government's safety net more and more.

Predictably, those who criticize conservatives as heartless for not supporting Obama's parade of jobs proposals following the ARRA do not have the wherewithal to admit the stimulus actually failed. Then again, they are the same who say the rich aren't taxed enough and seem to believe there is an infinite amount of money among the rich and the business community to solve society's problems.

That is how people assume government can replace families as a social institution. That is how programs that discourage self-accountability and promote government dependency (and control) continue unabated.

Of course, conservatives already know that just taking money from the rich and future generations (in the form of the policies of the Obama Administration are making people America's current \$17 trillion of debt) and redistributing it as politicians see fit is not a cure-all.

Letter to the Editor **Be Careful and Check Credentials**

Last Tuesday at the Levy County commission meeting, Commissioner Mike Joyner addressed a situation that I have dealt with many times during my years in law enforcement in Florida as both a private investigator and a Special County Investigator. He spoke about the presence of professional predators who target the sick and the elderly in the Levy County area. These individuals come in the guise of home healthcare professionals, companions, contractors and many others in between.

I arrived in Levy County three years ago when I was called by a US military veteran, then about seventy years old who happened to have been a personal friend of mine for over forty years. Upon my arrival I found that my friend had suffered a fall resulting in his confinement to a wheelchair. There was a group of individuals with whom he'd become acquainted. These individuals were supposedly taking care of him by taking him to appointments, cleaning his house, etc. One of those people had moved into his home and would disappear with his minivan for days at a time and without his car (which contained

his chairlift), he was stranded, a prisoner in his own home. When I spoke to her on his behalf, she informed me that she was a certified paramedic/firefighter and retired Captain from Alachua County Fire Rescue and that she was a certified caregiver. I checked with Alachua County Fire Rescue to find that they had no record of a retired Captain by her name.

I also met a married couple who were also "helping" my friend. They said they too were home healthcare providers and informed me that they were very suspicious of my sudden appearance at my friend's house. They told me that he had given them his minivan in exchange for services and threatened me personally. They told me to go back to Fort Lauderdale if I knew what was good for me. After some checking I found the husband was a convicted pedophile and the wife was one of the local drug dealers. Needless to say I did not return to Fort Lauderdale and with the assistance of the Levy County Sheriff's Office these people were told to leave; however, shortly after that my friend's residence was robbed while he was out of town (with me) and several very expensive items were missing.

There was no evidence of break-in and it appeared to the deputy that whoever had done this had a key to his house.

About a year later one of his neighbors suffered the death of her father and her sister within a short period of time and it was not long before t his very same couple approached her. This neighbor told me they'd asked how much money she'd inherited and wanted to know where her father's tools were kept. Thankfully she caught on to their questions and told them to leave.

The point is – when you or a loved one are approached by people who claim to be equipped to help, please check their credentials and contact your Sheriff's Office immediately to verify that these people are legitimate. There are some good people who are there to help; unfortunately, there are also some unscrupulous people who are predators and they are very clever at helping themselves.

"These proposals are to work out a partnership with LCDPS to ensure coverage for shift work in an effort not to miss calls and more evenly distribute the call load on current members," he wrote.

Proposal 1 would take advantage of LCDPS's 52 firefighters who would be added to Bronson Fire Rescue's roster, giving the town a bigger pool of firefighters that could be placed on shifts. Dimaggio said the firefighters could be paid out of the Bronson Fire Rescue's budget and still keep the county allotment of special assessment money.

Proposal 2 calls for a partnership with LCDPS and Bronson Fire Rescue. Specific people from LCDPS would be placed on the work schedule, keeping the number of town "employees" to a lower number for insurance and workers compensation purposes. The town could reimburse the county for all shifts covered by LCDPS.

Dimaggio noted that water pressure is not what it should be for fighting commercial structure fires. He said the new Dollar General Market had to provide its own water tank to ensure enough water pressure to fight fires. He said the town will have to increase the size of water mains that

supply commercial and industrial areas "If you want to bring business development into this town."

Proposal 3 is similar to Proposal 2 except payment of services to LCDPS would be a quarterly payment.

Proposal 4 would be to transfer the town's fire services to LCDPS, saving the town the expense of a fire department.

"Then (we would) try to negotiate a reduced fire assessment from the County for town residents for a certain number of years, say three, to offset the cost of the fire equipment transferred to the county,"Dimaggio wrote.

He noted LCDPS is currently staffing four stations in Morriston, Rosewood, Fowlers Bluff and Yankeetown. The Town of Inglis is coming on line in the near future. LCDPS has 52 firefighters and is cross training EMS personnel to be dual certified as firefighters and emergency medical personnel.

"LCDPS is currently finalizing a new contract with UF for a medical director that will improve our ability to provide assistance to residences in our district," Dimaggio wrote. "They also have purchased additional fire equipment for upgrading the current stations. I have seen many positive

changes with the new department and feel they are on the right track to be a positive asset to Levy County.

"The transfer of Bronson Fire Rescue to Levy County would allow the Town of Bronson to invest the funds currently given to the department into infrastructure improvements that are needed to assist with future growth of the town and business district. The current water distribution system is in need of expansion and upgrading. As we found out with the new Dollar General Market, our current water system will not support the needed water flow for fire suppression efforts. The Dollar General Market had to install a water tank to supply the required flow rates for their required fire suppression system."

Weeks was not excited about Dimaggio's proposal to give the town's fire equipment to LCDPS and turn the department over to the county in exchange for a reduced fire assessment over a period of three years.

"We just need to find out if he wants to be the chief," Weeks said.

GWC's How to Make Your **Own Holiday Photo Card**







much about it," she said.

Commissioner Danny Stevens asked Gordon what the difference was between the Sabal Trail pipeline and two other natural gas transmission lines already operating in Levy County.

Gordon said it's the company and the size of the pipeline that scare her. She produced photographic copies of natural gas line explosions in other states. She said the gas will be highly compressed and she is worried that it could be more explosive than propane tanks that have less compression.

Stevens said a natural gas pipeline "goes past the back of our property in east Williston." He said it was his understanding that Sabal Trail officials met with citizens at the Williston City Council chambers recently. He asked if Gordon attended.

She said she did attend, but the company did not answer her questions.

"If the county commission were to ask these things, it would carry more weight," she said.

Commissioner Mike Joyner suggested Gordon contact an attorney representing landowners. He said the attorney has asked some of the same questions that Gordon is asking.

"You're asking the board to get answers. I'm asking you to go to the horse's mouth," Joyner said.

Gordon responded that the attorney Joyner mentioned is representing landowners concerning eminent domain issues, which is not what she is concerned about.

Eminent domain allows governments or utilities to condemn land for public purposes. The gas company in this case can condemn land

to build the pipeline, but it must pay property owners for their land.

Commissioner John Meeks said he inquired about the depth of the pipeline. He said he was told that a farmer could request that the pipeline be buried four feet down instead of three feet to avoid the possibility of the pipeline being struck by a farm plow.

He said he was also told the pipeline company would mow the property every five years, but a farmer can get an exemption to the mowing if the land is being farmed.

Gordon said one of her principal concerns is whether first responders are trained to deal with a major gas line explosion and whether the gas company is insured for such explosions.

Joyner said he heard in a meeting of the regional planning council meeting that the company has a magnificent response team that will come to Levy County to train first responders.

"It's not that we're sitting back and not asking questions," Joyner said. "We're asking questions. It may not be the ones that interest you." Commissioners took no action.

Final Hurdles Crossed to Purchase Williston Tax Collector Office

Levy County Tax Collector Linda Fugate crossed two big hurdles Tuesday in her efforts to purchase a piece of property in Williston for a tax office.

The Levy County Commission voted to accept the building she is purchasing in Williston, and later in a separate meeting the Williston City Council ordered deed restrictions removed from the property.

With acceptance of the property by the county commission, the former medical office will become county property after the real estate closing occurs on Wednesday morning.

Removal of deed restrictions proved to be more complicated than first imagined.

The 2,000 square foot building behind Nature Coast Regional Hospital was once a medical office and a yoga studio, among other things.

When the hospital was owned and operated by the city,

deed restrictions were added to require the entire complex to be used for dental or medical offices.

Years ago the city sold the hospital to a private entity, but the deed restrictions on the property were never removed by the city.

That changed Tuesday night.

City council members voted unanimously to adopt a resolution that essentially orders City Attorney Fred Koberlein to do whatever is required to clear the title by eliminating the deed restrictions.

Koberlein said he would need to find out from Levy Abstract and Title Company exactly what the title company is requiring to have the restrictions removed, but he said the closing could go forward.

As soon as Koberlein knows what the title company wants accomplished, he said the deed restrictions can be removed within 48 to 72 hours and filed with the county clerk's office in Bronson.

The situation was complicated by the fact that the building

Fugate plans to use for a tax office is part of a medical office complex behind the hospital. When the deed restrictions are removed from her office property, the restrictions are removed for the remaining offices in the complex.

Koberlein said that wouldn't be a problem because the city granted the deed restrictions and has the power to remove them without consulting other businesses in the office complex.

Council members said they didn't have any problem with removing the restrictions from the entire office complex.

Fugate said she wasn't aware that removing the deed restrictions from the property she is purchasing would remove them from the other offices, but she was happy that the closing could take place as planned.

Council members were satisfied all the legal questions had been settled.

Councilman Cal Byrd announced that he has family members involved in the transaction, but he did not abstain from voting.

Community Tips Found Donation Jar Thief

December 10, 2013 the Williston Police Department notified the public via the media and Facebook of a theft that occurred in Williston. The theft outraged many due to the person involved stealing a jar with donations intended for "Give Kids a World Village" which grants wishes for terminally ill children.

Within minutes of the press release going public the Williston Police Department received numerous tips by phone and Facebook identifying the suspect in the case.

The suspect was located and questioned by the investigating officer. During the interview the suspect confessed to committing the crime to support a chemical dependency problem.

A sworn complaint has been completed and forwarded to the Office of the State Attorney for prosecution. Pursuant to Florida State Statute 901.02 should the State Attorney's Office decide to pursue prosecution they can only issue a summons (not an arrest warrant) requiring the person

appear in court to face the theft charge. Until the time that the summons is served this case is classified as a pending investigation and the name of the suspect cannot be released by law.

As Chief of the Williston Police I would like to thank all of the concerned citizens who stepped forward to assist in identifying the suspect in this case.



Hungry Children in Levy County Fed by Special Group with a Mission

Many people have difficulty believing childhood hunger exists in Levy County in an age of food stamps and free school lunches.

Isn't that problem exclusively in third world countries?

A program known as the Food4Kids Backpack Program of North Florida is making a dent in childhood hunger by sending home backpacks filled with food on weekends for children identified as being hungry while at school.

The program exists at Joyce Bullock Elementary School, Williston Elementary School and Bronson Elementary School and now Chiefland Elementary School, which has 9 families on a waiting list. CES currently feeds children in 5 families.

Jennifer Moore, who founded the program in Alachua County, Michelle Barron, a guidance counselor at Chiefland Elementary School and Beverly Hernandez, who heads the program at CES explained the backpack program to the Chiefland Rotary Club last week and asked for club support in sponsoring children.

Barron noticed before weekends and holidays Wasson. that some of the children she counseled at

Chiefland Elementary School were telling her that there was no food in their home. The children wanted to stay at the school over the weekend to have access to food.

The backpack program was already established in Alachua County when Barron heard about it. She contacted Moore, who has family members in Levy County. Barron established the program at CES.

Moore said she was raised in Gainesville for most of her life and had never been exposed to childhood hunger. She brought pizzas to one of her children's classrooms for a birthday party once day and noticed two children were gulping pizza as though they were starved. The two children consumed four pieces in less than 10 minutes and wanted more. This was a Monday. The teacher said they had not eaten since Friday.

Moore went home and searched the Internet. She found the backpack program and felt it would work.

"Within a week we were sending out backpacks and they were coming back empty," Moore said

Moore said the program currently serves 22 school sites. At Chiefland Elementary School, the food is stored in a portable classroom building that isn't being used. The food consists of non-perishable items.

Children are sent home with a backpack filled with seven meals for the weekend. Parents are being told the food is for the kids and they are not to eat the food.

Hungry children are not difficult to identify, according to Moore and Barron. They are often restless or complain of their stomach hurting, or their head hurting because of hunger. All children in Levy County public schools receive free lunches. The hungry children are often easy to identify because they wolf down their food as though they are starving.

Rotarian Jeff Beauchamp asked how childhood hunger could exist in an era when food stamps and the WIC program for breastfeeding mothers provide food for those families.

Moore said there is obviously some abuse of government food programs and those programs are not supposed to allow childhood hunger, but she said they can't stop abuse of the programs. But she said in many cases the parents are just "stretched thin" by lack of income and there is no abuse of the government food programs.

"My job is getting sadder and sadder each year," Barron added.

Barron said she doesn't mind telling the parents the food sent home in backpacks is for the kids.

"These are starving children," she said.

The Food4Kids Backpack Program is a registered non-profit organization that targets chronically hungry students who are referred to the program. Every Friday rolling backpacks filled with 7 meals for the weekend are distributed at each school site. The backpacks are returned the following money and refilled for the next weekend.

A child can be sponsored for \$6 or for \$250 for an entire year.

Or if you would like to shop for a child, the backpack program uses canned food (pasta, soup, veggies, meats, tuna); juice boxes and shelf-stable milk, breakfast foods (instant oatmeal, breakfast bars, cereal,); snacks (raisins, pretzels, crackers, granola); (mac & cheese, PG&J); fruit and pudding cups.



Chiefland in the Middle of Major Sewer System Upgrade

Many people in Chiefland probably believe the duplexes and triplexes in the area of 6th and 8th streets and 4th Avenue are connected to city sewer, but the rentals are on septic tanks.

Chiefland is in the process of enlarging a lift station on the Chiefland Elementary School property and adding sewer lines and 39 new connections to serve residences and rental properties on those streets.

A \$650,000 Community Development Block Grant is providing the money for sewer system improvements, which includes a small lift station at an existing retention pond on 6th St.

"It's going to be messy for a while," said Projects Coordinator Laurie Copeland.

Andrews Paving is handling the work.

The city waived connection fees for residents and used the waiver as the city's matching funds for the grant. The city is also paying for the abandonment of residential septic tanks. Contractor Tommy Jones will empty and compress the tanks then back fill the crushed tanks. The drain field will be abandoned at each site.

While the abandonment of septic tanks is at city expense, the homeowners will be forced to foot the bill if they refuse to allow the city to do the work. Hookup to city sewer is mandatory. The CDBG grant will pay to extend sewer lines from the force main to homes and rental property.

The CDBG is also paying for sewer line work in the

Hardeetown area on 12th Avenue and 13th Avenue. Robotic cameras were run through the pipes to make certain they are not cracked or leaking. Once the lines are found to be without damage, a contractor will seal the pipes with a polymer liner that will protect the pipes for 25-30 years, according to Copeland.

The grant will also connect 35 homes in Eleanor Village to sewer and mobile homes behind the Pizza Hut restaurant. The grant will pay for the paving of 12th Street and will also provide pavement for SW 2nd Court, a street damaged by a previous CDBG project.

Chiefland was able to obtain the grant because it is

considered an economically depressed community, with a high rate of poverty and high unemployment.

Copeland said the city has added four new lift stations and expanded the sewer system using CDBG grants in the past couple of years. She said contractors have found it easy to work with Sewer Superintendent Randy Wilkerson. She

described him as an ideal sewer superintendent. She said he hasn't had a pay raise in five years and never complains.

"The guy is great," she said.

She commended city commissioners for the way they use the CDBG grants, which are becoming increasingly difficult to obtain.

"I can say our commissioners are very wise in what they do with our grants when we get these grants," she said.

PUT IT DOWN RIGHT NOW!" Suddenly all forty seven people in the vicinity were staring at me. Gas sales came to a grinding halt. Beady little eyes everywhere peered around their pumps like a curious pack of rubber necked ground vultures. My hands went out, my shoulders hunched in desperation. The question "What?" rose to my lips like molasses. I spun a wide swath half expecting to see somebody behind me with a gun. Nope. Had I accidentally stole something? Meanwhile that harried voice kept pounding me, "PUT IT DOWN RIGHT NOW MISTER!" Finally some fellow looked up from packing his cooler and chimed in, "Dude, I think she's talking about your ourselves here in America? Though it promises more comfort cell phone." I glanced down. Sure enough, it was still clasp in than an old recliner, sadly I fear it may also be rocking the my trembling palm, where I'd been dialing home. After that my memory reel speeds back up to normal. I recall momma stomping across that lot to scold me over the potential dangers and incendiary tendencies inherent in the common cell phone when used within close proximity of a gasoline pump. After I'd put a few hundred miles worth of thought under my belt it hit me, "What if mom was just acting in love?" 



Williston Charity Tournament Raises Awareness of Seatbelt Safety

A charity basketball tournament held Saturday in Williston was aimed at encouraging young people to fasten their seatbelts and drive the speed limit.

The tournament attracted high school teams from as far away as Orlando and Gainesville. During the day, a Florida Highway Patrol crash simulator gave young people a bird's eye view when a car overturns and the occupants are not wearing seatbelts. The occupants (dummies) were ejected through windows of the car.

The Team Mighty Ike Basketball Tournament was organized by the family of Issac Jewade Floyd, a talented Williston basketball and football player killed on Dec. 17, 2011 when the car he was driving at high speed rolled and he was ejected from his car.

All three of his passengers were also ejected. One died. The other two were critically injured. Neither Floyd nor his passengers were wearing seatbelts. A human body can be thrown through a small window opening by the force of a rollover.

Floyd was driving at 91 miles per hour when he crossed the railroad tracks at County Road 316 and rolled his car. His sister, attorney Lenora Floyd, said she wants young people to realize their dreams by staying alive.

"Our goal is to help youth by encouraging families to wear their seatbelt," she said. The theme of the one-day tournament was "Stay Strapped, Heed the Speed." "He was just a wonderful, all-around good person," Floyd said. "By the support we're getting from the community, we know he did everything from the heart."

Floyd said 1,000 people attended her brother's funeral.

Money raised from the annual basketball tournament will fund college scholarships. The hope is that eventually the tournament will grow and fund full scholarships to universities and colleges.

Danny Floyd, father of Issac and Lenora, was on hand for the tournament. Floyd is probably best known for his hundreds of hours of volunteer work in summer and afterschool basketball programs for the youth of Williston.

Issac Floyd had a warm personality and was well liked, according to his sister.



important. She believes he would have had a much better chance of survival if he had been wearing his seatbelt.

With that fact in mind, she plans to make the charitable basketball tournament an annual affair. She said Levy County has had 19 fatalities thus far in 2013. The FHP said the majority of the deaths involved drivers and passengers not wearing seatbelts.

She said it points out an obvious fact. While the public often focuses on the dangers of drinking and driving, which Floyd agrees is important, a lesser known fact is that people are dying in large numbers every year by not wearing seatbelts.

"The more I researched it, the more I realized the importance of wearing seatbelts," she said.

Easy Creamy Basil Tomato Soup Eggnog Pumpkin Pie

1 can condensed tomato soup 1 can milk (or half milk/half cream if you have it)

7.5oz (1/2 can) of diced tomatoes

1/3 teaspoon dried basil flakes Shredded cheddar cheese for garnish

Mix the milk with condensed soup. Place the diced tomatoes in chopper and chop to your desired consistency. If you do not have a chopper, place diced tomatoes on cutting board and chop. Add tomatoes to soup mix along with the dried basil. Be sure to "scrub" the basil in the palm of your hand to ignite the basil flavors. Cook over medium-low heat. Serve with toast or crackers and garnish with shredded cheddar cheese.

Makes 2 bowls.

1 can (15oz) solid-pack pumpkin 1 cup eggnog 3 eggs 1 1/2 teaspoon pumpkin spice 1/4 teaspoon nutmeg 2/3 cup sugar 1/4 teaspoon salt cinnamon

Prepare you favorite homemade or storebought pie crust. Set aside. In a large bowl combine all the ingredients except the cinnamon and mix well. Pour mixture into pie shell. Sprinkle the cinnamon over the top of the pie.

Bake in a 357*degree oven for 65 minutes or until toothpick inserted in middle comes out clean. Cool on rack. Once cool, refrigerate pie until ready to serve or for at least 2 hours.
