Tackling traffic

Residents get early look at county's Neptune Road project

By Rachel Christian Staff Writer

Widening Neptune Road – a vital connector between Kissimmee and St. Cloud – is number one on Osceola County's list of construction priorities.

Before work can begin though, a lengthy \$1.5 million Project Development and Environment (PD&E) study must first occur. The study was launched last fall and planning staff isn't expected to wrap up until January or February 2020.

But on April 11, residents had a chance to ask questions, give comments and see what planners and consultants have accomplished so far during a community meeting held at the Osceola County Administrative Building.

The affected roadway stretches just under four miles along Neptune Road from U.S. Highway 192 to Partin Settlement Road. The area narrows to two lanes at various points, which can cause congestion, gridlock and accidents that the new project aims to remedy. According to Florida Department of Transportation crash

statistics, accidents along the affected area have steadily increased over the years, from 42 cases in 2014 to 108 in 2017

in 2017.

The overall number of vehicles traveling along Neptune also increased about 18 percent from 2010 to 2017.

2010 to 2017.

Poster board displays of alternative designs and evaluations were posted at the April 11 community meeting for residents to view, as well as a looping video presentation explaining key takeaways.

The whole Neptune Road project is divided into several parts. Here are some highlights.

From Partin Settlement Road to Ames Haven Road.

Both alternatives being considered for this section include a four-lane divided roadway with 11-foot wide lanes. There would also be a 4-foot bicycle lane and a 12-foot recreational path provided on both sides of this 1.8-mile stretch.

In Alternative One, widening occurs mostly to the north of

Red and white signs with the phase "Fix the Traffic!" are popping up all over Osceola County.

The signs – and soon the mailers, TV commercials and other advertising – are part of a campaign that's not only anti-traffic – it's in favor of a 1 percent sales tax increase meant to raise money for Osceola County's transportation issues.

"Fix the Traffic!" is a Political Action Committee, or PAC, formed by Osceola County businessmen Hector Lizasuain - a former county employee who now works for Magic Development - and former county commissioner and property appraiser, Atlee Mercer.

Lizasuain and Mercer are counting on support from Osceola's business community to help pass the referendum that would raise the county's sales tax level to 8.5 percent, putting it on par with Hillsborough County for the highest in the state.

The purpose of the PAC

Fix the Traffic! is putting a message out that if the sales tax fails, the county's only other option to raise transportation improvement funds would be a hike in ad valorem rates – better known as property taxes. That would disproportionately impact businesses, Mercer said, and it wouldn't capture revenue from visiting tourists.

"That's not a threat. It's a fact," Mercer said. "Osceola County has over a billion dollars in backlogged road widening projects. That's a lot of money that has to come from somewhere."

Mercer, a self-described staunch Republican, sat on the County Commission for years and watched minimal road improvements take place.

He believes the commission he sat on did what it could with the resources it had. But he noted that the county needs more money now or gridlock traffic and congestion will only get worse.

"We can't have developers pay for the sins of the past and we can keep ignoring the problem," he said. "It will cripple our economy."

The sales tax would generate an estimated \$68

New bill aims to add Kissimmee River to national protected list

A federal bill is making its way through U.S. Congress that, if approved, could help fund an environmental study at the Kissimmee River by designating it under the

National Wild and Scenic Rivers program.

HB 37 aims to authorize a study of Kissimmee River so it can be included in the rivers program, a designation that grants the waterway and its tributaries stringent ecological protections.

The Kissimmee River is a naturally winding river that enters Osceola County at East Lake Tohopekaliga and forms the headwaters of Lake Okeechobee and the Everglades. Below Lake Kissimmee, the river creates the boundary between Osceola and Polk counties.

In the 1950s, the river was dredged to reduce flooding in Central and South Florida, but a few decades later it became clear that altering the river's natural course was having major

Kissimmee restaurant owners arrested for selling beer to undercover cop

Two downtown Kissimmee restaurant owners were arrested on April 11 for operating a bar without a state alcohol license.

David Morales, 53, and his brother, John Morales, 55, were arrested at Hatfield's Bar and Grill at 30 Broadway in Kissimmee after a bottle of Bud Light beer was served to an undercover state agent from the Division of Alcoholic Beverages and Tobacco. According to the arrest affidavit, Hatfield's was not licensed to sell any alcoholic beverages because its license is revoked.

Hatfield's was cited for a non-specific enforcement

stipulation by the arresting agency May 29 last year. On Dec. 6, enforcement issued a civil penalty before revoking the alcohol license at Hatfield's, according to state records.

Hatfield's alcohol license status is still listed as revoked.

Bond was set at \$250 for both John and David Morales. Both brothers had

bonded out of the Osceola County Jail by 3 p.m. Friday.

Hatfield's will remain open for food consumption only and operate normal business hours until the legal matter is resolved at the state level, according to a restaurant employee.

Hatfield's was issued its alcohol license from the state in 2015.

Neptune Road and a minimum of 130 feet of right-of-way is needed.

Alternative Two widens Neptune Road mostly to the south, requires the relocation of power poles and at least 139 feet of rightof-way.

From Ames Haven Road to Old Canoe Creek Road.

There would be widening on both sides of the street along a one-mile section of Neptune stretching from Ames Haven to the canal by the Florida's Turnpike.

Widening on the south side of Neptune Road would then occur for another half mile from the canal to Old Canoe Creek Road.

A minimum of 130 feet of right-of-way is required.

From Partin Settlement Road to Old Canoe Creek Road.

This section will have a major impact on surrounding neighborhoods, with right-of-way effecting between 58 and 75 residential parcels. Another six to eight non-residential parcels could be impacted.

Between 9 and 25

residential relocations could take place along this 3.4-mile section. It comes with a big price tag, too. Construction costs without right-of-way land acquisition is estimated between \$39 and \$40 million and up to \$4 million in utility relocation costs.

There isn't any adverse impact to wildlife expected here, but there are medium impacts to wetlands and flood plains.

From Old Canoe Creek Road to U.S. Highway 192.

Two alternatives are being considered for this half-mile section.

Alternative A includes a four-lane, undivided road with 10-foot lanes, a 10-foot recreational path on the north side of Neptune and a 6-foot sidewalk on the south side. It's not expected to require additional right-of-way.

Alternative B calls for a five-lane road with 10-foot lanes and an 11-foot center left-turn lane where a median is being considered in various spots. There would also be a 10-foot recreational path on the north side of Neptune along with a 6-foot wide sidewalk

on the south side. It would require some additional right-of-way on the north side.

There are no relocations required for either alternative.

Construction costs for this section could range from \$3.3 million to \$3.5 million and no utility relocation costs are expected.

There are no expected environmental or wildlife impacts to this area.

County and consulting staff will fine-tune project details and data before hosting a final public input meeting in January.

Finally, staff will make a presentation to county commissioners, who will choose whether to build the project or not.

Funding will dictate how quickly construction occurs. Design, right-of-way acquisition, and construction could take five to six years, said Josh DeVrives, director of planning for the county.



million a year in revenue to widen roads, expand intersections, improve traffic control, build sidewalks and trails and support public transportation, including SunRail and Lynx.

What the PAC money is going toward

Fix the Traffic! was formed in mid-March and last reported \$33,000 in contributions to the Osceola County Supervisor of Elections on March 31. According to Kari Ewalt, community relations manager at Osceola Supervisor of Elections Office, PACs only report contributions monthly, and then the 16th and 4th days prior to an election.

On April 15, Mercer said contributions are likely closer to \$100,000 for Fix the Traffic! His goal is to raise at least \$500,000 and use the money to fund a full political advertising campaign to include mailers, yard signs,

TV commercials, radio ads and more.

"There's a lot of misinformation out there about the sales tax. There's also a lot of people who just don't know it's going on," Mercer said. "It takes money to run a campaign."

Contributors and donations so far

Seventeen businesses and individuals contributed to the PAC between March 19-31 with amounts ranging from \$100 to \$5,000 each. Twelve of the donors were engineers or engineering firms and two were real estate businesses. Only four contributors had addresses listed within Osceola County.

Mercer said PACs often receive donations from groups with something to gain from election outcomes.

"People will always do what they perceive to be in their best interest," he said. "If this tax passes, the county is committed to building

over a billion dollars of transportation projects, so if I'm involved in engineering, I'll probably get some of that money. So maybe I should make sure that passes."

PACs in Florida and beyond

PACs are organizations that raise money privately to influence elections and they have become a popular fundraising mechanism in America because contribution limits are higher. An individual can only contribute \$1,000 a year to a candidate or campaign, but groups can donate up to \$5,000 to a PAC.

Before Hillsborough County voters approved a sales tax increase in November, a similar PAC formed there called "All For Transportation." It raised just under \$4 million in about five months, according to the county's Elections Office website.

The opposing PAC,

meanwhile, raised about \$137,000.


An opposing PAC in Osceola?

But not all residents are in favor of the upcoming Osceola County sales tax vote.

A faction of fierce opposition has discussed forming a PAC of its own. Zane Matter, a Republican conservative candidate running for State House District 42, said he was looking into filing papers with the SOE this week or next week to create a PAC. Other residents against the proposal also say they're looking into it.

"Residents can't afford this tax," Matter said. "It's basically a slap in the face of hardworking Osceola County residents."

Voters can cast ballots on the sales tax increase May 21. New voter registration for this special election ends April 11 and early voting runs from May 13 to 19.

environmental impacts to wetland waterflow and wildlife in surrounding regions.

Efforts to restore the Kissimmee River to its original state were approved by Congress in 1992 and modifications to the headwater lakes began in 1997.

After more than two decades, the Kissimmee River Restoration Project has improved over 63,000 acres of wetlands within the watershed and helped restore wildlife.

The National Wild and Scenic Rivers System was created by Congress in 1968 to provide protection to outstanding free-flowing rivers. Protection is granted via voluntary stewardship by landowners and river users, and through regulation and programs of federal, state or local governments, according to the U.S. Fish and Wildlife Service.

Soto introduced HB 37 in January to help get the Kissimmee River into that program, along with five other environmental measures that take aim at everything from sinkholes to fracking.

Soto put forth an identical bill for the river study last year. It passed the House but then stalled.

"We will continue to work tirelessly to advance this critical legislation," Soto said in a January statement.

St. Cloud resident and

environmentalist Valerie Anderson said she thinks the Kissimmee River bill is a good way to bring attention and protection to a natural Osceola County resource.

"A lot of work and money has gone into restoring the Kissimmee River and it deserves to be recognized as an ecologically and economically valuable river," she said.

Anderson was appointed to Soto's new Environmental Advisory Board in late February along with eight other community leaders and eco-advocates.

Anderson, who also serves as the director of communications and programming at the Florida Native Plant Society, said

additional protection would be perfect for a rapidly developing area of Osceola County.

"The south shore of Lake Tohopekaliga flows into the Kissimmee River and the entire lakeshore is slated for development," she said. "This title and recognition couldn't come at a better time."

"We've got to get right back to work, assembling next season's team. There will be an awful lot to do before we start again next season," he said. "I'm really looking forward to the challenge of doing a better job next year."

For a change, you can "Believe in Magic" again, Orlando fans

The Orlando Magic are winners in the NBA Playoffs. First, let that statement settle in. Marinate in it. Appreciate it.

Now, let's unpack how they got there and what that means heading into Game 2 of their series with the Toronto Raptors.

In mid-January the team sat at 19-24, one game out of the eighth seed and still trying to find consistency on the court. From that point, even with a couple of tough losses, the Magic finished the season 23-16, earning their first winning season since the lockout-shortened 2011-12 season. That was seven years ago if you're slow on the math.

One of the biggest changes from January to now has been the team's bench; its production had been lacking in many games early in the season and not many teams can make a playoff run without solid contributors off the bench — Terrance Ross being the obvious exception.

In stepped Michael Carter-Williams, Wesley Iwundu and Khem Birch, who changed the dynamic of the Magic second unit with their energy and playmaking ability on both ends of the court. Carter-Williams was trying to play his way onto the team with a 10-day contract, Iwundu was still trying to find consistency in the NBA game and Birch was saddled behind Mo Bamba before he went down with injury. All three players gave the Magic second unit renewed life and their play kept Orlando in key games down the

stretch, making huge, game-changing plays.

The starters have been playing at a high level as well. Nikola Vucevic has been having the best season of his career, and his All-Star nod reinforced that. NBA sophomore Jonathan Isaac has broken out as of late, having changed up his shooting mechanics to make his three-

point shot more consistent and is now a true threat from downtown. Aaron Gordon has grown his game to be a variable two-way player, guarding opponents' best offensive players on defense while also making smart plays on offense. Evan Fournier has come up big when needed, averaging 15 points per game through the last 39 games of the season and point guard D.J. Augustin has played some of his best basketball in recent memory and is peaking now, made clear by hitting the game-winning shot against the Raptors in the Magic's 104-101 playoff-opening victory Saturday in Toronto.

All of this player development has been in part to Head Coach Steve Clifford, who has done a job that four other coaches could not do: make the Magic contenders again. Not since Clifford was an assistant on Stan Van Gundy's bench has Orlando played meaningful basketball in April.

He truly deserves a tremendous amount of credit for his job coaching.

Now, the Magic have finally reached the promised land of the playoffs and they're facing one of the top teams in the Eastern Conference in the Toronto Raptors. Having already stolen Game 1 in dramatic fashion, the series is guaranteed to go at least five games, which allows

four more games for the Magic to show off in front of a national audience. Regardless of what happens with the series, these next few games are an opportunity

for Orlando to reintroduce themselves to the fans of the league. It's a chance to show off what a team of pure length can accomplish in the postseason. Not just that, but it's a chance for this town to fully embrace the Magic again, not simply as the lovable losing local NBA team, but the winning playoff basketball team that has a legitimate shot to make waves in the playoffs.

The offseason will produce some pretty daunting issues, like how to keep Vucevic and Ross, what the plan will be with Mo Bamba and whether the team should go after another point guard. But those questions can be left for another day. The Orlando Magic are in the NBA Playoffs and, for now, it feels pretty good to "Believe in Magic" again.

The District will continue to be a statutorily created single and special purpose local government limited to providing basic systems, facilities and services to the property within its boundaries subject to the County's Comprehensive Plan and planning and land development regulations and conditions. The information presented at this hearing will be used to afford the Petitioner, any affected units of local government and the general public, a fair and adequate opportunity to appear and present oral and written comments regarding the establishment by ordinance of the state law created District.

The proposed land area to be serve by the District is wholly within the County of Osceola ("County"). The District, as created by law, is hereby expanding the external boundaries by adding approximately 371.06 acres, more or less, to encompass a total area of 458.14 acres, more or less. The boundaries of the real property to be serviced by the District is outlined in the map depicted in this notice. There is no real property within the boundaries of the District which will be excluded from the jurisdiction of the District.

Materials relating to the above may be examined in the offices of the Osceola County Community Development, 1 Courthouse Square, Suite 1100, Kissimmee, Florida 34741, between 8:00 a.m. and 5:00 p.m., weekdays except holidays. 



Explore the true meaning of Easter

Bunnies and baskets, chocolates and candies. It's that time of year when parents scramble to ensure their children wake up to a trove of treats, and families decide on who is serving the lamb dinner this year.

These are some of the familiar Easter traditions, but much more is involved with the holiday than egg hunts and brightly adorned bonnets. For the religious, it can be important to delve into the true meanings behind Easter and let those discoveries help shape celebrations.

Easter, above all, is a religious commemoration of the resurrection of Jesus Christ. It is the culmination of the holy period known as Lent, and it the most significant date on the Christian liturgical calendar.

Jesus Christ was the Son of God, who fulfilled the prophesies that he would give his own life for his people so they could enjoy eternal life after their own mortal bodies perished. Easter, from Jesus' very own words, marked a new covenant for the faithful

According to scripture, Jesus was enjoying the Passover dinner when he sat down with his disciples. Understanding that this would be his last earthly meal and that someone close to him would betray him, he took bread and gave thanks to God for it. He broke the bread and said it was his body that should be given up so sins would be forgiven. He did a similar gesture with wine, indicating that it was his blood that should be shed as a sacrifice for all. Christ instructed the disciples to do the same ritual in the future in memory of him.

Jesus was subsequently betrayed and turned over to the authorities. He was sentenced to crucifixion and perished on the cross. His body was cleansed and placed in a tomb sealed by a stone. His followers were unaware of the miracle that would ensue in the days to come. On Easter Sunday, the tomb was discovered open and empty. Jesus had risen from the dead, providing irrefutable proof that he was the Son of God. In turn, Jesus fulfilled



all he was born to do and preached.

Easter did not always symbolize Christ's resurrection when it was first celebrated. It was once a pagan ritual of renewal and birth. However, when early missionaries began spreading Christianity's message, the holiday

— falling around the time of Christ's actual resurrection — was adopted to commemorate the religious miracle. Today it stands as a testament to ultimate sacrifice and the promise of eternal life for all who believe in him.

Here are some sweet treats that make Easter special

From chocolates to marshmallows to caramel eggs to jelly beans, Easter is chockful of candy. And for those who think Easter is only child's play, guess again.

Americans spend up to \$2 billion on Easter candy each year, according to Sweet Services, an online candy retailer. The National Confectioner's Association says people in the United States consume nearly seven billion pounds of candy during the year, and Easter is the second-most popular holiday (behind Halloween) for indulging a sweet tooth.

Faith comes first for many Easter celebrants. But there's nothing wrong with enjoying some candy come Easter Sunday. Here's a look at the history behind some of the sweets the Easter Bunny might leave in your basket this year.

Chocolate eggs: The first chocolate eggs were made in Europe in the early 19th century. Since then, they have become one of the most popular and recognizable treats associated with Easter. The chocolate egg is predated by edible Easter eggs made from sugar and pastry first designed in Germany. According to the "Guinness Book of World Records," the largest chocolate Easter egg ever made debuted in 2011. It was just over 34 feet high and weighed nearly 16,000 pounds.

Chocolate bunny: The Easter Bunny also is a German incarnation. The seasonal bunny was introduced to America in the 18th century by German immigrants who believed in the "Osterhase," an egg-laying hare they believed was a sign of new life and prosperity. Germans also introduced the first edible chocolate bunnies. The NCA says 76 percent of people eat the ears on chocolate bunnies first.

Jelly beans: People aren't quite sure where the jelly bean originated, but some think it was based on a soft, chewy Middle



Eastern sweet called Turkish delight and the hard candy shell of Jordan almonds. William Shraft, a Boston-based confectioner, may have coined the phrase "jelly bean" when he urged people to send these sweets to Union soldiers fighting in the Civil War.

Peeps: Peeps are owned and made by Just Born Inc., a Pennsylvania-based company

started by Russian immigrants when they acquired the Rodda Candy Company in 1953. Just Born figured out a way to automate and streamline the process of making Peeps, and today they can produce 5.5 million per day.

Easter is a day filled with fun and lots of sweetness. Candy is a big part of the celebration.

Create colorful Easter eggs



Beautifully colored Easter eggs are a beloved holiday tradition. In many cultures, eggs represent new life, fertility and rebirth. For Christians, the Easter egg is symbolic of the resurrection, or the eternal life, of Jesus Christ. The practice of coloring eggs and offering them as decorative items is embraced during both secular and religious Easter celebrations.

Embracing some new tips and tricks can produce beautiful eggs and make this beloved tradition even more fun.

▶ Begin with firm, hard-boiled eggs. Bring a pot of water to a rolling boil. Then use a large spoon to gently lower the eggs into the water. Lower the heat to maintain a simmer and boil for just about 12 minutes. Transfer the eggs to a bowl with ice cold water and let them cool. Allow the eggs to cool completely before coloring.

Lay out newspaper or an old tablecloth to soak up any spills. Spills are inevitable, so don't let them spoil the fun. In addition, empty egg cartons make ideal drying racks, so do not discard them.

Make patterns or other designs on the eggs. Use a white crayon to draw on the egg directly. The dye will not stick to the wax. Or use string, rubber bands, tape, stickers, or other items to create your pattern. Dip the egg and then remove the materials afterward to reveal the design.

Swirl a few drops of food coloring into shaving cream on a flat surface. Roll the eggs into the mixture, let dry, and then gently clean to remove the excess shaving cream. The result is a marbled effect.

Recognize that you don't have to "dye" eggs at all. Use a sponge to dab on a design. Strips of tissue paper can be adhered to the egg with glue or shellac. Children may enjoy submerging the egg in glue and then coating it in glitter.

The connection between beer & lent

In the weeks leading up to Easter, practicing Christians commonly commit to a period of fasting and abstinence known as Lent

This commitment commemorates Christ's 40-day journey into the desert, and the sacrifices modern day Christians make are meant to replicate those made by Christ during that period.

Many Christians abstain from alcohol during Lent, but those who do may not realize that beer played a significant role in helping a small community of 17th century monks survive the Lenten fasting season. Monks from the Order of St. Francis of Paola, often referred to as "Paulaner monks," fasted from all solid foods throughout the season of Lent during the 1600s. According to the Paulaner Brewery, the monks, originally from southern Italy, relocated to Bavaria, once an independent country but now a southern state in Germany, in the 1600s. Their strict religious orders forbade the monks from consuming solid food during Lent, but they still needed nutrients to sustain them. So the monks concocted a strong brew loaded with carbohydrates and nutrients.

The monks must have liked the beer, as they continued to brew it and even began selling it in their community.






