Paving project underway on Okaloosa Lane

CRESTVIEW — Wayne Harris, who spent most of his two terms as a county commissioner battling to get Okaloosa Lane in Crestview paved, spoke succinctly when told work that needed

to be accomplished is at long last getting underway. “About damn time,” he said. Harris recalled epic battles trying to convince residents living along the roadway to release some land so the county could pave Okaloosa Lane and put in sidewalks. “Finally our engineer (now

Public Works Director), Jason Autrey, readjusted the road,” he said. At present, the county is constructing a bridge over a stream that flows across Okaloosa Lane, according to county engineer Scott Bitterman. When that work is completed, likely by the end of the year, the paving

will commence. “We’re in the process of taking bids to pave the right of way,” Bitterman said. “We will start to pave early 2018, as soon as the bridge is done, basically.” Bitterman acknowledged that one property owner on

RV ordinance doesn't pass second reading

CRESTVIEW — Following the second reading of the ordinance amendment concerning recreational vehicles, the City Council held a public hearing. According to Growth Management Director Teresa Gaillard, this new ordinance would affect 7,800 parcels of single-family homes and approximately 70 percent of the city. The ordinance would require that residents who own RVs park them on the side or back of their home and cover them with some type of screening. The screening can be a 6-foot privacy fence, a faux fence, plants and shrubbery, or other forms of approved screening apparatus, according to Gaillard. According to Councilman Doug Faircloth, the main reason for the ordinance

CRESTVIEW — A Walker Elementary student had the privilege of being the first resident to tour the new Publix store Nov. 8 at 1355 Ferdon Blvd. N., Crestview. Crestview comes together, honors veterans

CRESTVIEW — Crowds lined Main Street Saturday morning for the annual Veterans Day Parade.

An enormous American flag hung over the parade route hoisted by a Crestview fire truck. Veterans of American wars wore hats and clothing representing the conflicts in which they served. Men, women and children waved American flags along the sidelines in honor of those who served our country.

'WE ... CAME BACK AS BROTHERS'

Those participating in the annual parade included the almost 300 members of the Crestview High School "Big Red Machine" Marching Band, the Shoal River Middle School Band, and the Baker School Band. There were Boy Scouts, Girl Scouts and Cub Scouts along with Crestview and Baker School ROTC units.

The Panhandle Saddle Club rode horses and dressed patriotically. Members of the Crestview City Council drove veterans in cars and golf carts in the parade. ERA American Real Estate handed American flags to crowds lined along the parade route. The Carver-Hill Memorial Historical Society also rode in the parade.

Air Force veteran Al Blaker stood along the parade route proudly waving the American flag, as did Vietnam veteran Terry Faulkner. Faulkner served in Vietnam from 1967-1969. His father was a Marine in World War I and his brothers served in the military.

"We went over there as soldiers and came back as brothers," Faulkner said.

Vietnam veteran Thornell Henderson and his wife Pearl also stood along the parade route waving the American flag. He served in the Army from 1966-1969 and was in Vietnam in 1967.

"Veterans are forgotten lots of times. Remembering veterans with this parade is nice," said Henderson. He and his wife are the parents of three sons who serve in the Air Force: Damian, D'Andre, and Dante.

Vietnam veteran Bobby Sullivan volunteered along the parade route as he does every year. He served in Vietnam from 1966-1967 and was in the Air Force for 29 years.

Retired Navy veteran David Legerton was there with his wife Donna supporting the military.

'THESE VETERANS PUT THEIR LIVES ON THE LINE'

After the parade, a ceremony took place at the Okaloosa County Veterans Memorial honoring those who served and serve in the U.S. military.

Raymond Horton, an Army veteran with the 4th Infantry Division, Field Artillery, who served in Vietnam, was there with his wife Rena. The Hortons have been married for 66 years. Those who served in Korea, Vietnam, Iraq and Afghanistan were also recognized.

Airman Amani Perry opened the ceremony singing the National Anthem. The guest speaker was Cmdr. Anthony Mitchell, who spoke about why men and women join the military.

"We put on a uniform to be part of something great! It is also a reflection of those who raised us. When these men and women are sitting in the middle of the most God-forsaken places, they

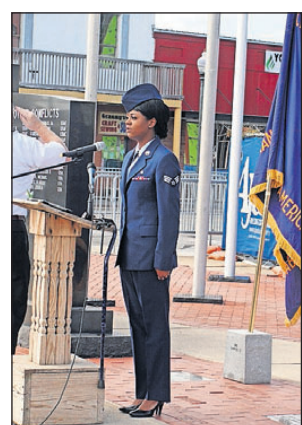

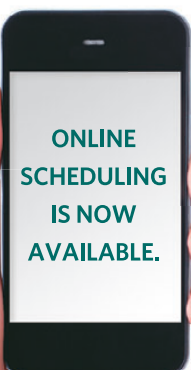

Baker routs Jay, advances to Elite Eight

BAKER — Kalee Ciurleo stood on the sideline, not a scratch on him.

No dirt or grass marks dotted his black jersey. Not a bead of sweat dripped from his brow, where a perfectly clean pink Nike headband rested as he watched yet another Jay set of downs go backwards.

Four drives in, the 6-foot senior gunslinger had connected with Ethan Garrett on a 46-yard pass and then again on a 10-yard touchdown pass to Derek Peoples. Paired with a 3-yard Junior McLaughlin score and 1-yard Jayson Moore touchdown, Baker led 28-0 with 14 minutes into Friday's Region 1-1A semifinal tilt at Doug Griffith Memorial Stadium.

"The defense is eating, son," Ciurleo yelled to no one in particular.

The defense was eating. The offense was eating. The coaches were eating.

Everybody was at the Friday night table in a 42-6 running clock victory over the Royals.

Now Baker is ready for seconds, thirds and — yep, they've saved room — a fourth trip to the playoff buffet.

OK, enough with the metaphors. No need to dance around Baker's talents or state title hopes.

The top-seeded Gators (11-0) have now won 24 straight, a mark that factors in Pahokee vacating last year's title after playing an ineligible player. And this season no foe has played the Gators to within a possession as eight of the wins have come by running clock en route to a 488-176 margin of victory.

"We've been clicking on offense and the defense is finally jelling together," said Ciurleo, who completed 9 of 11 passes for 196 yards and two touchdowns Friday night to give him 20 touchdowns and just one interception for the season. "We're just firing on all cylinders."

The closest any team has come to a win is Chipley, which lost 41-27 at home.

The Tigers or Holmes County (Bonifay) will get a chance to avenge their loss to Baker next Friday at Doug Griffith Memorial Stadium, where a Final Four berth will be on the line.

The Gators beat Holmes County 35-6 on the road in the season opener, while they defeated Chipley by 14.

"We played both Chipley and Bonifay and they're both good clubs, but I think we can improve on what we did the first time," Baker coach Matt Brunson said. "It'll be interesting whoever it is."

Fun for Baker, that is. Probably not so much for the visitors.

Bulldogs win playoff thriller against Gulf Breeze

CRESTVIEW — Jaden Voisin thought he had the ball.

He dove for it. He cradled it. He rolled over on top of it. He thought it was the game-sealing interception.

The referee believed otherwise, his arms signaling an incompletion. The Crestview sideline was incensed. Voisin threw up his hands in frustration.

"I thought I had it," Voisin said. "The ball didn't touch the ground. I was just like, 'I gotta get another one.'"

He did. Two plays later, Gulf Breeze quarterback Dylan Kelley tried to force the ball over the middle. Voisin was there.

"I see the quarterback readin' No. 7," Voisin said. As soon as I saw it, I just broke on the ball, dove for it."

This time there was no doubt. Voisin came up with the ball. The Jack Foster Stadium crowd went wild.

After a 38-35 playoff victory Friday night, Crestview was moving on.

It was tough. Each team traded big play after big play, but this was the benchmark coach Tim Hatten and his team needed. The Bulldogs previous smallest margin of victory had been 17 points in 35-18 win against Niceville in the regular season finale.

"We made some mistakes in the red zone," Hatten said. "We gave up some big plays, but they earned those big plays. They had some great schemes and some great players, and it was tough. It was a battle."

The game, which had been well contained going into the halftime break, exploded in the second half.

Gulf Breeze running back Tyler Dittmer scored the last of his four touchdowns with 6:43 to play on a 38-yard swing pass to the left that was left uncovered to cut the

Bulldogs' lead to 31-28. Crestview answered 10 seconds later on Rod Bouchard's 59-yard touchdown pass to Voisin.

Bouchard finished the night 10-of-19 for 155 yards and three touchdowns passes, adding 70 yards and a fourth touchdown on the ground.

If not for three timely second-half interceptions, Gulf Breeze likely had the firepower to overcome Crestview's defense. Dittmer, who led a Gulf Breeze rushing attack that put up more than 350 yards when the Dolphins played Crestview in the 2016 regular season finale, was similarly dominant Friday. He carried the ball 23 times for 171 yards and three rushing touchdowns.

"That's a good football team," Hatten said. "We didn't beat a team that won only three ball games. They're a good coached football team with arguably the best back in the panhandle." Seven Crestview penalties and an untimely Bouchard interception nearly derailed the Bulldogs' victory before it started.

After allowing Dittmer to run almost untouched for a 57-yard touchdown on the game's opening drive, Crestview responded with a drive of its own.

Taking advantage of short field position, the Bulldogs marched down to the Dolphins' 25 where Bouchard tired to connect with Voisin running

an out rout to the left side. Voisin leapt but the ball was juggled and Gulf Breeze linebacker Carl Taylor kept both feet in bounds to take possession at the 9.

Gulf Breeze managed to hold Crestview scoreless in the first quarter.

The second quarter was a different story.

Jay Stanton and Bouchard opened the quarter, using their legs to carry Crestview 80 yards down the field on seven plays. Stanton capped the drive with a 35-yard scamper up the middle to even the score at 7, his line bisecting the Gulf Breeze defense right through the middle.

Stanton, the Bulldogs' bell cow, finished the game 173 yards on 22 carries with the touchdown.

"It was a tough game," Voisin said. "They were a really good team, but we played hard, fought hard, practiced hard and got it."

With the win, Crestview advances to the region semifinal. The Bulldogs will host the winner of Escambia and Pine Forest at 7:30 p.m. Friday.

Last season's Bulldogs couldn't make it past the second round, falling to St. Augustine. Although Voisin enjoyed Friday night, he said the team wants to change that.

"It feels great, but we're trying to get past last year," Voisin said. "Made it to the second round. Got beat. Trying to get further than that."

Friday night could've been 100-0. That's how good the Gators were.

In the first half alone, Baker's offense had 392 yards and scored on all six drives. McLaughlin had

all of his 95 yards and two scores, including a 7-yarder where he absorbed helmet-to-helmet contact from a Jay linebacker at the goal line and remained on his feet as he powered through the tackle for his 21st touchdown of the season. Moore added 76 yards and two scores from 1 and 3 yards out.

The defense, meanwhile, allowed 27 yards of offense and had three fumble recoveries to give them 18 forced turnovers on the season.

"The first half, the guys were playing with their hair on fire and the offense

was fun to watch," Brunson said. "We threw and caught it well, we ran it when we needed to and we played great defense."

One of the fumble recoveries came from Baker's tackles leader, Zach Brown.

"We haven't really played our best all season, but tonight we showed up with emotion, something we had been lacking," Brown said. "Before the game we talked about how we wanted to play with emotion, play on fire, fire on all cylinders and just go."

"We're playing as good as we've played all year, but we can play even better."



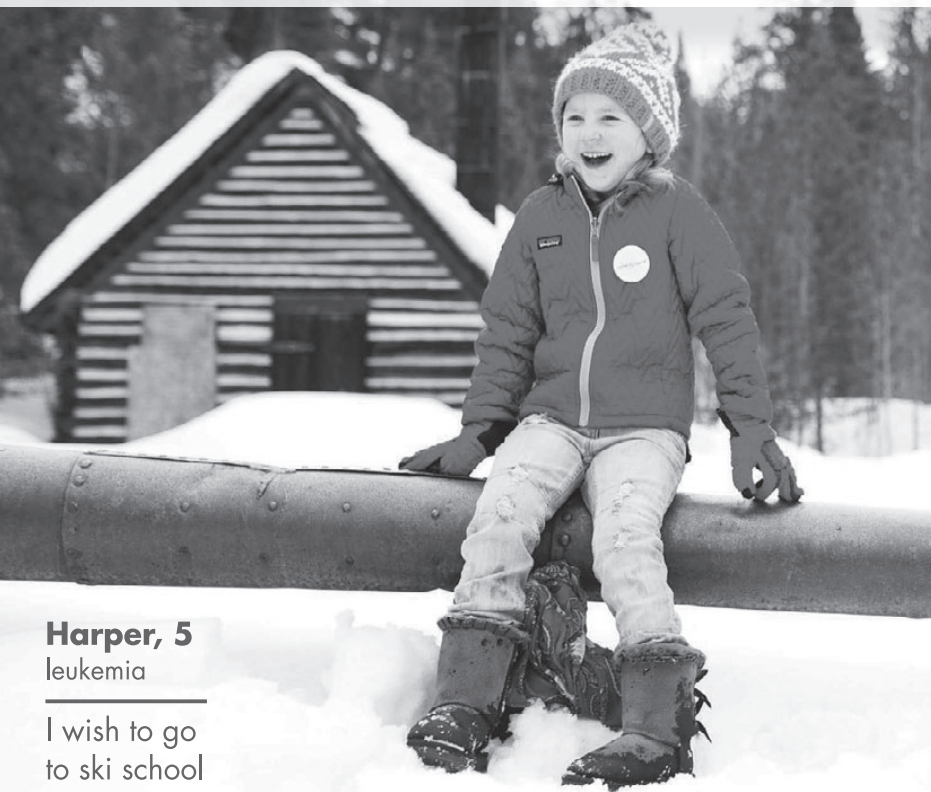
Derek Peoples Jr. pushes away a Jay defender while he scores a touchdown as Baker hosted Jay in a football playoff game.

What happened to Thanksgiving?

It seems as though Halloween ended and Christmas began. When and why did we abandon Thanksgiving?

The first Thanksgiving was celebrated because the Pilgrims were thankful for surviving the previous year; thankful to the Lord and to the local Indians for their help.

The Pilgrims landed with 116 passengers at Cape Cod about Nov. 9, 1620. Following the winter of 1620-1621, only half of the passengers and crew survived.

In the spring of 1621, an Indian named Squanto came and kindly taught these settlers how to live off the land, catch fish and plant corn and other local crops.

In the fall, when the crops had been harvested, Gov. William Bradford declared a

Harvest Feast for both the settlers and the native Indians.

The settlers hunted fowl and the Indians brought deer to the feast while the women cooked up some delicious dishes.

While we know about the venison, fish and fowl, there was probably a type of corn bread, as well as local vegetables that the Indians had taught the settlers how to plant and harvest.

Different sorts of tree nuts may have been harvested and used in various recipes. Since there was no wheat or butter, pies wouldn't have been included, and the beverage of the day would have likely been water.

The feast lasted for three days, according to the Smithsonian Magazine's website. Think of how full we'd be if we ate Thanksgiving dinner for three days.

Thanksgiving was recognized in 1777 by a Proclamation of the Continental Congress. It states, "November 1, 1777: FORASMUCH as it is the indispensable duty of all Men to adore the superintending Providence of Almighty

God; to acknowledge with Gratitude their Obligation to him for Benefits received, and to implore such farther Blessings as they stand in Need of: And it having pleased him in his abundant Mercy, not only to continue to us the innumerable Bounties of his common Providence..."

In 1863, President Lincoln declared Thanksgiving an official national holiday.

Let's not overlook Thanksgiving since it is an important day to show gratitude and thankfulness for our bounty.

Let guests serve themselves

“Interactive” meals are a fun alternative to a sit-down dinner. Some ideas from Manhattan-based entertaining expert Francesco Bilotto:

- Some types of food — think Italian or Mexican — are crowd-pleasers, and buffets work well with large groups. Offer a pasta bar with pesto, marinara and Alfredo sauces.
- Another idea is a grilled cheese bar (you'll need to put someone in charge of the skillet). Stock up on hearty breads and fancy cheeses plus tomatoes and bacon.
- The idea works just as well with desserts. Buy doughnut holes, then add a handle with a cake pop stick and provide dips and sprinkles.

Make the most of fresh herbs

How to keep different herbs fresh, from Real Simple:

- **Basil, parsley, cilantro:** Trim the stems and place in a glass or short vase with about an inch of water. Keep on the counter at room temp. To dry, place chopped herbs on a plate and set in a cool, dry place for a few days. Store in the fridge afterward.
- **Chives, thyme, rosemary:** Wrap loosely in plastic and put them in a door compartment of the refrigerator. Rinse just before using. To dry, place whole herbs on a plate in a cool, dry place.
- Herbs should be thrown out when leaves turn dark or brittle, or when you see mold.

What's bugging you

The National Pest Management Association in September released its Fall/Winter Bug Barometer, forecasting what types of pests to expect in each region of the country:

- **Southwest and West Coast:** Exceptionally hot temperatures will drive cockroaches and ants inside.
- **Midwest:** The mild spring and warm summer boosted rodent populations, so more mice are looking for shelter now. Earwigs and millipedes are also more abundant.
- **Southeast:** Mosquito populations will persist well into the fall, from summer's heavy rains.
- **Northeast:** More stink bugs and ladybugs emerged in summer, and they'll try to move indoors when temps fall. Ticks will also stay prevalent until cooler conditions move in.

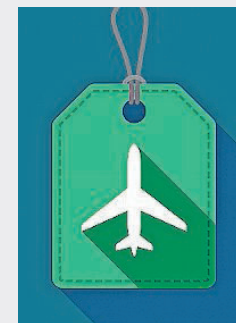
Skip: Mail-in rebates

Unless you're disciplined enough to fill out the form and wait to receive the rebate, you could end up paying more than you intended. And even if you do follow through with a rebate, you'll have to shell out a higher price at the register before getting some money back.

Always read the fine print; some kitchen appliances, electronics and other popular items may require you to fill out a mail-in rebate to achieve the advertised price. 

Okaloosa Lane did decline to sell right of way to the county; the planning done to move the road will cause a portion of Okaloosa Lane not to have sidewalk when the paving is complete.

The sidewalk that will be in place is important for school children, Harris said. Both Riverside Elementary School and Shoal River Middle School are located on Redstone Avenue, close to its intersection with Okaloosa Lane.

Harris said one of the reasons he fought so hard for so long to get Okaloosa Lane paved is that as a dirt road it was prone to washouts. One rainstorm in 2014 that dropped almost 2 feet of rain on Okaloosa County scratched a trench 6 feet deep in the roadway near the stream.

Bitterman confirmed "paving a dirt road clearly helps with washouts and water quality."

A paved road running north and south, providing connecting routes to State Road 85 and U.S. Highway 90 will obviously improve bus access to the schools, Harris said.

"This project will save the school district thousands of dollars a year," Harris estimated. "If they have a ribbon cutting or something, I want to be there."

amendment was to ensure residents aren't hooking their RVs up to their homes, using the utilities and living out of them. With a 6-foot fence, he said, the city would not be able to tell if someone is living in their RV.

Another issue Faircloth had with the ordinance was the lack of specification of who approves the screening. According to Gaillard, the growth management department would approve the screening.

While the council discussed the amendment, Councilman Shannon Hayes said if the ordinance amendment is not approved, they will revert back to the previous ordinance which is more restrictive; RVs 24 feet in length or longer cannot be stored on property.

Councilman Joe Blocker questioned if the city is crossing the line by regulating private property. City Attorney Ben Holley said the city has a right to regulate what residents do on their private property.

According to Gaillard, the council did not provide firm feedback to staff when the ordinance was discussed at previous meetings, workshops and during a first reading. Councilman J.B. Whitten disagreed with her statement, and said they provided much feedback to city staff.

Residents approached the council to voice their opinions; among them was Andrew Rencich, who received a notice of code violation in early 2017.

"As I mentioned before... the ordinance... affects working and retired, middle-class families through the city of Crestview,"

Rencich said. "This ordinance is a gross government overreach on individual property rights. The way the ordinance is written leaves massive holes for possible litigation and is open to interpretation."

Rencich said the ordinance is discriminatory against RV owners, as other types of trailers are not mentioned. Resident Stephen Strom agreed.

"I don't have a dog in this race, as I don't have an RV," Strom said. "This is discriminatory. Flat out, no question about it... We can put any boat in our yard; I can put the Queen Mary on a trailer and park it in my yard... and it would be no problem."

Hayes made a motion to approve the ordinance and send it to the mayor and the city clerk to sign. Councilman Cox seconded the motion. According to Cox, the ordinance was well done; there was a length restriction before, and now there is not.

Whitten said the council promised the citizens they would continue on until the ordinance was fixed, and he feels it needs to be fine-tuned before passing. Most back yards aren't equipped to take an RV, and equipping them would be costly or impossible.

"I think we overdid it, and got carried away with what we wanted to do," Whitten said. "In case you can't tell, I don't support it."

The council voted on the previous motion to pass the ordinance, but it failed with only Cox and Hayes in favor. Hayes made a motion to hold a continuing workshop on the issue on Jan. 22, 2018, and all council members were in favor.

The moratorium was extended until the council can make a decision.

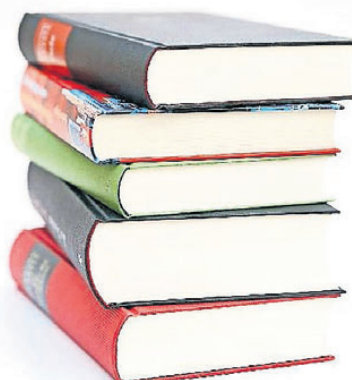

About that Christmas cactus...

Is your grandmother's pass-along Christmas cactus blooming really early? Do the leaf segments have "teeth" along the edges? Are the "stringy things" sticking out of the flowers yellow in color?

Well, I hate to tell you this, but that is not a Christmas cactus (*Schlumbergera bridgesii*). It

is a Thanksgiving cactus (*Schlumbergera truncata*). You can tell the Thanksgiving cactus apart from the Christmas cactus by the shape of the leaves and flower anthers.

The leaves, botanically referred to as phylloclades, are serrated on the Thanksgiving cactus. Additionally, the pollen-bearing anthers in Thanksgiving cactus flowers are yellow. Christmas cactuses have smooth-edged leaves and pinkish-purple anthers.

Both of these species are native to the coastal mountains of south-eastern Brazil, where they are found

growing in trees or on rocks. Therefore, the preferred potting media for Thanksgiving and Christmas cacti should contain about 40 percent perlite to ensure good drainage and aeration.

To care for your Thanksgiving cactus, allow the soil to dry out when it is not blooming. As flower buds develop, the soil should be moist to the touch. However, overwatering can kill the plant. Additionally, provide plenty of indirect light and temperatures of 60-65 degrees Fahrenheit.

Want to get last year's plant to bloom again? Beginning in mid-September, it

will need 12-14 hours of total darkness, along with cool (60-65 degrees F) nighttime temperatures for three to four weeks. To achieve the light control, the cactus can be placed in a closet or covered with a large brown paper bag overnight.

Once buds start to form, fertilizer can be applied to encourage growth and blooms. However, flower buds will fall off with any significant changes in temperature (below 50 degrees F), light or watering.

Now, if your "Christmas cactus" doesn't set flowers until spring, it is probably an Easter

cactus, a totally different species (*Rhipsalidopsis gaetneri*). The leaf margins of Easter cactus have small bristles and are more three-dimensional, with a thick ridge on one side. Additionally, the flowers are more star-shaped than the other two cacti.

All three cacti species have flowers that come in a range of colors including variations of red, pink, peach, purple, orange or white.

During holidays, be extra vigilant about protecting financial data

Although this might seem like a hassle, it can be helpful, because even if identity thieves were to grab one of your new passwords, they still couldn't use it for other sites you may visit. And you can even find a free online program that can help you keep track

of all your passwords.


- Be suspicious of "huge savings." It happens every holiday season — identity thieves develop fake sites with attractive graphics and stunningly low prices on a variety of items, especially digital devices. If you fall for these pitches, you won't get any merchandise, but you might get a handful of headaches once the bad guys have your credit card number and other personal information. To prevent this, be wary of any deal that sounds too good to be true, and do some digging on the websites that offer these mega-savings.

- Watch for fake shipping notices. During the holidays, when you may do a lot of online shopping, you will probably receive some legitimate shipping notices. But the bad guys have gotten pretty good at generating fake notices designed to resemble those from UPS, FedEx and even the U.S. Postal Service. If you were to click on the link provided by one of these bogus notices, you could either take on some malware or get taken to a "phishing" website created by the shipping notice forgers.

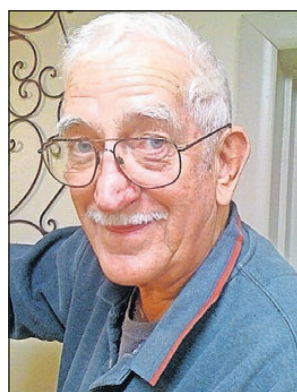

In 1978, President Jimmy Carter brought two world leaders to Camp David, the presidential vacation home: Anwar Sadat (sah-DOT), the president of Egypt, and Menachem Begin (BAY-gin), the prime minister of Israel.

The two Middle Eastern countries had been at war for more than 30 years. Many people, including children, had been killed in battle and by acts of terrorism. But Carter believed that if he could get Sadat and Begin to talk face-to-face, they could begin to work out their problems.

Touching their hearts

The Israeli leader had requested autographed pictures of the three men together. He wanted them for his grandchildren. President Carter had his secretary find out the names of the kids, and he personalized each photo.

When Begin was handed the pictures, he thanked the president. Then he looked at the autographs and read his grandchildren's names.

The tough old leader's eyes filled with tears. The sight of those names led him to talk about the special people in his life and about the terrible effects of war on children.

After that, the tone of the talks turned around, and a settlement was reached. In 2002, President Carter was awarded the Nobel Prize for Peace.

A simple beginning

James Earl Carter Jr. was born on Oct. 1, 1924, in Plains, Georgia. His dad owned a general store and bought some farmland in Archery, where as a teenager Jimmy was given his own acre to grow peanuts.

Carter was a good student and was accepted into the U.S. Naval Academy in Annapolis, Maryland, in 1943. He married Rosalynn Smith in 1946, and they lived in many different states while he served on Navy submarines.

After his discharge from the Navy, Carter and his family worked to expand their peanut-growing business.

Political life

Carter served as a Georgia state senator and as governor from 1971 to '75, and in 1976 he was elected president.

Although he faced many challenges, as president Carter worked for human rights all around the world, for energy conservation, for educational programs and for environmental protection.

The Carter Center in Atlanta continues the former president's work with teams of people who observe elections all over the world and try to resolve conflicts.

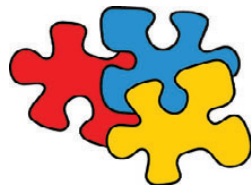

Final adjustments made on Bark Park

CRESTVIEW — Construction on the Crestview Bark Park may soon begin after years of planning and preparation.

April Meier, owner of Pawsitively Scrumptious on Main Street, was approved by the Community Redevelopment Agency and the Main Street Crestview Association to oversee the project. Meier said she began exploring the idea of opening a dog park in 2013 due to the Hub City's overwhelming demand.

In 2016, Crestview resident Ted Simmons gifted the

MSCA \$62,000 for construction of the dog park within Twin Hills Park.

Meier raised funds through dog washes, raffles and a "Paws for a Cause" event where donors could purchase an engraved brick memorializing their pets that have died. The bricks cost \$65 and will be displayed outside the park.

The fundraising efforts collected approximately \$3,000. In 2017, the CRA agreed to put another \$10,000 toward the project. Growth Management Director Teresa Gaillard said there has been a lot of donated time and maintenance for this project, which has saved on cost.

To offset the costs of

maintenance and ensure dogs are properly vaccinated, the city plans to implement a membership registration process. The projected membership costs would be \$25 annually for residents and \$35 annually for non-residents, according to Meier. Members will receive a swipe card for park entry and Meier said she believes they will be more inclined to volunteer in park upkeep.

With the Crestview Public Works Department's guidance, MSCA worked on the design layout and purchased all equipment. All of these aspects were presented to the CRA at their October meeting.

The original projected completion date was March 2017; however, the project was delayed because the city needed to ensure proper drainage was accounted for per EPA guidelines.

Callie & Co., a land planning and landscape architecture company out of Destin, designed the Bark Park.

The park will include 14 waste receptacles, six benches, two barrel obstacles, weave poles, two agility walks and two A-frame obstacles. The city is purchasing all of this equipment from Dog On It Parks.

A conceptual plan is complete with the layout of the park, but the plan is not

released for construction yet.

According to Gaillard, the next step will be to tweak the plan based on requirements from the public services department, and then construction can begin.

Gordon Martial Arts students learn from taekwondo artist

CRESTVIEW — In 1955, a 35-year-old two-star South Korean general named Hong Hi Choi coined the term Taekwon-Do. About 10 years later he formed the International Taekwon-Do Federation, which would serve as a launching platform for millions to do the most popular martial art in the world. Before his death in 2002, seven men were promoted to the highest rank of 9th degree black belt. The second of those men is Kwang S. Hwang.

In the martial arts world, getting the opportunity to meet a first-generation martial artist is unusual. An opportunity to catch a seminar with one is even more unlikely. On Nov. 2, the students at Gordon Martial Arts were able to learn directly from Grand Master KS Hwang. During the seminar the students were taught in fundamentals of Taekwon-Do with principles of generation of

power as went through all of the color belt patterns. Afterward there was opportunity for pictures and quick visits.

Hwang was born in 1942 and started his martial arts training at age 11. Graduating top of his class, in 1968-1969, he was one of the Taekwon-Do instructors

dispatched to Vietnam during the war. While in Vietnam, as a captain in the ROKA, he taught the art to the Korean Tiger Division, the Korean Army, U.S. Army, U.S. Marines, and Vietnamese Army.

While in Vietnam, he received commendation medals from Korea

and Vietnam. In 1971 he was service company commander of the 26th Infantry Division, which was also known as the Taekwon-Do Division. After leaving his military career, he moved to the USA and opened a martial arts school. Today he travels around the world teaching Taekwon-Do.
