

Mency's murder trial date pushed to March

LIVE OAK — The trial for Corry Mency has been pushed back to March.

Mercy is charged with murdering his cellmate in prison and his trial was previously set for January.

According to the Suwannee County Clerk of Court Office, the trial was pushed back due to Mency being appointed a new lawyer.

According to court documents, a correctional officer overheard the inmates yelling and went to check on the cell. When the officer entered the cell, Mency said his roommate had suffered a seizure, the documents state.

The officer found Gabriel lying on the bed covered by a blanket with blood on the wall near his head.

Mency was removed from the cell and later told officers that Gabriel had been sexually harassing him, the documents state.

According to inmate testimony, around 6 a.m., one inmate heard a struggle and beating coming from Mency's cell. After a few minutes, he heard Mency call out for medical assistance about a seizure.

The medical examiner reported Gabriel's death was manual strangulation. The examiner also found bluntforce face and head trauma on the victim.

Wellborn farmers place in national yield contest

WELLBORN - Mark and Taylor Randell, and Mark Randell and Tommy Taylor, all of Wellborn, recently placed in the 2017 National Sorghum Producers Yield Con-

Mark and Taylor Randell won state first place in the irrigated reduced-till division, while Mark Randell and Tommy Taylor won state first place in the irrigated conventional-till division. Both divisions were won with Pioneer hybrid 83P17, which yielded 90.78 and 91.91 bushels per acre, respectively.

"We are proud of Mark and Taylor Randell, and Mark Randell and Tommy Taylor's performances using Pioneer brand sorghum hybrids in the 2017 NSP yield contest," said Liesel Flansburg, DuPont Pioneer sorghum marketing manager in a release. Remembering Suwannee

Fire leads to Alimar's demise in late '70s

Today completes the article series on the notable Live Oak hangout, the Alimar Theatre.

The Alimar received major competition in 1936, when the Suwannee Theatre was opened by Johnnie and Ford Kalil a block away on the west side of Ohio Avenue. This theater, in service for several decades itself under a variety of owners, gave the citizens of Suwannee County additional options for movies and other performances. The Alimar, Suwannee Theatre, and other local movie theaters (eventually including drive-ins) were a source of employment and hangouts for area youth. By 1950, the Alimar was listed in the Film Daily Year Book as having room for 700 patrons, far more than the Suwannee Theatre's seating capacity of 300.

On Dec. 29, 1970, a crowd showed up at the Alimar to watch the "world premiere" of the movie "Zaat," filmed in North Florida. Actor Wade Popwell, who played the monster in the movie, was present in character to welcome the throng of moviegoers. Unfortunately, the low-budget film was a flop and is generally included in lists of the worst movies of all time.

In the late 1970s, a second movie screen was installed at the Alimar to allow more variety in its shows. However, patrons

did not get to enjoy this benefit for long, as the historic theater burned down in or about 1979, taking with it the adjoining Dixie Grill. A note from one of the firefighters who attended the blaze stated that nine firefighters, eight volunteers and the fire




chief were all required to put out the fire. Three pumper trucks were used (a 1956 Ford, a 1969 Ford, and a 1978 Ford), using nearly half a mile of hose and about 300,000 gallons of water. Ironically, one of the movies playing at the time of the fire was "Smokey and the Bandit!" (the other movie was "Crimebusters").

Although most of the shell of the Alimar survived the fire, it was deemed too badly damaged to be economically repaired. Seeing the same fate as many other prominent buildings in Live Oak and Suwannee County, the building was torn down. The historic theater was replaced by a parking lot that honors its history by being named Alimar Court.

Council eyes expanding natural gas program

LIVE OAK — The Live Oak City Council had a short meeting Tuesday night.

The city approved a proposal from Florida Gas Utility to design an expansion of the city's

natural gas program.

"We have been looking for ways to expand our natural gas program," City Manager Ron Williams said. "It is not only environmentally solid and beneficial but there are financial incentives for the city to do it and also our businesses throughout

the city are asking to make natural gas available."

The proposed design features a natural gas pipeline project along U.S. Highway 129 to serve the Busy Bee service plaza and other customers on the west side of U.S. 129 near Interstate 10. The proposed pipeline will also serve

the South Oaks Shopping Center

The design will cost \$41,763.75.

The council also voted to accept a quit claim deed for property adjacent to the city's roadway on Horne Avenue.

Williams said historically the

city has used the property and the property owners don't want

"They don't have any use for (the property) at all," Williams

He added the property owners are covering the cost of the quit

White Springs fire chief resigns

Six firefighters also submit resignations

WHITE SPRINGS — Seven members of the White Springs Fire Rescue, including Fire Chief Kevin Pittman, resigned at Tuesday night's town meeting.

The resignations came after discussion at the December meeting in regards to Town Manager Stacy Tebo asking for Pittman's resignation Nov. 29. Also during that meeting, members of the fire department asked for support in a vote of no confidence against Assistant Fire Chief Andrew Greene.

The council then decided to move the issues with the fire department to the January agenda.

During Tuesday's meeting, Tebo submitted a Memorandum of Complaint against Pittman, providing each council member a copy.

Several citizens asked for a copy of the memo as well as Pittman, who said he had not seen or heard of the memo.

"This document was created today and was finished right before the meeting," Tebo replied.

Pittman said: "Since it involves me I would like to be able to read through it."

According to the memo, Tebo asked for Pittman's resignation in order to avoid public embarrassment and keep disciplinary action out of his personnel file.

Tebo added that when she asked for Pittman's resignation it was just as chief, that he could decide whether to remain as a volunteer

firefighter.

In the memo, Tebo outlined the reasons that led to her decision to seek the resignation, mainly stemming around attempts to get certification for the town's volunteer firefighters.

According to the memo, Pittman

allegedly told Tebo he was a certified instructor and with the help of another instructor would hold classes to provide certification for the firefighters.

Last summer,
Tebo and Pittman had talked about
recognizing everyone who earned
their certifications publicly at a
meeting, according to the memo.
The recognition was rescheduled
from June to July because not everyone had received their certificates.
The recognition was held at the July
11 meeting.

However, Tebo states in the memo that she received a call from Hamilton County Emergency Management Director Henry Land on Aug. 2, stating one of the individuals was not certified and Pittman's signature was not being accepted by the fire college.

Land offered Tebo assistance in getting students certified and could sign off on the certificates, according to the memo. Tebo told Pittman and he allegedly stated it would not be necessary.

In the memo, Tebo states she then looked further into Pittman's previous employment and certifications where she found an expired instructors certification. It expired June 30, 2015, and was given a one-year extension to June 30, 2016.

While looking into his previous employment at Suwannee County Fire Rescue it shows he was terminated on July 12, 2012, and is stated on his resume that he worked with SCFR through July 2013.

"He was dishonest to me about his instructor certification," Tebo wrote, adding "he was also dishonest on his resume.

"The integrity of the Town, the Council, and myself was compromised as we unwittingly participated in the deception."

Also in the memo, Tebo documented issues surrounding the purchase of a fire truck from the Windsor Fire Department. The memo states that Pittman had spent money on repairs and decals for the truck prior to the council approving the agreement, also alleging that the repairs were done without her approval.

After given a chance to read through the memo and prior to the memo being read aloud at the meeting, Pittman resigned.

"I have been fired before and I have quit a lot of jobs, so effective right now you have my resignation as fire chief for this department," Pittman said. "Tomorrow I will return the truck, personal items and the keys, my keys to the town.

"There is no point in going through this, this is nothing but... crap. I'm just going to say it and I am not going to have my name put out there and walked on."

Following Pittman's resignation, six volunteer members of the department resigned as well.

"Hold on. We have moved on from the fire department, there's no..." Mayor Rhett Bullard said before the six volunteers cut in stating: "Let's just do this right then, right now. If you're going to move on, then we're going to move on. My name is Thomas Brazil, I'm a Firefighter engineer for White Springs Fire Department and this is my resignation."

Brazil was joined by Antonio Perez, William Register, Peter Shanks, Andy Stormant and Andrea Thompson in submitting their resignation, leaving nine members at the fire department as of Wednesday afternoon.

Dent's departure from House makes Allentown vulnerable to Democrats

WASHINGTON — It is almost a law of our political physics: Those who choose to leave Congress thereby demonstrate qualities that make one wish they would linger here longer. After seven terms in the House of Representatives, which followed eight years in Pennsylvania's House of Representatives and six in the state Senate, Republican Charlie Dent, 57, is moving on without knowing his destination.

He smilingly says he does not want to jeopardize his 13-0 win-loss record in elections, but that does not explain what is, in Washington's mentality, inexplicable: He is leaving even though he is one of the 12 House "cardinals" who hold coveted chairmanships of Appropriations Committee subcommittees. Another eccentricity is that he is not angry about anyone or anything, not even the Senate, where so many House-passed measures go to die, victims of, among other things, the need to get 60 votes for almost anything more consequential than naming a post office. This, and Congress' dysfunctional budget process, devalues the status of cardinal.

Dent has been a leader of the Tuesday Group, approximately 50 "moderate" Republicans many of whom, including Dent, would thank you for not affixing to them that libelous label. (Dent likes "center-right.") He comes by his Republican politics of (don't-say-) moderation by family tradition: His father's sister, who also was born in Allentown, was Mary Dent Crisp (1923-2007). She became chairman of the Republican National Committee in 1977, but was replaced in 1980 when she dissented from the Republican platform's strong opposition to abortion, and to the Equal Rights Amendment, which Republican platforms had support-

Dent is leaving because he fancies — yet another eccentricity — trying a career outside politics, not because he sees difficulties for Republicans 10 months hence. He does, however, know there is a possibility that in 2019 House Republicans will be in the minority, a dismal experience that he has had but that 175 of the 239 current Republican members have not. Last November's elections for "row offices" (treasurer, controller, clerk of courts, etc.) in the collar counties around Philadelphia (Chester, Bucks, Delaware) were disastrous for Republicans. In Chester, Democrats won all such offices for the first time ever. In Bucks, Republicans lost every race except for district attorney. In Delaware, Republicans lost two county council races, their worst result since 1974, the post-Watergate election in which Republicans lost 48 seats in the U.S. House





Harris said since it was an older project in place prior to that new rule coming out, it was anticipated that they would be allowed to follow the old rule but they weren't.

"We had to scramble because this project has to be done right away," Harris said.

The project will begin at the existing four-lane section at the Interstate 10 interchange and extend west of the 175th Road and U.S 90 intersection.

The project is funded by Florida Department of Trans-

portation **Dragline Repairs**

The commissioners also approved emergency repairs to the dragline, which operates in the Branford limerock

Harris said the dragline is in need of repairs before it can be operational again.

He said the county is unable to mine limerock for its maintenance needs and new projects until the dragline is fixed.

The estimated repairs from Barry Green & Associates were \$37,500 but the commissioners approved the use of new parts which will increase the cost. A new swing shaft is \$15,250 compared to a \$9,900 rebuilt shaft. The cost of labor, motel costs, travel expenses and mileage may cost as much as \$12,000.

Harris said the cost of repairs could be higher than estimated if, during repairs, something else is discovered.

The commissioners also approved the rental of a crane, that is needed to facilitate repairs.

— the late Rev. Dr. Martin Luther King Jr.

On Monday, Jan. 15, 2018, we will celebrate the life of the slain civil rights leader the late Rev. Dr. Martin Luther King Jr. Some know and some don't realize that 2018 will mark 50 years, a half century, since his death by an assassin's bullet on April 4, 1968, in Memphis, Tennessee.

Dr. King's words live on, and in cases of access to social and political opportunities for many in our nation, his works nor his sacrifice have gone unrewarded. Happily in today's world, people of all races, creeds, and colors are allowed access to educational, social and political opportunities that, in the lifetime of Dr. King, and his forebears was truly, "a dream." One part of the dream "deferred" deals with the quote by Dr. King at the beginning of this column, "What are you doing for others?" If you can't make a difference with a hundred people or, even 10, maybe you can make a difference with one or a couple. How can I do that? It's a

question worth asking, and one that deserves and answer, and it's very simple.

Exercise in your daily life more kindness, less narrow-mindedness and more openness to the ideals and ideas of others and, remember folks can have a disagreement without being "disagreeable." That's something worth pondering.

If someone doesn't necessarily have your same opinion, allow that person to have their own opinion, but within the framework where you CAN, exercise kindness, civility and tolerance, and, in that way, you will have paved the road to mutual understanding.

My philosophy of education during the years I spent in and out of the classroom was a very simple one: "Children may not always remember what you taught them, but they will always remember how you made them feel."

During this week when we anticipate the celebration of the Dr. King's national holiday, I want to pay tribute to some folks, some have forgotten and others never knew in a small corner of the world that was economically and politically insignificant and steeped in the traditions of the deep South as much as any place in the Mississippi Delta, my own hometown of White Springs, Florida. A small school, South Hamilton Elementary, and a group of adults, educators, and everyday citizens, who modeled for many students "how" to live and the fact that "respect wins respect." It wasn't easy for any of them, but they did it in their own way, and they did it at a time of major social transition, the full desegregation of the schools. In many parts of the nation, buildings burned, folks marched and fought, but in our corner of the world, peace prevailed despite many differences, and, this was due, to the "calm," "professionalism" and striving for peace and understanding in a small corner of the world in the Deep South here in north Florida. There may be some who will point to the faults these in-

this column, and the ones who are reading it, there was not perfection, but what there was, a willingness to try, a willingness to cooperate, a willingness to give life and love and all that it entails a chance. Utopia? Hardly. It was the Best of times and the Worst of times, but their example did provide a big step in the right direction of smoothing the pathway for a better tomorrow, and, through example, teaching us "how to think" and not "what to think." Big difference.

In today's world, if anything, there may be more turmoil, more mistrust, more lack of tolerance than there was 50 years ago, I don't know. What I do know is there is always the opportunity to do "for others" and "to do" in a way that is positive and kind. If each of us will work to do that, we might move towards a better tomorrow and realize the dream Dr. King gave his life for a half century ago. It's worth trying on a daily basis. He did, and his dream lives on.

of Representatives. Allentown's Democratic mayor, although under indictment on a 54-count criminal indictment for corruption, was re-elected thanks to, among other things, surging Democratic turnout, and support from the approximately half the city's population that is Hispanic.

In 2016, Donald Trump's supporters voted, Dent thinks, for "an attitude." He says, "If I set myself on fire over an issue, some of these people would complain that the temperature of the flame is not hot enough." Trump won Dent's district with 51.8 percent of the vote; Dent won 58.4. This will be one of the districts Democrats target in their quest to gain 24 and reinstall Nancy Pelosi as speaker.

Hurt people lead to more hurt people

I love to read biographies and watch documentaries that tell the story of people who have survived despite extreme odds stacked against them. I cheer for those who have survived persecution, abuse, neglect and prejudice. And I grieve for those who don't; those who allow it to pound them into despair, bitterness, hate and an unquenchable thirst for revenge.

A few nights ago, I watched a documentary that left me feeling so troubled that I can't stop thinking about it. It was about a woman who killed several men and was put to death for her crimes several years ago. Her history began to unfold with sexual abuse from the age of 8, which continued until she was about 13. By that time, she was on her own and turned to prostitution to support herself. By her testimony, the first time she committed murder, it was in self-defense. She killed a man to stop him from killing her. This was the point of no return for her, so she kept killing, until she was caught, prosecuted and put to death.

At the end of the documentary, there were testimonies from the families of her victims who were devastated, and rightly so. No one spoke on her behalf. No grieving parents or friends to question what went wrong. I turned the television off and went to bed thinking how sad this woman's life began and ended. She started out as a victim and ended up leaving a trail of victims in her wake. I am the last to deny personal responsibility of our own choices, but when people become victims at such a young age, especially of this kind of abuse, we can easily understand how their perception of life is distorted.

My reason for sharing this with you is twofold. First, if you have suffered abuse and you have never addressed it to the point of emotional healing, please consider doing so. Find a trusted friend or a Biblical Counselor to work through this with you. Seek healing so that you don't in turn leave victims in your wake. Don't think just because you aren't planning on killing someone that you are harmless. The truth is this: hurt people hurt people. Find healing.

Secondly, I mentioned that one form of abuse is prejudice. Prejudice has become quite a political buzz word in our society, but it goes far beyond simply racial or ethnic division. Webster's dictionary defines prejudice, "To bias the mind by unfair opinions." The word itself (pre + judge) shows how: We judge someone BEFORE they have any input. Be honest, who stands a chance against a mind already made up? Think carefully about your opinions of others and consider that if you were in their same situation, you may have made similar choices.

"There is neither Jew nor Greek, there is neither slave nor free, there is no male and female, for you are all one in Christ Jesus." (Galatians 3:28) "All have sinned and fall short of the glory of God" (Romans 3:23)

We knew from common sense that smoking wasn't good for the human body even before the surgeon general weighed in. But we grew it for other people to abuse.

Few country preachers dwelled on this evil because in so many cases it paid for the new organ and the new pews. Like I said, hypocrisy. I attended that church.

As a farm boy I saw the poisons we mixed to kill the insects that could decimate a

tobacco crop. Many of those chemicals are no longer on the market. They were also determined to be carcinogenic.

At one time, tobacco was an allotted, government-supported crop. Health enthusiasts and some taxpayers gnawed on that subject until it began to become unhinged. Taxes on tobacco were often referred to as sin taxes but welcomed in coffers.

During my stay at Mayo Hospital in 2016, I saw many people there getting lung transplants. My guess is that many of these cases were linked to cigarette smoking.

The irony is that there I was with cancer, and I'm not even a smoker. My point is that there are enough things out there that we can't control that can get us without cheering on the adversaries.

A little tobacco is still grown in these parts. But not nearly as much as back in the 1950s and 1960s. Times change. It would shame us now to have a tobacco harvest festival. And that's a good thing.





Joyner said he spoke with the team during the break about starting a new chapter — forgetting about a tough first half of the season and starting new in 2018.


It looked like the Bulldogs heeded that advice on Wednesday.


