STATE BAR ASSOCIATION PERFECTS ORGANIZATION

W. A. Blount, of Pensacola, Elected Vice President for This Circuit.

MEETING AT JACKSONVILLE WAS LARGELY ATTENDED BY LAWYERS FROM ALL PORTIONS OF THE STATE—SUMMARY OF THE PROCEEDINGS.

With a large attendance of lawyers from all portions of the state and with much enthusiasm manifested in the objects for which it was organized the Florida State Bar Association was yesterday launched upon its career of usefulness for the legal profession and for the good of the people of the entire state, says the Jacksonville Times-Union.

The convention of lawyers that had been called, assembled in the auditorium of the Jacksonville Board of Trade, and for nearly four hours worked with the sole object in view of perfecting an organization for an association whose object is declared in the constitution to be:

"To advance the science of jurisprudence, to promote reform in the law, to facilitate the administration of justice, to uphold the standard of integrity, honor and courtesy in the legal profession, to encourage legal education, and to cultivate a spirit of cordiality and brotherhood among the members of the bar."

Officers Elected. The officers elected to steer the new draft for the first year of its existence are as follows:

President—R. L. Anderson, of Ocala. Vice President for First Judicial Circuit—W. A. Blount, of Pensacola. For Second Circuit—W. H. Ellis, of Tallahassee.

For Third Circuit—Ira J. Carter, of Live Oak.

For Fourth Circuit—Charles M. Cooper, of Jacksonville.

For Fifth Circuit—George M. Martin, of —.

For Sixth Circuit—Jefferson B. Browne, of Key West.

For Seventh Circuit—Syd L. Carter, of Gainesville.

Secretary—Fred T. Barnett, Jacksonville.

Treasurer—John W. Burton, of Arcadia.

Executive Council—The above officers and D. U. Fletcher, of Jacksonville; William Hunter, of Tampa; W. A. McWilliams, of St. Augustine and William A. Hocker, of Ocala.

Convention Called to Order. The meeting was called to order by Hon. Walter B. Clark, president of the Jacksonville Bar Association, who welcomed the visiting members of the bar and briefly outlined the objects for which the meeting had been called.

Mr. Clark stated that delegations had been expected from Pensacola, Tallahassee and other places in the western part of the state, but that a telegram had been received stating that they were unable to reach Jacksonville in time to attend the meeting on account of a railroad accident. He expressed deep regret at the unavoidable absence of these delegations and the individual members of the bar from middle and west Florida. He then proceeded to address the convention.

Temporary Organization. The convention then proceeded to perfect a temporary organization, and this resulted in the selection of former Governor Francis P. Fleming as temporary chairman, and Mr. George Couper Gibbs as temporary secretary.

Before turning over the convention to the temporary officers, Mr. Clark read a letter he had received from the members of the supreme court of Florida, expressing their regret at being unable to attend the meeting and participating in the organization of the State Bar Association. The letter was signed by each of the members of the supreme court, and in it they expressed their hearty endorsement of the movement and wished the prospective organization every success.

Upon motion of Hon. W. L. Palmer, of Orlando, the chairman then appointed a committee of five to draft and report a constitution and by-laws for the proposed association. The committee named consisted of W. L. Palmer, of Orlando; R. L. Anderson, of Ocala; W. A. Carter, of Tampa; George C. Bedell, of Jacksonville, and W. H. Ellis, of Tallahassee.

Wants Supreme Court Moved. Gov. Fleming invited any member present to address the convention while they were waiting for the committee to report. No one seemed disposed to respond, but finally W. W. Dewhurst, of St. Augustine, made a brief address in which he advocated the association and the members of the bar generally making an effort to secure the removal of the supreme court of Florida from Tallahassee to some point more centrally and conveniently located for the transaction of business by the attorneys from the various portions of the state. He was

of the opinion that a constitutional amendment could be passed providing for the holding of terms of the supreme court in some other section of the state than Tallahassee.

C. Fabian Law of Green Cove Springs called attention to the fate of the constitutional amendment voted upon last fall.

Gov. Fleming remarked that some of those amendments failed to pass on account of being in bad company. American Bar Association.

Mr. Clark then addressed the convention, by request, upon the American Bar Association, of which he is the vice president for Florida.

He stated the objects and advantages of the association and urged that the membership from Florida should be increased to double the present number.

After being out for nearly an hour, the committee appointed to draft a constitution and by-laws, reported, submitting a draft of a constitution and by-laws, which is very similar to the constitution of the bar association of the state of Maryland.

The constitution contained the following provision in regard to membership and election of members of the association:

Membership. Article III. The members of the legal profession of the state of Florida attending this convention, this 5th day of February, 1907, are hereby declared to be members of this association, provided they shall, during its present session, sign this constitution and pay the admission fee hereinafter provided.

Any other member of the legal profession in good standing, residing or practicing in the state of Florida, who shall have been at the bar of this state for at least one year, may become a member upon nomination and vote of the association or action of its committee on admission, as hereinafter provided.

Election of Members. Article IV. Nominations for membership may be made to the president of the association, and be by him at once reported to the committee on admissions, which shall thereupon examine the same and report thereon with its recommendation to the association at its next annual meeting. The members of the association at such meeting shall thereupon vote upon said nomination by ballot. Several nominations may be voted for upon the same ballot and in such case placing the word "no" against any name or names upon the ballot shall be deemed a negative vote as to such name or names and against those only; but during the period between the annual meeting members may be elected by the executive committee upon the written nomination of at least two members of the association, approved by the members of the committee on admissions from the proposed member's judicial circuit. One negative vote in every five shall suffice to defeat an election. No member of the bar residing in a county or city where there is a local bar association shall become a member of this association unless he shall also be a member of such local association. This clause, however, shall not apply to the state federal judges.

The following in regard to committees is included in the constitution:

Committees. Article VI. At the annual meetings the association shall also elect an executive council, to be composed of four members, of which council the president, secretary and treasurer shall be members ex-officio. Said members of the executive council shall hold their office for one year from the date of their election, and until their successors are elected:

The president shall, with the approval of the executive council, appoint the following standing committees, to-wit:

A committee on admissions. A committee on judicial administration and legal reform. A committee on legal education. A committee on grievances. A committee on legal biography.

If any member of a standing committee shall fail to attend any annual meeting, his absence shall create a vacancy and the president of the bar association may, in his discretion, fill such vacancy by appointment.

Each standing committee shall be composed of one member from each judicial circuit represented in the association, and a majority of the members of each of said committees shall constitute a quorum of such committee to transact business.

Each committee shall, at each annual meeting, report in writing a summary of its proceedings since the last annual report, together with any suggestions deemed suitable and pertinent to its powers, duties or business.

A general summary of all such annual reports and the proceedings of the annual meeting shall be prepared and printed by and under the direction of the executive council, together with the constitution, by-laws, names and residences of officers, standing committees and members of the association as soon as practicable after each annual meeting.

In the constitution, as reported by the committee, it was provided that the annual dues should be \$10 per year. After considerable argument the dues were fixed at \$5, and the constitution was then adopted without further amendment, although several proposed amendments were offered but defeated.

Permanent Officers Elected. A committee to select the names of officers and report the same to the convention, was then named, and retired. This committee consisted of William Hunter, of Tampa; W. B. Clark, of Jacksonville; Syd L. Carter, of Gainesville; A. H. Mickler, of St. Augustine, and W. A. Carter, of Tampa.

The committee was out for quite a while and finally reported the names mentioned near the beginning of this article as those nominated for the permanent officers of the association.

The secretary of the temporary organization was authorized by a unanimous vote to cast the vote for the election of the officers nominated and all were declared elected.

This perfected the organization and the newly elected president, Mr. R. L. Anderson, of Ocala, was escorted to the chair and presided over the further proceedings.

To Meet in Jacksonville. An invitation to hold the next annual session of the convention in Jacksonville was extended by Mr. W. B. Clark, on behalf of the Jacksonville Bar Association. As the place of meeting is to be selected by the executive council, on motion of Mr. R. E. Davis, of Gainesville, it was declared to be the sense of the association that the executive council select Jacksonville as the place for holding the next meeting.

Some routine business, only of interest to the members of the association, was then transacted, and the convention which had organized itself into the State Bar Association, adjourned, subject to the provisions of the constitution and by-laws, and also with the avowed intention of all the members to meet at the banquet last night at the Aragon, given by the Jacksonville Bar Association.
