## Gainesville Youth Summit



The State Attorney's Office is hosting its 3rd annual summit, "Serving Youth: Strategies that Work" on Friday, March 11, at the Trinity United Methodist Church, 4000 NW 53rd Ave., Gainesville, FL.

Education Activist, Joe Clark, will provide this year's keynote. Clark is the subject of the Warner Brothers film, *Lean On Me*, starring two-time Oscar nominee Morgan Freeman as Joe Clark. With the aid of a bullhorn, a baseball bat and the strength of his convictions, Clark took a crime infested, drug-ridden, inner-city high school and transformed it into an institution filled with serious learning

and immeasurable pride.

If interested in attending, the registration fee is \$20 per person if registered by March 4<sup>th</sup>, and \$30 per person for on-site registration. Registration fee includes refreshments, lunch, program materials, and the 2005 juvenile justice resource guide.

**Richard Hollinger**, Dean Dabney and Laura Dugan had their paper, "Who Actually Steals? A Study of Covertly Observed Shoplifters," published in Justice Quarterly.

**Jodi Lane**, along with co-authors Susan Turner, Terry Fain and Amber Sehgal, had "Evaluating an Experimental Juvenile Probation Program: Intervention and Outcomes," published in Crime and Delinquency. Jodi also had an article published in Criminal Justice Review entitled, "Researcher-Practitioner Collaboration in Corrections: Overcoming Hurdles for Successful Partnerships," co-authored by Susan Turner and Carmen Flores.

**Alex Piquero** had papers accepted at several journals, including Criminology, Journal of Quantitative Criminology, and Journal of Research in Crime and Delinquency.


for getting me prepared for his career and I hope to see many future UF alumni in the agency."
