## St. John Police Investigating Death of Woman, 41, After Fight with Husband in Rental Villa

#### St. John Tradewinds

Police are investigating the death of a female that occurred at a private villa on St. John. The incident was reported to the 911 Emergency Dispatch at about 11:50 a.m. on March 2.

According to the preliminary information, police interviewed a male who said he and his wife were on vacation from Virginia and had an argument at the villa. The male said after the argument he slept outside the rental property in his vehicle. The next morning he tried to enter to the villa but could not gain access. He called for assistance to get inside and once inside discovered the unresponsive body of his 41-year-old wife.

St. John Deputy Police Chief Maria Jones said this case is presently under police investigation and detectives are examining all aspects of this case. She said "This is preliminary information and further investigation as well as an autopsy needs to be done," Deputy Chief Jones said.

Deputy Chief Jones urged anyone who had contact with the couple during their stay on St. John should call the detectives and tell them what they know. "Any information, even if you think it may not be significant or relevant to the case may help detectives get a clearer picture of the events leading up to this death," the Deputy Chief said.

With a theme of "Our Culture, Our Future: Passing the Torch," the two-day festival featured many talented local crafts people demonstrating everything from wood carving to basket weaving before a crowd of students from across St. Thomas and St. John all in the shade of the Annaberg Sugar mill

The Echo People set the tone with African-style drumming and dancing and Smalls and the Music Makers kept the beat up with their infectious scratch band sound.

Among the demonstrations were wood turning by distinguished St.

John wood artist Avelino Samuel, broom making by Edmund Roberts and seine net making by Mario Benjamin. During the two-day free festival, students also had the chance to see how to make dumb bread, johnny cake and Mauby; and taste those efforts as well.

Students also enjoyed tasting sugar cane cut right from the Annaberg garden and watching chicken wings fry up in an old pot over coals made on the Annaberg grounds as well.

VINP docents were on hand to share the rich history of the Annaberg Sugar Plantation and answer questions from the public.

Festival organizers welcomed younger students on Thursday, February 27, and older students on Friday, February 28, who heard from culture bearers including historian Dr. Gilbert Sprauve, folklorist Glen "Kawabena" Davis and African drumming instructor Eddie Bruce.

#### Public Hearing Is March 11 on Developer's Group Dwelling Request To Build 28-unit East Bay Beach Club

The long-tranquil East End neighborhood of St. John could be in for quite a change if developer's get a nod on their group dwelling permit from Department of Planning and Natural Resources officials.

The public has a chance to weigh in on the matter at a DPNR Group Dwelling Permit public hearing on Tuesday evening, March 11, at Guy Benjamin School, classroom six, at 6 p.m.

A company called East Bay Holding Company, LLC, has filed an application with DPNR for a group dwelling permit in order to construct East Bay Beach Club, a development of 28 three- and four-bedroom units plus a club house and associated structures on eight acres of land on East End Bay.

#### **Estate Hansen Bay Site**

The proposed development site, Parcel No. Remainder 6A-1 Estate Hansen Bay, is located past Privateer Bay at almost the very far end of East End. The area is zoned R-1, residential-one, which allows for two homes per half-acre of land.

East Bay Beach Club plans were drawn by the Adache Group

Architects of Ft. Lauderdale, Florida, and show eight single story, beach-front, three bedroom units and 20 hillside two-story, four-bedroom units plus a beach-front club house, pool and pool deck. The club house plans, located off the pool and pool deck, include a kitchen prep area, a great room, a bar, a gym and several offices.

Files for the planned East Bay Beach Club can be viewed at DP-NR's office located across from Elaine I. Sprauve Library in Cruz Bay. The office is open Monday through Friday from 8:30 a.m. to 4:30 p.m.

#### A Father Buries His Only Son, An Island Loses a Shining Young Man

Thomas Matthew was gazing at the morning bustle on Cruz Bay from the roadside above the quiet, sun-dappled cemetery sloping down to the waterfront early on the morning of February 24, envisioning the view his 22-year-old son, Magarbi McCullum "TJ" Matthew, would have from his final resting place.

"He was my only son," Matthew said of the oldest of his three children, his voice wavering.

"He liked to be called 'TJ' for Thomas Junior," his father recalled with his familiar smile easing his somber demeanor.

TJ was killed in a February 16 automobile accident near Seattle, Washington, where he had been serving in the U.S. Navy.

TJ and his father created Our Market Smoothies, the colorful oasis in downtown Cruz Bay across from the U.S. Post Office. Together they made Our Market and Hospitality Car Rental into a shaded gathering spot for visitors and residents with TJ working with his father there after school and on weekends and holidays.

#### "Spitting Image" of His Father

"He was the spitting image of his father," one business owner said of TJ.

TJ soon was helping to run the business with the same style as his father — the same heartfelt, friendly service and purposeful business sense.

"When he came back for Christmas and New Years, I was late opening up one day," Matthew recalled of his son's first visit home in December after three years in the U.S. Navy. "He said, 'Daddy consistency is the key to success in business."

TJ had stayed in the states since his enlistment in order to study to continue advancing in rank and most recently had achieved a promotion which normally would take six years, his father proudly noted.

"He said 'Daddy if I keep work-

ing I can make Chief," Matthew said with obvious pride at his son's accomplishments.

Matthew will be going to Washington state in early March to attend military services honoring TJ.

#### **March 8 Service at VINP Field**

A military color guard from Puerto Rico is scheduled to participate in a service for Magarbi "TJ" Matthew at the V.I. National Park ball field across from Mongoose Junction on March 8 at 10:30 a.m.

"The church would be too small," TJ's father said of the turn-out expected to welcome TJ home.

TJ will be buried next to his grandmother, Aurelie Doreen Matthew, in the center of the Cruz Bay cemetery with a clear view of the ferries coming and going from the Cruz Bay dock — the ferries which took TJ from his home island to success in his short U.S. Navy career.

"She raised him," Thomas said, taking some comfort in knowing TJ will be with his grandmother.

## If You Purchased Municipal Derivative Transactions from January 1, 1992 to August 18, 2011 You Could Get a Payment for a Class Action Settlement.

A proposed Settlement has been reached with Bank of America, N.A. ("Bank of America"), in a class action lawsuit that alleges price-fixing in the sale of municipal derivatives transactions by Bank of America and other companies. The case, *In re Municipal Derivatives Antitrust Litigation*, MDL No. 1950, No. 08-02516, is pending in the United States District Court for the Southern District of New York.

#### Who Is Included in the Settlement?

- (2) Any time from January 1, 1992 through August 18, 2011 in the United States and its territories or for delivery in the United States and its territories.

The Defendants and Co-Conspirators are listed in the detailed notice available on the Settlement website.

#### What Does the Settlement Provide?

Bank of America agreed to a settlement amount of \$20 million (plus any funds remaining in the State AG Escrow Fund that, as of the date this Notice is issued, Bank of America has access to pursuant to the terms of the State AG Settlement – this potential additional amount could be between \$0 and \$1 million) to be paid as follows: \$10 million has already been paid into an escrow account and the balance will be paid later. This Settlement is only a partial settlement of the lawsuit because it only affects the claims against Bank of America. The lawsuit is continuing against other Defendants. Morgan Stanley, Wachovia/Wells Fargo, and JPMorgan have already settled. Bank of America will provide reasonable cooperation, including discovery cooperation, to Class Plaintiffs' Counsel in the litigation that will continue against the other Defendants.

#### What Do I Do Now?

• Remain in the Settlement. To remain in the Settlement Class and participate in the Settlement, you do not have to do anything now. If the Court approves the Settlement, you give up the right to sue Bank of America for the claims and issues in this case. The Settlement Agreement, specifically Paragraph 1(cc), which is available at <a href="www.MunicipalDerivativesSettlement.com">www.MunicipalDerivativesSettlement.com</a>, describes in more detail the legal claims that you give up if you stay in the Class. If you remain in the Settlement Class, you still have the right to exclude yourself from any other settlements with other defendants reached in this lawsuit. Claim forms are not available now. Register on the Settlement website to receive a claim form when it becomes available.

• Exclude yourself from the Settlement. If you do not want to remain in the Settlement Class, you must exclude yourself. You must send a written request for exclusion by first-class mail, postmarked no later than May 6, 2014 to the Settlement Administrator. The detailed notice available on the Settlement website describes the information you are required to include in your request for exclusion. If you exclude yourself, you cannot participate in the Settlement, but you retain your right to sue Bank of America on your own for the claims in this lawsuit.

**NOTE:** You may receive similar notices regarding proposed settlements with other Defendants (i.e., GE Funding Capital Market Services, Inc., Trinity Funding Co., LLC and Trinity Plus Funding Co., LLC). However, if you wish to exclude yourself from the Bank of America settlement, you <u>must</u> send a separate and specific notice with regard to the Bank of America settlement.

• <u>Object or Comment on the Settlement</u>. If you remain in the Settlement Class and want to object to or comment on the Bank of America Settlement or any part of it, you must file an objection with the Court and deliver a copy to Class Counsel and Bank of America **no later than May 6, 2014**.

#### When Will the Court Decide Whether to Approve the Settlement?

The Court has scheduled a hearing on June 6, 2014, at 10 a.m. at the United States District Court for the Southern District of New York, United States Courthouse, 500 Pearl Street, New York, NY 10007, to consider whether to finally approve the Bank of America Settlement as fair, reasonable and adequate, whether to approve Class Counsel's request for reimbursement of litigation expenses, and to consider any objections.


The Court has appointed the law firms of Hausfeld LLP; Boies, Schiller & Flexner LLP; and Susman Godfrey L.L.P. to serve as Class Counsel and represent all Class Members. If you want to be represented by your own lawyer, you may hire one at your own expense. You or your lawyer may ask to appear and speak at the hearing but are not required to. If you want to be heard by the Court, you must file a written notice of your intention to appear with the Court and deliver a copy to the Class Counsel and Bank of America no later than May 6, 2014. The Court may change the time and date of the hearing. Any change will be posted on the Settlement website.

## Magarbi Matthew Remembered for His Kind Spirit, Impressive Work Ethic Following Fatal Car Crash

Magarbi McCullum Matthew, known affectionately as TJ, was remembered last week after he died February 16 in a fatal car crash in Washington state. Matthew, who was stationed at the USS Nimitz with the U.S. Navy, was on his way back to the base after taking friends home when he struck a tanker truck carrying liquid nitrogen, causing the truck to roll over onto his car. He died at the scene just before midnight.

Matthew, who was 22 years old, was an E-5, or petty officer second class, in the U.S. Navy. He'd reached this rank, which typically takes six years to achieve, in just three years.

"He was caring, loving, respectful, and humble," said Matthew's father, Thomas Matthew of Our Market Smoothies and Hospitality Car Rental. "He loved taking care of people."

Friends of Matthew's from the Navy brought his body home last week.

"He was pretty impressive as far as knowing what he wanted to accomplish," said AO2 Marie Jackson. "I'd say he could accomplish anything and everything. He was a hard worker, always wanting to learn."

Jackson recalled how Matthew motivated himself to rise through the ranks in the Navy. As an E-3, he pinned an E-4 insignia inside his uniform collar to remind him of what he hoped to achieve.

Matthew grew up on St. John, attending Julius E. Sprauve School and Gifft Hill School before graduating from Sts. Peter and Paul School on St. Thomas. Classmate Malik Stevens remembered Matthew as someone he respected.

"He was one of the few of us who was out doing something positive with his life," said Stevens. "For it to be brought to such an abrupt and sad end really affected a lot of us who grew up with him. I was heartbroken that such a good guy with so much potential was taken from us so soon."

Chief Recruiter for the Virgin Islands Richardson Lewis remembered Matthew as the first person he enlisted when he reported to the territory in 2010.

"He came into the office and he was a little bit overweight," said Lewis. "I said, 'Hey, you want to join the Navy, you lose 10 pounds and come back and see me.' Within that month he came back into the office and he'd lost 15 pounds, so I knew this kid was for real."

Matthew traveled from St. John three times a week to attend the Naval program on St. Thomas, and was on time more frequently than those who lived on St. Thomas, Lewis recalled.

"I knew there was something special about this one," said Lewis. "One word to describe him would be 'impressive.' His initiative was something serious."

In addition to his impressive drive, Matthew was remembered for being liked by everyone.

"He was well-loved," said Thomas Matthew. "He did smoothies and worked the car rental with me, and he used to get more tips than me."

Matthew's funeral is scheduled for Saturday, March 8, at 10:30 a.m. at the V.I. National Park ball field. Everyone is welcome to attend.

## No New Information on Malfetti Murder

There has been no new information from V.I. Police Department about the investigation into the mid-January stabbing death of a New Jersey man in his south shore apartment.

There is nothing new to report from V.I. Police Department investigators.

A VIPD spokesperson has said officials will issue statements when they have something to release to the public.

There is nothing new to report from the private investigator working for the Malfetti family.

The Federal Bureau of Investigation has not taken an active role in the investigation despite the call by a New Jersey U.S. Senator for federal involvement in the investigation into Malfetti's death.

#### Friends Lambaste USVI on Internet

Friends and family of Malfetti on St. John and in his home state of New Jersey, meanwhile, have fed internet chatter which typically follows any major crime against a visitor about how dangerous the U.S. Virgin Islands are for tourists.

Malfetti family private investigator William Phoenix has never asserted Malfetti was murdered in a case of mistaken identity, although Phoenix has confirmed to *Tradewinds* he was aware of the island rumor that Malfetti was killed after being mistaken for the previous tenant of the apartment he had recently rented.

Phoenix has down played the importance of the "mistaken identity" rumors while alluding to other avenues of investigation.

The young man has told friends and acquaintances that he was the intended target of the attack on Malfetti, but speaking with him is not a priority for Phoenix.

"We have other persons of interest," private investigator Phoenix told *Tradewinds* in an e-mail on Friday, February 21. Phoenix would not elaborate. The private investigator has been guarded in his comments or answers to questions from *Tradewinds* concerning the investigation, including the whereabouts of a large screen television stolen from the apartment during or after the stabbing murder of Malfetti.

"I will answer what I can while keeping my client's and the investigation's best interest in focus," the private investigator wrote in a February e-mail to *Tradewinds*. "That being said, I'm not prepared to discuss the television at this time."

#### **Investigator Confirms Time Frame of Events**

Phoenix has confirmed the time frame of the events leading up to the discovery of Malfetti's body on January 19.

"The burglary (to the main residence) occurred between the hours of 11 p.m. Friday night (January 17) and the time they awoke and reported it Saturday morning (January 18)," Phoenix previously told *Tradewinds*. "(The owners) reported the burglary to their residence. They were home at the time the burglary occurred."

"There is no evidence to support that the homicide did not occur during the same time frame as the burglary to the... home," Phoenix continued.

"His car and Jimmy were discovered on the 19th," Phoenix said. "Their caretaker discovered Jimmy Sunday morning."

"Jimmy's car was located on Rendezvous the same day his body was found, January 19," the private investigator confirmed in an e-mail.

Despite calls by New Jersey U.S. Sen. Robert Menendez for FBI involvement in the investigation of Malfetti's murder, the FBI has not had significant involvement in the investigation, Phoenix said.

"We were told the FBI is involved in a 'limited' capacity," said the investigator whose Phoenix Investigations is based in St. Petersburg, Florida

#### **CBCC Urging Residents To Complete** Water Tests, Consumption Survey

Before planning for Coral Bay's future water use and water needs, Coral Bay Community Council officials are trying to get a picture of the area's current water use and hoping residents will help.

The group has a \$182,000 U.S. Department of Agriculture grant to help create a water and waste water plan for the Coral Bay area. CBCC's first step is to understand residents' current water needs, explained the group's environment projects manager Patricia Reed.

"We're trying to understand residential, commercial and development water and waste water needs now and going forward," said Reed. "One way we're trying to do that is by having people complete a survey on their water use and what type of waste water systems they have. We want to hear from all residents of Coral Bay."

"We're collecting baseline information to get a handle on how much water is used here in Coral Bay for when we look at future water use and planning for future water use," Reed said.

The water use survey takes between 10 and 15 minutes and is available at Keep Me Posted,

Connections and at the CBCC office as well as online at https:// www.surveymonkey.com/s/cbccwateruse

CBCC officials are also interested in the quality of water residents have in their cisterns. The group took 20 samples of Coral Bay residents' cistern water to Ocean Systems Lab on St. Thomas last week to test water quality, particularly bacteria levels.

"The cistern testing is part of the USDA grant which gives residents the opportunity to see if their water meets EPA drinking water quality standards, particularly as it relates to bacteria" said

CBCC officials are considering hosting a second round of testing if residents, who must pay a \$40 lab fee, are interested, Reed explained.

"Cistern testing will let us know people's drinking water quality," she said. "Do we need to do more efforts towards filtration systems or if drinking water quality is fairly good, we can focus elsewhere."

## Amanda Hayes Convicted of Second Degree Murder, Faces to 13 to 16.5 Years

Former St. John resident Amanda Hayes was convicted of second degree murder by a Raleigh, North Carolina jury and sentenced to between 13 and 16-and-one-half years in jail by Judge Don Stephens on Wednesday, February 19.

Hayes, 41, was found guilty of second degree murder for her part in killing 27-year-old mother of two Laura Ackerson in July 2011. Amanda Hayes' husband, Grant Hayes, who lived on St. John for several years with his then-girlfriend Laura Ackerson and their two young sons, was convicted of first degree murder in September 2013 and is serving a life sentence without the possibility of parole.

The jury of nine women and three men deliberated for 11 hours before handing down its second degree murder conviction following a 13-day trial which featured testimony from 49 witnesses, including Amanda Hayes.

During the trial, prosecutors alleged that Amanda Hayes worked with her husband Grant Hayes to murder Ackerson, the mother of Grant Hayes' two sons. Laura Ackerson and Grant Hayes were in a heated custody battle over their two young sons when prosecutors allege Grant and Amanda Hayes killed Ackerson, dismembered her body with a power saw, packed her remains in coolers and transported the body pieces to Texas, where they dumped Ackerson's remains in a creek near the home of Amanda Hayes' sister.

Defense attorneys, however, contended that Amanda Hayes only found out that Ackerson was dead after she arrived in Texas with her husband, Grant Hayes' two sons and the couple's one-month-old daughter, Lilly, according to a www.newsobserver.com story.

"Amanda Hayes testified over the course of two days that she did not kill Ackerson nor help with the dismemberment," according to the report. "She said she did not know that Ackerson was dead in July 2011 until arriving at her sister's house in Texas and having a conversation with her husband outside, under the cloak of darkness, as he fingered a machete."

"Amanda Hayes said she was coerced and afraid of her husband," according to the Raleigh, North Carolina newspaper website. "She said she was fearful that he would harm her grown daughter and the infant Lilly, barely a month old when Ackerson was killed."

Before being sentenced, Amanda Hayes addressed Judge Stephens asking for leniency, as seen in a video on the North Carolina news website www.wral.com.

"Your honor, I would just like to apologize with my whole heart, being, soul — first to Laura, I apologize to her, to her family, to her children, to my family, to Grant's family, to everyone who had to work this case, to everyone who had to sit through this trial, to everyone in the media who has had to watch this and that it has touched their life," Amanda Hayes told Judge Stephens. "I am so so sorry that this touched my life in any shape, form or fashion or anyone that I love or care about or anyone and I truly, truly am

sorry with every ounce of my soul."

Laura Ackerson's father, Rodger Ackerson, however, didn't buy Amanda Hayes' story and painted her as a manipulator, according to the Raleigh News Observer story.

"She's a manipulator, she's a liar," Rodger Ackerson was quoted talking about Amanda Hayes in the report. "She uses that sing-songy voice when she wants to get something from you. That doesn't work with me."

Prosecutors went a step further than Rodger Ackerson and alleged that Amanda Hayes, a former actress, had been preparing for the role of her life, according to the www.newsobserver.com report.

"Prosecutors contended that Amanda Hayes' time on the witness stand was 'the performance of her life,'" according to the report. "Prosecutor Becky Holt said Amanda Hayes had been preparing for her courtroom performance this month for nearly two years. Holt said Hayes had access to police reports and evidence in the case and developed a storyline that seemed 'too rehearsed."

While Amanda Hayes' defense team ponders their case for an appeal, Rodger Ackerson reminded people what the gruesome trial was really about, according to the report on www.newsobserver.com.

"This whole mess is about four people," Ackerson was quoted in the www.newsobserver.com report. "It's about Laura and three kids."

Laura Ackerson and Grant Hayes' two sons, Little Grant Hayes and Gentle Hayes, along with Amanda and Grant Hayes' daughter, now 3, all live with Grant Hayes' mother in Kinston, North Carolina.

Before handing down his sentence of between 13 and 16 and a half years behind bars to 41-year-old Amanda Hayes, with credit for her two and a half years already served, Judge Stephens had one last comment for her, according to the www.newsobserver.com report.

"My problem, I think, here is that I personally believe, based on my view of the evidence, that it is quite possible and likely that Amanda Hayes could have saved the life of Laura Ackerson and she chose not to," Stephens was quoted in the report. "She chose to participate in her killing."

## If You Purchased Municipal Derivative Transactions from January 1, 1992 to August 18, 2011 You Could Get a Payment for a Class Action Settlement.

A proposed Settlement has been reached with GE Funding Capital Market Services, Inc., Trinity Funding Co., LLC and Trinity Plus Funding Co., LLC (collectively, "GE"), in a class action lawsuit that alleges price-fixing in the sale of municipal derivatives transactions by GE and other companies. The case, *In re Municipal Derivatives Antitrust Litigation*, MDL No. 1950, No. 08-02516, is pending in the United States District Court for the Southern District of New York.

#### Who Is Included in the Settlement?

This Settlement includes all state, local and municipal government entities, independent government agencies, quasi-government, non-profit and private entities that purchased:

- (1) Municipal derivative transactions through negotiation, competitive bidding or auction, from any Alleged Provider Defendant or brokered by any Alleged Broker Defendant,
- (2) Any time from January 1, 1992 through August 18, 2011 in the United States and its territories or for delivery in the United States and its territories.

The Defendants and Co-Conspirators are listed in the detailed notice available on the Settlement website.

#### What Does the Settlement Provide?

GE agreed to a settlement amount of \$18.25 million. This Settlement is only a partial settlement of the lawsuit because it only affects the claims against GE. The lawsuit is continuing against other Defendants. Morgan Stanley, Wachovia/Wells Fargo, and JPMorgan have already settled. GE will provide reasonable cooperation, including discovery cooperation, to Class Plaintiffs' Counsel in the litigation that will continue against the other Defendants.

#### What Do I Do Now?

• Remaininthe Settlement. Toremain in the Settlement Class and participate in the Settlement, you do not have to do anything now. If the Court approves the Settlement, you give up the right to sue GE for the claims and issues in this case. The Settlement Agreement, specifically Paragraph 1(bb), which is available at <a href="https://www.MunicipalDerivativesSettlement.com">www.MunicipalDerivativesSettlement.com</a>, describes in more detail the legal claims that you give up if you stay in the Class. If you remain in the Settlement Class, you still have the right to exclude yourself from any other settlements with other defendants reached in this lawsuit. Claim forms are not available now. Register on the Settlement website to receive a claim form when it becomes available.

• Exclude yourself from the Settlement. If you do not want to remain in the Settlement Class, you must exclude yourself. • Object or Comment on the Settlement. If you remain in the Settlement Class and want to object to or comment on the GE Settlement or any part of it, you must file an objection with the Court and deliver a copy to Class Counsel and GE no later than May 6, 2014.

#### When Will the Court Decide Whether to Approve the Settlement?

The Court has scheduled a hearing on June 6, 2014, at 10 a.m. at the United States District Court for the Southern District of New York, United States Courthouse, 500 Pearl Street, New York, NY 10007, to consider whether to finally approve the GE Settlement as fair, reasonable and adequate, whether to approve Class Counsel's request for reimbursement of litigation expenses, and to consider any objections.

The Court has appointed the law firms of Hausfeld LLP; Boies, Schiller & Flexner LLP; and Susman Godfrey L.L.P. to serve as Class Counsel and represent all Class Members. If you want to be represented by your own lawyer, you may hire one at your own expense. You or your lawyer may ask to appear and speak at the hearing but are not required to. If you want to be heard by the Court, you must file a written notice of your intention to appear with the Court and deliver a copy to the Class Counsel and GE no later than May 6, 2014. The Court may change the time and date of the hearing. Any change will be posted on the Settlement website.



Although enjoying the comfort of her well-honed art work, Etre also took the opportunity to push herself to new locations, finding new inspiration along the way.

"Painting continues to challenge, frustrate, and humble me," said the painter. "Striving to capture light, color, and the astonishing beauty of St. John on canvas, I traversed to new venues for inspiration and composition."

As she travels down her path of transition, Etre continues to seek the answer to a few guiding questions, she added.

"Do they pull me back or keep me present," questioned Etre. "Do they aid in going forward?"



Throughout the school year, students are periodically gathered together in either the gym, the cafeteria, or in the library to listen to someone speak. After going through this so many times, I've mastered multitasking, listening to

the speaker while examining my

As I look around, I see a large population of students with very diverse backgrounds, but often with the same facial expression; boredom. Why are they so bored?

Sometimes it comes down to

the speaker. Your attire, posture, attitude, agenda, speech, what you say, and how you say it are all important. Everything you do and say means something. Obviously if you come in and read your speech off a paper and say it with no emotion at all, we aren't going

#### 18th Annual 8 Tuff Miles Draws 1,000+ Runners and Walkers

Rain can't stop the Carnival and rain certainly didn't stop the 1,101 people who ran and walked across St. John on Saturday morning, February 22, as part of the 18th Annual 8 Tuff Miles road race.

An early morning downpour drenched participants as they congregated at the start line outside of the V.I. National Park Visitors' Center in Cruz Bay, but the rain tapered off in time for a U.S. Coast Guard fly-over ahead of the race's start.

With the rains over for the time being and the top 100 finishers from last year tucked in the front of the pack, guitarist Matt Still from Jacksonville, Florida, strummed out the "Star Spangled Banner."

The sun was out when Race Director Peter Alter reminded participants of the newly installed speed bumps a few feet from the start line and waved his orange flag in the air just around 7:20 a.m. to get the 18th annual running of what has become the largest road

race in the Virgin Islands underway.

It took more than two full minutes for all 1,101 participants to cross the start line and head out on the course which winds along Centerline Road all the way to the finish line in the Coral Bay ball field.

The skies, however, did not stay clear for long. The fastest runners encountered the next squall, one that would stick around for much of the race, at around mile one, according to several 8 Tuff Miles participants.

Less than an hour later, 30-year-old Rick Pahl of Muscatine, IA, crossed the finish line first with a time of 51 minutes and three seconds. It would be more than 30 seconds before the next runner sent the crowd of well-wishes and volunteers into cheers as 32-year-old Marc Teismann of Newport, Kentucky, crossed the finish line in a time of 51 minutes and 42 seconds.

About a minute later, Paul Jones, 38, of Apex, NC, was the third place finisher after cruising over the finish line with a time of 52 minutes and 32 seconds.

While there were no records set on the men's side — the course record of 45 minutes and 46 seconds set last year by David Riddle, 31, of Ohio still stands — there was plenty of excitement in the women's field at 8 Tuff Miles this year.

Perennial favorite Ruth Ann David —

who has been the first female finisher for the past four years — found some competition in the form of Jessica Rice, 38, of Needham, MA. Rice set a new women's course record with a time of 56 minutes and three seconds. She crushed the previous women's course record of 57 minutes and 15 seconds which was set in 2004 by Letitia Dusich of St. Croix.

Ruth Ann David, 40, of St. Thomas finished second on the women's side this year with a time of one hour, one minute and 23 seconds. Third place for women was taken by 22-year-old Emily Egelhoff Whalen of Ashville, NC, who finished with a time of one hour, two minutes and 36 seconds.

While the blazing speeds of the first finishers are impressive, equally impressive are the hundreds of other runners and walkers who make the race the huge success that it is each year.

The 8 Tuff Miles race entices more than 1,000 people to get out of bed in the dark on

the last Saturday morning in February and hoof up and down at times ridiculously steep hills to cross a finish line on the opposite side of the island. And the race's popularity simply continues to grow.

"One thing I've learned after 18 years is that people like 8 Tuff Miles, no matter what the weather is," said Race Director Peter Alter, who was enjoying a few lazy afternoons last week following the hectic pace he sets leading up to the big race.

Along the race route runners and walkers have the chance to re-hydrate at 12 different water stations staffed by volunteers who dress up and cheer on participants. Volunteers also help set up and break down at the start line, transport backpacks to the finish line, fold finisher T-shirts, keep time, set up and break down at the finish line, distribute medals, goodie bags and fruit and more.

"A big thank you to the close to 400 volunteers

who helped out this year," said Alter.

## St. John Historical Society Celebrating 40th Anniversary Tuesday, March 11

St. John Tradewinds

The St. John Historical Society invites the St. John community to celebrate its 40th anniversary at a party at the Battery on Tuesday, March 11, at 5 p.m. The event will feature catered food and drinks and a slideshow of St. John and Historical Society images. A video entitled "Flight to Freedom: Hans Jonathan," which follows the quest of a modern-day Icelandic family to discover the true story of their enslaved Crucian ancestor, will be shown, along with a presentation by V.I. historian and SJHS board member George Tyson. All are welcome to attend. Non-members are asked to consider making a donation at the party.

The SJHS began in February 1974 with a meeting of 19 residents at the V.I. National Park headquarters at the Creek in Cruz Bay. The goals and objectives of the SJHS were laid out that day, and have remained largely unchanged since.

SJHS volunteers have played a major role in promoting and preserving the island's unique history and cultural heritage throughout the society's 40 years. The clearing and stabilization of the ruins of the Annaberg Country School was one of the first projects undertaken by the society, and stewardship of the site continues to remain a high priority for the SJHS, which completed its annual clearing of the school's ruins on February 15.

The society was instrumental in the volunteer staffing of a mu-

seum at the Cruz Bay Battery, and later, at the Elaine I. Sprauve Library, in the 1980s. SJHS volunteers have left their mark across the island, from a sundial with an engraved plaque that was donated to the Emmaus Moravian Church, to the replacement of an illegible red stone plaque commemorating the construction of the Cruz Bay Battery with a new bronze plaque and the replacement of cannon mounts, also at the Battery.

Through the efforts of SJHS volunteers, the ruins of the Annaberg slave village were restored; the Enighed cemetery and the Elaine I. Sprauve Library were cleaned up and planted with inkberry trees, oleander, and ground orchids; and the oldest marked grave in the Cruz Bay Cemetery, where Lucretia Virginia Howard Minor rests, was restored.

The society preserved island culture with its place names project, where more than 20 local culture bearers helped to extensively map the Coral Bay and East End quarters with vernacular place names of the early 1900s. In October 2009, the SJHS published its first book, "St. John, Life in Five Quarters," a compilation of 66 articles and more than 160 historical pictures, illustrations, and graphics, further demonstrating the society's commitment to be a strong advocate for the presentation and dissemination of St. John history.

After entering into a 99-year lease with the St. John Communi-

ty Foundation for land on the historic Bellevue Estate on Gifft Hill Road in 2013, the society plans to construct an accessible climate-controlled archive, library, and research space for the non-profit's ever-growing collections, as well as a modest museum and exhibit area in which to share them.

Willis, who joined the board for the first time in 2013, would like to ensure continued preservation of the island's history for decades to come by educating St. John youth.

"One of my goals is to encourage new writers, new storytellers, new photographers, new genealogists, new archaeologists, and new archivists to actively pursue our day to day history, while we impress on them the wonder of what came before," said Willis. "Young people's perspective is important, and our organization will be stronger when we get more of our young people to join us."

The SJHS board of directors extends sincere thanks to the entire SJHS membership and all of the society's loyal contributors and friends, both past and present. It is because of their support, and the support of the St. John community, that the St. John Historical Society has remained the active and enduring organization that it is today.

#### **DOE Gearing Up for Transition to Online Assessments**

#### St. John Tradewinds

As the V.I. Department of Education gets ready to make the jump from the traditional paper testing to online assessments — which will eventually replace the old VITAL-S with the more modern, and interactive exams offered by the Smarter Balanced Assessment Consortium (SBAC) — the Department of Education is also reaching out to parents, and the general public, for their support.

The new assessments are aligned to the Common Core State Standards, which the Department adopted in 2010 and continues to be aggressively integrated into the public school curriculum. The adoption of the Common Core State Standards in English Language Arts and Math set high performance and knowledge goals for students, while also pushing the bar higher for teachers — whose lesson plans and instruction now have to be more streamlined and tailored to the subject matter — and parents, who can now also have more of an understanding of what the students are expected to learn at their respective grade levels.

The standards offer a clear progression of skills throughout the grade levels, along with opportunities to review in order to keep student skills' sharp. The accompanying switch to a new online assessment system aligned to the Common Core will not only allow students to be better prepared for college and the workforce, but will give our schools and parents will receive more timely feedback about the students' performance — ultimately allowing us to track student progress from elementary to high school — while the tests themselves will become more interactive and accessible, boosting student engagement overall.

While the official transition will not happen until March of 2015, Department of Education officials are gearing up for a field test in May that will help

identify what else needs to be done to make sure all schools and students are prepared to administer and take the online assessment. Meanwhile, training is ongoing for test administrators — who will administer the exam to students in grades 4, 7, 11, according

"We will also continue working with our administrators and teachers to ensure that the online assessments remain fair, accessible and are administered appropriately to all students," Education Commissioner Donna Frett-Gregory said. "Working to make sure that the proper technological infrastructure is in place before the testing begins will also be a top priority. We will also remain committed to improving the technical support and training provided to teachers on assessment practices."

Nationwide, studies show that a large majority of educators are enthusiastic about the implementation of the Common Core State Standards and expect them to lead to greater student achievement. While it is not expected that student testing scores will show a dramatic jump during the 2014-2015 school year -the first official year of VIDE's newly adopted Common Core assessments — teachers have said they look forward to seeing achievement steadily increase as students become more exposed to the rigorous curriculum.

#### Attorney Maxwell McIntoch Arrested for Embezzlement by Fiduciaries and Obtaining Money Under False Pretenses

Insular Investigation detectives on St. Croix arrested Attorney Maxwell McIntosh on February 27, charging him with Embezzlement by Fiduciaries and Obtaining Money Under False Pretenses following complaints by clients and an investigation that revealed he used his clients' money to operate his business and pay personal bills.

According to the Affidavit filed by the detective Attorney McIntosh was hired to oversee a family probate case and given a check for \$183,188.31. The client filed a report with VIPD when the matter was not concluded in three years and McIntosh said he was unable to complete the probate. Further investigation into the matter revealed that the check was deposited into a bank account that did not have any funds.

A second client of McIntosh told police that the attorney was hired to sell some family property for \$259,315.79 but only gave the owners \$20,000. The family said they were unable to recover the balance of the sale from McIntosh

Detectives said the investigation into McIntosh's bank account reflects that he was using the account in which he was holding clients' funds to operate his business and pay personal bills.

Maxwell McIntosh appeared in Superior Court shortly after his arrest and was released on his own recognizance pending further court action.
