

NAVSTA earns 2nd retention award

Naval Station (NAVSTA) Guantanamo Bay (GTMO) won the Retention Excellence Award for fiscal year 2007. This is the second consecutive year that the command has received this honor.

The annual award recognizes commands that meet or exceed CNIC retention goals for the year. For 2007, the goals were: 50 percent for personnel with less than six years of active service, 60 percent for personnel between six and 10 years active service, and 80 percent for personnel with more than 10 years of active service.

"We [NAVSTA] had a 100 percent retention rate for first, third and fourth term Sailors," said Chief Navy Career

counselor (SW) Jon Monteleone, NAVSTA GTMO command career counselor.

Monteleone stated that the command's retention success is a direct result of excellent command leadership and command career development boards.

"Through the use of an intrusive Career Development Program, we make sure NAVSTA Sailors understand their career paths and what programs are available to them," said Monteleone. "What we advise them if they want to put in an officer commissioning program application, take the chief's exam early or learn how to earn an early promote evaluation," said Monteleone.

Through the efforts

many Sailors have become aware of their options to stay Navy including benefits that guarantee them a choice of their next duty station or type of duty.

The Guaranteed Assignment Retention Detailing (GUARD 2000) Program offers two guaranteed assignments within a 20-year career time frame for active duty USN, USNR-R (FTS), and USNR members in return for a four, five or six-year reenlistment.

" People have spoken of the GUARD program like it is a mermaid many have heard of, but few have seen. I saved my option to GUARD for orders for my final tour," said Electronics Technician (SW) 1st Class Jerry Ramm. "You must be about one year out from a PCS and EAOS and both must occur within the year, so a little thought needs to be put into your future reenlistments and the tour lengths you accept in order to plan the use of GUARD well. I've been planning for this occurrence since I decided to reenlist at my ten year mark and everything has been falling into place as I hoped."

NAVSTA Commanding Officer Capt. Mark Leary echoed Ramm's statement that it is important for Sailors to prepare early so that they are aware of all options open to them.

"NAVSTA GTMO's leadership continues to rely on the commitment of Sailors as the cornerstone of readiness to achieve GTMO's and Navy's mission," said Leary. "The award-winning contributions of the NAVSTA Command Career Counselor, our retention team and command leaders not only strengthens this command, but provides quality Sailors back to the Fleet at their rotation dates," said Leary. "Team GTMO is made up of some of the finest people from around the globe and their work ethic and professionalism makes NAVSTA GTMO one of the best locations for assignment in the world."

GUARD 2000 at a glance

First Guarantee. The first guaranteed assignment must be used during member's first reenlistment. Tour length waivers of up to 18 months of a prescribed sea tour (PST) will be considered on a case-by-case basis.

Subsequent Guarantees. Members who are in their second or subsequent term are entitled to one additional guaranteed assignment under this program.

The GUARD 2000 assignment is the result of negotiations between the member and the detailer (the detailer has greater latitude in assigning members to lower priority billets for a longer reenlistment period) for a mutually agreeable assignment.

Safety Corner: Seatbelt use in GTMO

In the early 60's there was a catchy little tune "buckle up for safety buckle up." It was designed to draw attention to a new safety device in cars, the seatbelt.

The Department of Defense has required the use of seatbelts while driving or as a passenger since the 1980's. OPNAVINST 5100.12H states "Individuals must be aware of their personal responsibility in the Navy's Traffic Safety Program."

The national average for seatbelt use is 82 percent according to the National Highway Traffic Safety Administration (NHTSA).

The Guantanamo Bay average seatbelt use in is about 58 percent, this is 24 percent below the national average.

I hear people stating that "we're only in GTMO" or "the speed limit is only 25 MPH." There are statistics and research papers that shows up to 74 percent of traffic fatalities occur at less than 25 MPH and less than 45 miles from home.

You're living in a statistic, complacency can be disastrous.

At 24 percent below the national average where is the "personal responsibility?"

Traffic violations increase in GTMO

You can't blame it on the warm sunny weather. You can't blame it on road construction either. You can't even blame it on the amount of traffic that's here! So why are traffic violations on the rise in Guantanamo Bay (GTMO)?

Master at Arms 1st Class(SW) Terry Bunche, Naval Station Security Pass & I.D. Office said, "We've [Security] noticed an extreme increase in the amount of traffic tickets being issued in the last month or so."

The traffic laws in GTMO are comparable to the laws back in the states, with one major exception, the speed limit. The speed limit here is 25 miles per hour (MPH) in most designated areas and major roadways. The speed limit in parking lots is only 10 mph, 15 MPH in any residential, barracks or billeting area, and five MPH during physical training or during troop movement. It doesn't take much for a driver to be distracted or to lose concentration and before he or she knows it they are up to 30 MPH.

The GTMO Motor Vehicle Code (NAVSTAGTMO 11200.1) prescribes administrative penalties (on a point system) for various violations. Driving with an expired registration is worth three points, failure to yield to emergency vehicles will get you four points, following too close to another vehicle can be four points, and failure to report an accident is six points. Points assessed shall remain on the driver's record for 12 months. The Code requires the Security Officer to revoke a driver's base privileges for one year when a driver accumulates 12 points within 12 consecutive months or 18 points within 24 months.

Upon receipt of a citation, the violator has a right to an administrative hearing at the GTMO Traffic Review Board. Traffic Review Board appearances are mandatory for some violations. At the Traffic Review Board, the Traffic Magistrate hears evidence from both sides in order to make a finding as to whether the driver committed the violation.

The traffic review board chief magistrate is the public works officer. The Guantanamo

Bay traffic review board takes place once a month. The chief magistrate takes final action on all appeals from suspension or revocations of driving privileges.

"The traffic board is an administrative forum, not a legal one," said Chief Magistrate Cmdr. Jeff Johnston. "There is no connection between GTMO driving record and their on-base privileges elsewhere. The Consolidated Law Enforcement Operations Center (CLEO) system tracks everyone's driving throughout the military services, on all installation. So if you pick up a six-month suspension the day before you leave GTMO, you'll spend the first six months of your next tour bumming a ride from the main gate."

In addition to the military-wide suspension tracking system that Johnston mentioned, the joint-service Motor Vehicle Traffic Supervision instruction (OPNAVINST 11200.5D) requires the installation to notify a driver's state licensing agency of any suspension of one year or longer based on a drunk driving or refusal to submit to blood, breath, or urine testing for drug or alcohol content.

One of the most serious offenses in the Code is driving a vehicle under the influence of alcohol or other controlled substances. No person may operate a vehicle while intoxi-


cated or impaired by alcohol beverages, drugs, or chemical substances. If the driver's blood or breathe alcohol content (BAC) is 0.08 percent or greater, the Traffic Review Board may presume that the driver was intoxicated, and the driver will be subject to a mandatory one-year suspension. If the BAC is at 0.05 percent but less than 0.08, the Board may presume that the driver is impaired, and he or she will face a six-month suspension.

All GTMO drivers should understand the naval Station's "Impaired Consent" policy regarding breath and blood testing for alcohol or drug content. Driving a motor vehicle on NAVSTA GTMO is a privilege, not a right, and by exercising this privilege, all drivers' consent, in advance to the chemical testing of his breath, blood, or urine, for the purpose of determining alcohol or drug content. Failure to submit to testing will result in the immediate revocation of driving privileges for one year, in addition to any period of revocation or suspension that may be imposed for any other moving violation. Failure to submit to such testing will also result in the driver being considered for removal and permanent debarment from the installation. NAVSTA cautions residents about unexploded ordinance

What started out to be a great day at the beach could have ended in absolute disaster. A family with kids went to the beach for some fun in the water which included some sea shell collecting. As the children were scouring the beach for sea shells they came across what appeared to be a wonderful souvenir: the shell casing from a 40mm anti-aircraft round.

In most cases such a shell casing would make a great souvenir. The only problem with this casing was that the primer was still intact therefore classifying the shell casing as unexploded ordinance (UXO). The primer in a 40mm anti-aircraft round is not small. The primer alone carries enough explosives to remove a hand or cause other serious injury, maybe even death.

The children removed the shell casing from the sand and placed it in the bag with

the rest of the shells. Mom had no clue about the special cargo until the shell casing with intact primer had made it all the way home.

Fortunately nothing happened. Once mom found the shell casing she contacted security and the UXO was safely removed.

Onboard Naval Station Guantanamo Bay, unexploded ordnance is unfortunately something that we have to deal with. However, by paying careful attention to your surroundings, teaching your children about UXO, and following planned procedures we can all enjoy our time on this island in a safe environment.

What to do if you find a UXO:

Remember the 3 R's.

Recognize—Pay attention to your surroundings. Anything that looks like it might have at anytime been part of ord-

nance, whether it looks like a projectile, bomb, submunition, rocket, or grenade it could be a UXO and could be deadly.

Retreat—Once you have recognized a potential UXO do not move any closer. Do not touch it, or remove anything from it. Do not use a radio or cellular phone. Many UXO are electronically triggered and could be set off by any transmission. As you leave, make sure you leave the way you came. If you have something to mark the location, do so by marking the spot where you are standing without moving any closer to the UXO.

Report—Immediately after you have safely left the area report the UXO to security at 4105 and the weapons duty officer at 4847 or 84015.
