

4-H Livestock Show returns to Immokalee

The Twelfth Annual Collier County 4-H Livestock Show will be held Thursday, January 18, 2018 through Saturday, January 20, 2018 at the Roberts Ranch Museum Grounds, located at 1215 Roberts Avenue, Immokalee, Florida. Admission and parking are free.

The Show this year is dedicated to Mildred Sherrod who was a long time supporter of 4-H youth and was instrumental in the 4-H Livestock Show being held at the Robert's Ranch Museum grounds.

The show is a countywide competition for 4-H youth to exhibit their livestock projects such as rabbits, poultry, goats, swine, breeding cattle and steer. Everyone is encouraged to come out and watch the competitions and learn more about livestock production and show.

On Saturday January 20th at 7:00pm all market swine and steer will be auctioned. Bids are placed per pound of the animal and additional add-ons can be given to the market exhibitors to help fund their projects. Various gift baskets and desserts will also be auctioned off to raise money to

keep the show going. Funds are due at the end of the auction unless arrangements are made with the sales management prior to the auction.

The purpose of the livestock show is to teach youth the fundamentals of good stock husbandry, to provide a wholesome product to the consumer by educating 4-H market livestock members on food safety awareness, to emphasize production and quality in farm animals, to stress the breeding of better livestock, to demonstrate the finer points of fitting showmanship, and to provide recognition and a fitting climax to each year's efforts.

Gates will be open for the shows at 6:00 p.m. Thursday and Friday and 10:00 a.m. on Saturday.

Tours of the Museum grounds will be available. Food will be available for purchase from Southernland Catering.

Crash claims three lives in Immokalee

According to the Florida Highway Patrol, the Collier County Sheriff's Office received a report of a crash on Custer Avenue in Immokalee just after 11:25 p.m. on Saturday, January 6, 2018.

When deputies, firefighters, and paramedics arrived they located Ra'Layah Johnson, age 3, who was transported to Naples Community Hospital where she was pronounced deceased.

The Collier County Sheriff's Office Dive Team and helicopter responded to help search for additional victims.

The search continued throughout the night and into Sunday morning when the vehicle was located and removed by Keith's Towing.

A second passenger, Ra'Majesty Johnson, age 5, was located in the vehicle and pronounced deceased.

North Collier Fire & Rescue District's Dive Team responded and deployed their boat. Along with the assistance of a Sheriff's Office drone, divers located the driver of the vehicle, Shatoria Michelle Brown, age 27, who was pronounced deceased.

According to the initial report provided by Florida Highway Patrol, the 2007 Chrysler Pacifica traveled east on Eden Avenue, continued past the intersection of Apple Street, and failed to stop at the intersection of Custer Avenue. The vehicle then traveled through a construction site and crashed into a retention pond where it became submerged.

Several residents were concerned when they learned about the crash since they thought the extension connecting Eden Avenue to Custer Avenue was still closed.

A resident who lives on Custer Avenue echoed those remarks and said that she was not aware that the extension had been opened. She said that she was concerned because the area at night is dark, poorly lit, and doesn't have the proper signage to let drivers know that the extension may be open.

Upon closer inspection, it does appear that the barricades which once stopped traffic from entering Custer Avenue, have since been moved to the side of Eden Avenue and there are no signs to warn drivers of the impending stop. In fact, there isn't even a stop sign at the new corner of Eden Avenue and Custer Avenue.

Arrest made in connection with Immokalee burglary

Angel Perez, age 21, was arrested Saturday, January 6, 2018 following a burglary at Crestview Park Apartments in Immokalee.

According to the Collier County Sheriff's Office, Perez is accused of stealing several items valued at over \$7,400 which includes two handguns, cash, a diamond plated necklace, an Armani watch, and

and after deputies confirmed the sale took place, he was charged with burglary, dealing in stolen property, grand theft of a firearm, grand theft, and defrauding a pawnbroker.

Perez was previously arrested in 2016 for driving without a license.

His bail is set at \$50,000 and his next court appearance is set for January 29, 2018.

The one street light that might illuminate the intersection of Eden Avenue and Custer Avenue has a broken lamp cover and appears not to work.

Because the construction site and roadway still belong to Habitat for Humanity of Collier County as part of their Faith Landing project, we reached out to their office for comment

Nick Kouloheras, President of Habitat for Humanity in Collier County said that he was upset when he heard about the tragedy that took place Saturday night. Kouloheras said that the new extension does not have the proper markings that a roadway should at this point because technically the road has not yet been officially opened.

Kouloheras went on to say that the connection from Custer Avenue to Eden Avenue was required and approved through the zoning process and for now the new extension still belongs to Habitat for Humanity.

As the project progresses and homes are built in the northwest corner of Faith Landing, the new road extension will be inspected by the County. Following that inspection, the road will officially be opened within 45-60 days. Twelve months after that. the road will officially be turned over to Collier County.

When asked about whether Habitat of Collier County plans to install signs or guardrails at the T intersection of Custer Avenue

and Eden Avenue until the road is officially opened, Kouloheras said that options are being looked which includes the possibility of securing the barricades that were originally in place.

Just prior to the vehicle entering the water, Brown's vehicle missed hitting a light pole by just a few inches. "I wished she would have hit the pole, maybe they would still be alive." Kouloheras said.

A search of the Collier County Traffic Operations website also reveals that there were no Road Alert Updates pertaining to the Faith Landing project for at least the last month.

Until the Florida Highway Patrol concludes their investigation, local residents say they will be pushing Habitat for Humanity to install proper lights and signs so that another tragedy like this doesn't occur in the future.

Students First

A lighthouse is seen as a welcoming structure, a reassuring sign Collier County Public Schools of steady ground ahead, and an optimistic symbol of hope for all

looking to move forward safely. Highlands Elementary School (HLE) was recently recognized as a Leader in Me Lighthouse School—the first in Collier County. With this designation, they're an example for other Leader in Me schools across the country and world.

"This is an achievement that we didn't think would happen until later on this year, but because we have such stellar leaders, they jumped on the bandwagon and they wanted this more than anything," says HLE principal Laura Mendicino.

As part of the 'Leader in Me' program, students participate in leadership teams and classroom roles throughout the year. HLE's goal is to give students the opportunity to meet others, synergize on community projects, and strengthen their natural leadership skills in an area of passion. As Mendicino explains, there are more than 3,500 Leader in Me schools in the world, but only 350 are Lighthouse schools-22 of those are in Florida, and now one in Collier County. The school hosted a school-wide celebration to share the news with students, staff, and guests.

"I think the fact that our students can light the path for Collier County is extremely



Mendicino explains. "Many times at a Title I school, people don't think that's going to happen, but our students have risen to the occasion and shown what they're capable of. Our students are capable of amazing things, and they're and leading the way for not only

excellence in themselves but in the school and the community of Immokalee. It has really been empowering for the students, and in turn, that's positively impacted our staff as

HLE has over 47 student leadership teams for students of all grade levels led by student choice. They meet once or twice a month for about 30 minutes. Mendicino savs each group begins with the end in mind and has a giveback goal, whether it's to the school or to the community or nationally.

This year, they even have a student Lighthouse team made up of 33 student leaders who meet with the parent and staff Lighthouse team to plan events, boost school culture and morale, and plan celebrations. They were even part of the creation of the school calendar.

"We know that with student leadership, our students are setting goals for success. They're developing habits they need to be successful. The Lighthouse pinnacle is just a cherry on top. We just want to make sure we're setting that foundation for our kids, and being a Lighthouse school gives us that affirmation that we are accomplishing that for our kids."

Phone and Internet Discounts Available to CenturyLink Customers

The Florida Public Service Commission designated CenturyLink as an Eligible Telecommunications Carrier within its service area for universal service purposes. CenturyLink's basic local service rates for residential voice lines are \$22.00 per month and business services are \$33.00-\$35.00 per month. Specific rates will be provided upon request.

CenturyLink participates in a government benefit program (Lifeline) to make residential telephone or broadband service more affordable to eligible low-income individuals and families. Eligible customers are those that meet eligibility standards as defined by the FCC and state commissions. Residents who live on federally recognized Tribal Lands may qualify for additional Tribal benefits if they participate in certain additional federal eligibility programs. The Lifeline discount is available for only one telephone or qualifying broadband service per household, which can be either a wireline or wireless service. Broadband speeds must be 15 Mbps download and 2 Mbps upload or faster to qualify.

Lifeline discounts include a transfer restriction (port freeze). This means that you are unable to obtain the Lifeline discount on service with another provider for a period of time. A household is defined for the purposes of the Lifeline program as any individual or group of individuals who live together at the same address and share income and expenses. Lifeline service is not transferable, and only eligible consumers may enroll in the program. Consumers who willfully make false statements in order to obtain Lifeline telephone or broadband service can be punished by fine or imprisonment and can be barred from the program.

DLC launches new outpatient medication-assisted program

David Lawrence Center, Collier County's only comprehensive, not-for-profit mental health and addiction recovery treatment center serving children, adults and families, is pleased to announce the receipt of a \$320,000 grant from the State of Florida through federal funding provided by the Substance Abuse and Mental Health Services Administration's (SAMSHA) State's Targeted Response to the Opioid Crisis (STR) initiative. These funds will support a new outpatient medication-assisted treatment program.

The State's Targeted Response to the Opioid Crisis funding aims to address the opioid crisis by increasing access to treatment, reducing unmet treatment need, and reducing opioid overdose related deaths. Specifically, the state of Florida's Targeted Response Project funds evidence-based prevention, medication-assisted treatment, and recovery support services. The state has earmarked the vast majority of these funds to be used for methadone and buprenorphine maintenance because these services have been demonstrated as most effective at retaining individuals in treatment, reducing illicit opioid use, and reducing opioid-related mortality.

David Lawrence Center's Crossroads Adult Addiction Recovery program is utilizing the funding to add the MORE (Maintenance of Opioid Recovery Everyday) Medication-Assisted Treatment program to expand its comprehensive continuum of inpatient detoxification, residential, intensive outpatient and ongoing recovery support services.

Medication-Assisted Treatment is the use of medications, in combination with counseling and behavioral therapies, to provide a whole-patient approach to the treatment of substance use disorders. Research shows that a combination of medication and therapy can successfully treat these disorders and help sustain recovery.

The MORE Medication-Assisted Treatment program offers hope to adults struggling with an addiction to opioids including heroin, fentanyl and prescription painkillers, through the use of Suboxone®, an opiate-based, FDA approved prescription

The goal of the MORE Program is to improve functioning and increase the chances of successful outcomes by allowing the individual to regain a normal state of mind, free of drug-induced highs and lows, so the benefits of recovery can be maintained.

The MORE program includes a comprehensive clinical assessment performed by a specialized, designated medication-assistance treatment therapist, medical assessment performed by a nurse and a psychiatric addiction medical evaluation performed by a psychiatrist.

The first phase of treatment begins with inpatient induction on the detoxification unit. Individuals must abstain from opioids for a minimum of 12 hours to enter this phase of treatment. While on the unit, clients are administered Suboxone and medically monitored around the clock for 2-3 days while response to the medication is evaluated.

Upon discharge, clients are immediately referred to a weekly Suboxone Medication Management Clinic. During this next phase of treatment, clients receive individualized treatment plans that include case management, twice weekly group therapy, individual therapy and routine drug testing.

Once the client is established on a steady does of Suboxone, he/she enters the Maintenance Phase where the intensity and frequency of continued treatment services is individualized. The length of stay in this phase can be indefinite.

For individuals who qualify for financial assistance, the grant will fund all medications and outpatient therapy services, and a state-mandated, sliding fee scale based on ability to pay can be utilized for the inpatient treatment.
