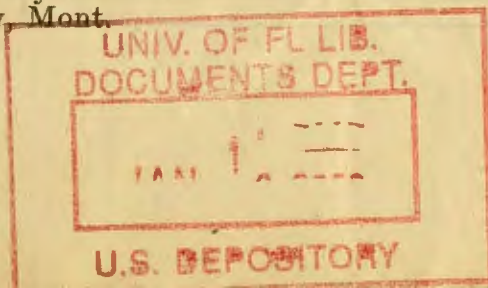

NOTICE REGARDING MEAT INSPECTION

FRESH AND FROZEN MEAT OF CERTAIN FOREIGN COUNTRIES EXCLUDED FROM THE UNITED STATES

The effect of B. A. I. Order 298, issued September 17, 1926, is to discontinue the importation into the United States of any fresh or frozen beef, veal, mutton, lamb, or pork from Argentina, Brazil, Czechoslovakia, Denmark, England, Hungary, France, Italy, Luxemburg, The Netherlands, Paraguay, Scotland, Spain, Sweden, Switzerland, Uruguay, and Wales on and after January 1, 1927.
